COLONIAL POLITICS.

DISTRICT COUNCILS AND ELECTORAL DISTRICTS.

One of the most important powers with which the Imperial Parliament have entrusted the Governor of this Colony, under the New Constitution about to come into operation, is that of carrying into effect, in virtue of his own delegated authority, the provisions of his rejected Bill of the late Session of the Legislative Council, by the establishment of District Councils all over the Territory. This important power is delegated to his Excellency in the 41st Section of the Act of Parliament, which is as follows:--(The Italics are ours.)

And whereas it is expedient that provision be made for the local government of the different parts of the said colony; be it enacted, that it shall be lawful for the Governor, by letters patent under the great seal of the colony of New South Wales, to incorporate the inhabitants of every county within the said colony, or of such parts of counties or other divisions as to him shall seem fit, to form districts for the purposes of this act, and by such several letters patent to establish a council in every such district for the local government thereof, subsuch district for the local government thereof, sub-ject to the following provisions: (that is to say) it shall be provided—

shall be provided—

1. That every such district council shall be elective, after the first nomination thereof, as hereinafter mentioned; the elections being made in the several districts, or other fit divisions to be defined by the charter, within the district; so that, until further provisons be made in this behalf by the Governor and legislative council of the colony of New South Wales, if the population in such district, according to the last census taken before the charter be less than seven thousand souls, the number of councillors for such district shall not be more than rine; if the population be seven thousand and less than ten thousand, the number of councillors shall not be more than fifteen; if the population be ten thousand and less than twenty thousand, the number of councillors shall not be more than fifteen; if the population be twenty thousand and upwards, the number of councillors shall not be more than twenty-one.

2. That until further provision be made in this behiff by the Governor and legislative council of the colony of New South Wales, the district councillors shall
be persons qualified to be elected members of the legislative council, and shall be elected to such office by
the persons qualified to vote in the election of members
of the legislative council within the district in which
the election is made.

3. That no district councillor shall hold any lucrative
officers wrongturnett under such district council or
others.

That no district councilior shall hold any increasive office or appointment under such district council, or enter into, o. be concerned or interested in, any contract or any pecuniary dealings with such district council, under a penalty or penalties to be fixed in such letters patent of incorporation.
 That no district councilior shall continue in office for record that there were, unless recelected.

4. That no district councillor shall continue in office for more than three years, unless re-elected.

5. That the district council shall be presided over by a warden, to be appointed and be removable by her Majosty, or by the Governor in the name of her Majosty.

6. That a district surveyor, who shall have passed an examination before a competent tribunal, approved by the Governor, shall be appointed in each district, for superintending the construction of roads and other public works undertaken by authority of the district council; and that the district surveyor, and all other officers needed for the exercise of the powers of the district council, shall be appointed and be removable by the district council, shall be appointed and be removable by the district council, shall be appointed and be removable by the district council, shall be appointed and be removable by the district council, shall be appointed and be removable by

the district council, suggest to the approval of the Governor.

7. That accounts in detail of all monies expended in every year, by or under the authority of the district councils, be laid before the Governor, and otherwise published in such a manner as may be directed by the charter, or provided by any law of the Governor and legislative council of the colony of New South Wales. DISTRICT COUNCILS TO BE ESTABLISHED.

It will be seen from the preceding Section of the New Act that the Governor is empowered, in establishing such District Councils as the Act contemplates, either to adhere to the limits of the Counties whose boundaries are already fixed, or to form new divisions of the Territory more accordant with the actual distribution of its population. Now this is a most important provision-important in the highest degree for the furtherance of the future comfort and welfare of the Colony-and if his Excellency is the man we take him to be, a man of a comprehensive mind, like his poses contemplated in the New Act, irre-

immediate predecessor, and not a narrowminded man, like his Excellency, Sir Ralph Darling !- it will very soon be seen in the manner in which he exercises this important discretionary power and cuts up the Territory for the formation of our District Councils. And as the Government are now beginning to look upon us as the regular occupants of the first of the Opposition benches in the future Provincial Parliament, we trust that on this matter of general concernment they will not forget

Had the soil of this Territory, therefore, been at all like that of the greater part of Upper Canada, and of some of the Western States of North America, or in other words, had it been like a Cheshire cheese-the same from the centre to the circumference, and capable of being cut up into a series of parallelograms of equal dimensions, according to the heavideal of Robert Owen-each of these parallelograms might well have been called a county, and have served all the purposes of a territorial county in England. But a country in which, according to Sir Thomas Mitchell, only one part in nineteen is available for agricultural purposes (the rest being either absolutely sterile or mere pasture-ground,) must be totally incapable of such a physical division, and ought therefore to be divided, for all political purposes, on some other principle. Now the Government, or rather the Surveyor's, division of the Colony into counties is one of the most absurd divisions imaginable, having no respect either to the character of the soil or the distribution of the population; there being whole counties in this Territory in which there is scarcely an acre of available land and in which the population can never be sufficient to form anything like a regular County establishment.

We trust therefore that his Excellency the Governor having thus been empowered by the Imperial Parliament to cut up the Territory afresh for certain important Municipal and political purposes, will have sufficient common sense to discard all this Surveyor's nonsence, and to avail himself of the discretionary power allowed him by the Act to cut up the country with a reference exclusively to the present and future distribution of its population. There are certain districts of the Colony, for instance, of which the inhabitants respectively have certain common interests, and form separate and distinct portions of the general population—such as the Illawarra district, the valley of the Hawkesbury, the Cowpasture district, the Parramatta district, the Bathurst district, the Argyle district, the Hunter's River districts, Upper and Lower, &c., &c. Now the inhabitants of these districts respectively ought, in our opinion, to be incorporated separately for the purspectively of all existing County divisions. The people of the Illawarra and Shoalhaven district, for example, are separated from the rest of the Colony by a precipitous mountain-ridge. They have common interests and common objects to pursue within that district, and they ought there fore to form one Municipal and political whole. But what can they possibly have to do with the vicinity of Camden, or the Cowpastures, although the late Surveyor, General, Mr. Oxley, was pleased to place both of these localities in the same county? Again, in the Bathurst district the Macquarie River divides the counties of Roxburgh and Bathurst, while it connects and binds together, by all the ties of one common vicinage, the inhabitants of both of these counties. So it is also with the opposite banks of the Hawkesbury and the Hunter respectively. These rivers are not dividing lines, as they appear to be on the Surveyor's chart, separating counties from each other, but connecting links, binding together into one social body the population on their opposite banks respectively. Now, supposing the County division to be strictly adhered to, and a separate Council to be constituted for each County, the inhabitants of the County of Bathurst, for example, beyond the Macquarie River, how desirous soever they might be of having a bridge across that river, would have to wait till the inhabltants of the County of Roxburgh should think proper, through their District Council, to co-operate with them in the undertaking. But the inhabitants of Roxburgh are already on this side the river; they don't want to cross it; they won't assess themselves, therefore, for a bridge, and the Bathurst people are consequently obliged to construct the bridge entirely at their own expense. So would it be also with the opposite banks of the Hawkesbury and the Hunter. These rivers ought not to be regarded as municipal boundaries, dividing the country, but as bonds of connection, linking together the population on their opposite banks. The Hawkesbury people, from Wiseman's up to Castlereagh, may have common interests and common objects to pursue, but they can have no such interests or objects in common with the people of Parramatta and Liverpool, any more than they can have with those of Maitland and Newcastle. Again, the Upper Hunter is as distinct a locality from the Lower, in point of interests and objects of common concernment, as those of Bathurst and Illawarra.

We look therefore with no small degree of interest for Sir George Gipps' forthcoming division of the Territory; for if that division is at all a judicious one, it ought decidedly to be adhered to for the other purposes of the New Act-we mean the division of the Territory into electoral districts for the return of members to the New Legislative Council. The division of the Colony into Police Districts, which we presume are formed exclusively with a view to the actual distribution of the population, affords

a kind of precedent for the sort of division we think absolutely necessary in the case in question.

While the large company of our readers therefore are waiting with much anxiety to see how his Excellency will cut up the Colony, we shall relate for their amusement the following anecdote. A young officer at a certain Regimental Mess-Table was one day cutting up a goose, and doing it somewhat unscientifically, when one of the Fitzclarences, who, it seems, belonged to the corps, observed, in rather a pointed and pompous manner, "It is the opinion of my father" (the late King William IV.) "that carving is a necessary part of the education of a gentleman." "And what," said the young officer, laying down his knife and fork, and bowing most respectfully to the off-shoot of royalty, "And what may be the opinion of your mother?" This, of course, was what the Hawkesbury people would call a settler; but leaving it to future antiquarians to ascertain what might have been the opinion of Mrs. Jordan on so delicate a point, we shall only express our own earnest hope that in cutting up the Colony, for the purposes of District Councils and Electoral Districts, his Excellency the Governor will show us all that he possesses the higher qualifications of an English gentleman of sound common sense and shrewd discernment, and not the mere common-place qualifications of an Assistant-Surveyor or Surveyor's Clerk.

Let the colonists but add seven more nominees in disguise to this compact phalanx, and there will be an end, for the next five years at least, to all progress in public freedom.

WHO IS TO GO OUT OF THE CITY COUNCIL AT THE END OF THE FIRST YEAR?

On being appointed First Lord of the Treasury in 1828, his Grace resigned the command of the army to Lord Hill, who has continued to fulfil the duties of the office up to the present time. Since 1794, with the exception of a short interval from 1809 to 1811, when Sir David Dundas commanded, this office has only had three occupants—his Royal Highness the Duke of York, Lord Hill, and the Duke of Wellington. The latter is now in his seventyfourth year, having been born on the 1st of May, 1769.

Church and State in Scotland .see it gravely stated in the London morning journals that the Marquis of Bute leaves the metropolis in a few days for Edinburgh, where, in his capacity of High Commission-er to the General Assembly, his Lordship will preside at the meeting of the Church Commission, on the 30th instant, when addresses are to be moved to her Majesty and Prince Albert. Perhaps the writer of the above announcement was not aware on what debateable ground he was treading; for it happens that the legality of the Commission is now sub judice in the Culsalmond case. The main argument of the suspenders for the illegality of that body is, that it has never received any recognition from the State. But should this high personage take the Moderator's chair on that day, and we know not how he could otherwise preside, then this will surely be the best of all recognition. Probably the Lord Provost will require also to surrender the Council chair; for the noble Marquis has as much right to preside in the one body as in the other.—Caledonian Mercury.

Not a Labourer wanted for Jamaica. Under this title the venerable Thomas Clarkson has just published a pamphlet containing a letter to a member of parlia-ment appointed to sit on the West Indian Committee. The patriarch of Negro freedom, with all the shrewdness of his early days, examines in this letter the reasons alleged by the planters of Jamaica for demanding more labourers, and proves their futility, clearly demonstrating that if they will but use agricultural implements of modern construction, reform the extravagant management of their estates, and avail themselves of the services which the emancipated Negroes will readily give for fair wages, they are sure to prosper. Mr. Clarksolemnly warns parliament and the country against sanctioning any plan what-ever for importing into the West Indies from the coast of Africa; such a step will, he is fully convinced, be the commencement of another slave trade.—Leeds Mercury.

We are sorry to hear that Dr. Maginn, the "Morgan O'Docherty" of Blackwood, died yesterday, at Walton-on-Thames. He was in his forty-eighth year, and has left a widow and three children .- Globe.

The Frankfort Journal announces the death of M. Isaac Harlwig d'Essen, one of the heads of the German Israelite Congregation, at Hamburg. Having no children, he bequeathed his fortune, amounting to 800,000 marcs banco (80,0001...) to charitable institutions in Hamburgh, Altons, and Copenhagen.

A very beautiful Arabian mare, (the

only one which has been permitted to leave the country for many years,) has just been presented to his Royal Higness Prince Alhert, at Windsor, from the English consul at Morocco. The mare, which for symmetry may almost be said to be unequalled, is, of a dark grey colour, standing fifteen hands high, and not more than two years. old. It is now at the Royal Mews, Windsor, and will ultimately be placed in the paddocks at Cumberland Lodge, under the care of Mr. Querton, his Royal Highness's stud groom, for the purpose of raising a stock in this country from the purest blood

IN DIA.

The Dutchess of Kent has brought news from India to the 15th October. At that date Generals Pollock and Nott were rapidly advancing towards Cabool. The prisoners had been removed a considerable distance into the interior. It was rumoured that a chief, who was independent of Akhbar Khan, had seized them, and that they would be given up when the British arrived at Cabool.

Authentic intelligence had been received in the Camp at Jellalahad of the doings of the forces in their advance towards Cabul. Generals Nott achieved a most splendid victory over the Affghan force under Shumshooden Khan, Governor of Ghuzuie, on the 30th August, killing Shumshoodeen, taking his guns, two in number, routing his army, and burning the camp. Ghuznie is now a heap of ruins, and it is supposed that General Nott would leave that place for Cabool on or before the 10th September. Pollock was expected to be there before the 14th or 15th. Shumshooden's followers fied in every direction. Two Bombay cavalry officers were killed and two wounded on the 30th. Nott and his army arc in the highest spirits, and they do not expect to meet with any resistance at Cabool. A skirmish had taken place at Jugdulluck on the 8th instant, in which Captain Nugent, Deputy Assistant Com-missary General, was killed by a ball in the head, General Sale struck by a spent ball, and about thirty soldiers wounded. Ma-homed Shah Khan satisfied with the superiority of our arms and strength, had retired to his fort at Lugman. It is expected, however, that the English will pay Lugman a visit, oust the wily old villain who so long had possession of the prisoners, and raze this fort, with all the other forts, to the ground: 64 men were billed and wounded. It is with feelings of billed and wounded. It is with feelings of horror we hear that some Affghan fiends burnt a man of H.M. 44th, whom they had possession of, in presence of the column as it was advancing on the heights; and fearing the flames might not prove fatal before our men neached him, they cut his throatas they fled !

Several other atrocities have been perpe reated. As Monsieur Reyschier, the French merchant, was proceeding from Jellalabad to Peyscher with a Sikh guard, he was met by a party of Affghan freebooters opposite Alse Baghan. After a short scuffle the Sikhs ran off, leaving poor Peyschier to protect his little boy, about eight years old. It is said the villains killed the child, and the poor father had to carry the corpse before him on horseback to Dhakka where it was interred:

MAURITIUS.

The Act passed by the Legislative Council of Mauritius, providing for the im-migration of Coolies, is published in the papers of the 30th of August.

THE SYNOD'S LAST.

The commission of the Synod of Australia held its usual sittings on Wednesday and Thursday last. The consequences of the infatuated policy of the members of this body must now be evident to themselves. if they are not wilfully blind, in the total apathy with which their proceedings are regarded by the people of their own com-munion. On the occasion of their public assembly, they sat solitary—a pitiful clerical clique, numbering seven individualsnot a single person, we are told, having entered the walls of the church to witness their proceedings on Wednesday, and on Thursday no one but the writer of the present paragraph. Among the minutes of the previous meeting, read on Thursday, there was one transaction recorded that will sink them still lower in the estimation of every respectable member of the Presbyterian church in the colony. We refer to a motion by Mr. M'Intyre, to the effect that whereas Mathew Whytlaw (the cashiered manager of the Steam Navigation Company, the returned bale from New Zealand, and the original mover of all the dissensions that have lately rent the Colonial Presbyterian Church,) stood high in the confidence of the members of this. Holy conclave, and whereas the said Mathew Whytlaw is about to return to Scotland, it is expedient that the said Mathew Whytlaw should be commissioned as the plenipotentiary of this Synod to use his best endeavours in every practicable way to counteract the misrepre sentations that have been sent to Scotland. relative to the proceedings of the said Such a motion as this-which was carried all but unanimously, Mr. Atcheson of Wollongong alone entering his dis--requires no comment: the Synod is sunk low enough when it has no other to represent its interests but Mathew Whytlaw; and if the remark of Burns-"sic poet an' sic patron"—can be justly applied in the present case, whatever opinion may be entertained elsewhere, there can be but one opinion here of the position and character of that church which has chosen such a man as its representative.

In regard to the misrepresentations that Mr. Whytlaw is to counteract, it may not be out of place to remark that they were publicly made here, and remain uncontroverted; and here only can the truth be ascertained. Mr. Whytlaw's mission is therefore of a piece with certain other underhand doings of the same parties; and us they choose to work in the dark in this way, we can come to no other conclusion than that indicated in Holy Scripture, "He that doeth evil hateth the light, neither cometh to the light, lest his deeds should be reproved; but he that doeth truth, cometh to the light." An impartial public will arrive at no other.

THE LEGISLATIVE COUNCIL AND THE NEW CONSTITUTION.

The Legislative Council is summoned for the 24th. The heads of a bill for the division of the colony into electoral districts in furtherance of the provisions of the New South Wales Act is published in yesterday's Gazette, as follows :-

"A Bill to provide for the Election of "Members to serve in the Legislative "Council."

The Act of Parliament 5 and 6 Victoria, cap. 76, intituled, "An Act for the Govern-ment of New South Wales and Van Dieman's Land," having directed that a Legislative Council, to consist of thirty-six members, of whom twenty-four shall be elective and twelve nominated by her Majesty, shall be constituted in this Colony, it is proposed, in conformity to the pro-visions of the said act, to enact as follows—

1. The parts of the colony within the boundaries of location to be divided into the following electoral districts, and each district to return the number of members

herein specified, viz.:-

ELECTORAL DISTRICTS .- District of Port Phillip, 5; county of Cumberland, 2; counrainip, 5; county of Cumberland, 2; county of Camden, 1; county of Northumberland, 1; county of Durham, 1; county of Argyle, 1; county of Bathurst, 1; counties of Roxburgh and Wellington, 1; counties of Cook and Hunter, 1; counties of Brisbane, Phillip, and Bligh, 1; counties of Westmoreland, Georgiana, and King, 1; counties of Murray, St. Vincent, and Auckland, (Twofold Bay,) 1; counties of Gloucester, Macquarie, and Stanley, (Moreton Bay,) 1; city of Sydney, 2; town of Melbourne, 1; town of Parramatta, 1.

- 2. In corporate towns the Mayor to be the returning officer, and in other places a returning officer, to be appointed by the Governor.
- 3. Writs for the election of members to be issued by the Governor to the returning officer, in which writs the day for holding the election, and the day on which the same shall be returnable, shall be named.
- 4. Convenient polling places to be ap-pointed in the several electoral districts. The returning officer to preside at the chief polling place, and to have power to appoint deputies at the other polling places.
- 5. The election to commence and be concluded in one day.
- .6. Officers to be nominated by the Governor, to prepare lists of voters, and publish them every year.
- 7. Such officers to give notice requiring voters to send in their claims.
- 8. Duly qualified persons may demand to be placed on the list of voters.
- 9. Lists to be forwarded to the returning officers.
- 10. Lists of voters in the electoral districts to be revised by persons appointed for that purpose.
- 11. Persons making lists to attend when required before the revising officers.
- 12. Revising officers to have power to insert in the district lists the names of claimants omitted, on due proof of claim and qualification.
- 13. Expenses at the first elections to be paid out of the funds of the colony, and in subsequent elections out of the local funds of incorporated districts.
- 14. No enquiry to be made at the time of election, except as to the identity of the voter, the continuance of his qualification, and whether he has voted before at the same election.
- 15. Certified copies of the register of voters to be furnished to each booth.
- 16. Powers of deputies of returning officers to be defined.
- 17. To provide penalties on officers for breach of duty.
- 18. No election to be void by any unavoidable delay or impediment in the time of holding the same.
- 19. To provide penalties against bribery and corruption.

GREAT PUBLIC MEETING.

Yesterday a great meeting of the working classes was held in the School of Arts, to petition the Governor against granting request of the City Council to assign to the Corporation 100 convicts, to be employed on the streets of Sydney, in accordance with the motion of Mr. Holden, which, however, our readers will observe has been withdrawn. Mr. Garret was called to the chair. The meeting at the outset was one of the most riotous that we have ever seen.

Turn him out, turn him out," resounded from every quarter of the building, which was crowded with upwards of 500 people, and the man was at last tossed from his seat in the gallery to the floor head foremost. He lay for some time head foremost. He lay for some time in a state of stupefaction, and in that state was carried from the room. lieve he is dangerously injured. After this although strong excitement evidently pre-vailed, a good deal of order and propriety was maintained. The speakers, who were all of the working classes, addressed their fellow-citizens in very fair and dispassionate terms, with the exception of one Lynch, whose speech bordered on sedition. Resolutions were adopted, expressive of the indignation of the meeting at the proposal, especially considering the fact, that 400 operatives in Sydney (many of whom would be rate payers notwithstanding) were out of employment; and recommending that the assigned servants in Sydney should be immediately dispatched to the country. The petition to his Excellency, adopted by the meeting in terms of these resolutions, requested that the present application, or any similar one that may hereafter be made should be refused by his Excellency; and that the convicts now assigned to parties in Sydney should either be forthwith withdrawn, or a tax imposed on the assignee to the amount of 10l. per head, to be applied to the city police fund. The meeting at the close became again very disorderly, and we effected our escape from the immense crowd with the greatest difficulty.

COLONIAL BEEF.

A meeting was held at the Royal Hotel, on Wednesday last, for the purpose of considering the important subject of the practicability and advantage of the curing of colonial beef for export. A committee was colonial beef for export. A committee was appointed for the consideration of the subject to report to a future meeting.

SUPERABUNDANCE OF LABOUR IN THE CITY.

We regret to say from what has come under our own observation during the week, that the want of employment complained of by parties in Sydney, is in a great measure their own fault. We know of one man, who, the other day, refused a situation in the Wellington district, (to which his expenses were to be borne by his employer), although offered a salary of 351. a-year, and rations for himself and wife. The man has been hanging on about Sydney unemployed since his arrival, about six months ago, and yet declined this offer, because it was too far into the interior. Men like this deserve no commiseration, and we suspect they form a very large proportion of the unem ployed in Sydney.

New Appointments.-" Captain Browne as Superintendent of the Water Police, and Captain Watson, as Harbour Master, have both been superseded by appointments from home. We are sorry to learn that one of the candidates for the representation of the city, has condescended, in order to further his canvass to the very lowest and most reprehensible means ever resorted to on such occasions. that of treating at certain public houses where his canvass lists are left for signature, the lowest class of electors, who of course alone are accessible to this means of political corruption. We have heard of strange doings in a house of this description not half a mile from the Police Office, which it would be premature at present to detail. We would recommend, however, the candidate for whose interests such practices are followed, if it be done with his knowledge and concurrence, to withdraw from the contest, as they are likely to involve very serious legal consequences. If not done with his approbation and consent, he ought to repudiate the doings of his very imprudent supporters, and thus remove from his own shoulders the odium of these discreditable transactions.

MR. ROGER THERRY AT ILLAWARRA.

This gentleman, we understand, has been showing himself to the Roman Catholic constituency at Illawarra, previous to entering on his electioneering crusade. other day he attended high mass at Wollongon in the morning, and at Dapto, eight miles distant in the afternoon. A very pious man of course must the faithful at Illawarra take Mr. Roger Therry to be; unfortunately, however, even at Illawarra, where the Roman Catholic influence is perhaps stronger than in any other district in the colony, the Attorney General, it appears, fluds it "no go." The members of the Roman Catholic Church, much to their credit, determining pretty generally to sacrifice their religious predilections to the public interest, and to oppose the pretensions of Mr. Therry as a government officer. This is as it ought to be. Sectarianism should not be allowed to interfere tarianism should not be allowed to interfere with the exercise of political rights. The principle of religious equality is at least professed by all, and there is little danger of that principle being subverted by the result of the approaching elections. The question is one therefore purely religious and as such is chould be recorded. political, and as such it should be regarded by all in awarding their suffrages. On the return of Mr. Therry to Sydney we understand he applied to Dr. John Osborne, whose influence in the district is paramount; but that gentleman-feeling no doubt indignant that such an imputation should be cast on the district, as that it had not a man of its own to represent its interests, and that its inhabitants must therefore betake themselves to the shambles of the Government offices, and confer that honour on a Sydney lawyer—wrote to Mr. Therry, politely declining the request, and announcing his determination to oppose him to the utmost of his ability, by contesting the field himself. Dr. Osborne is high in favour among all classes in the district—a liberal in politics, a man of education, and a gentleman. And Mr. Therry will find it a hard fight. The result we learn from a well informed quarter is by no means problematical. Even Mr. Police Magistrate Plunkett, one of Mr. Therry's warmest friends, is inclined to support Dr. Osborne, and halts between two opinions; and that feeling is more general in the district than could have been anticipated. CURIOUS RUMOUR ABOUT INDIA.

CURIOUS RUMOUR ABOUT IN DIA.

On the authority of "a traveller," just arrived from Bombny, the Courrier Francais gravely avers that "there exists in the British army in India a secret Association, whose object is to render that country independent of England. This Association, which is very numerous, is chiefly composed of Captains and Lleutenants, with a lew superior officers, and one or two generals. A few officers of the navy, and several other clvil employes of the company likewise belong to it. According to the plan of the Society, the entire of British India to form livelf into an aristocratic military republic, the president of which is to be elected for four years, and chosen from among the general officers. He is to assume the title of Marshal President. Acouncil of Inspectors-General, appointed by the Marshal President, are to act as Secretaries of State in each county. There are to be two military chambers, the one consisting of Generals, and the other of officers. The territory is to be divided into shires or counties of 1,000,000 inhabitants each (and no more)—governed by a General and Council, nominated by the Marshal President. The limits of the Republic are to be the ocean, Tartary, Persia, and China. The possessions of the French, Portuguese, and Danes, in Bludostan, are to form part of the Republic!"

POWERS OF CORPORATIONS—MODES OF ASSESSMENT.

At the present moment, when the sub-iect of municipal assessment is occupying the public mind, the following regulations for an assessment for the poor in a northern city may not be uninteresting, especially as English precedents are so much sought after. It appears that the Corporation that of Aberdeen—has not only the power of assessing property in land, but has actually undertaken to impose an income tax. The scheme has been submitted to the judgment of a gentleman high in the legal profession, in Scotland, who has given his opinion in favour of the legality of the scheme, except as to the number of assessors, which he considered ought in terms of law and in conformity with the usual practice to be more than one. The mode of assessment proposed is as follows:-

or assessment proposed is as ionious; a. — A sworn Assessor, with such assistants as may be deemed necessary, shall be appointed by the Magistrates, for the purpose of passing judgment on the returns given in, and fixing the amount of the assessment when no returns are made. These functionaries shall have salaries assigned to them,

which shall be paid out of the assessment.

II.—The Magistrates and Council shall annually appoint five individuals, being rate-payers, in the parish (three a quorum), who shall constitute a Board of Appeal for determining the rates of persons. corporations, or companies, who may be sons, corporations, or companies, who may dissatisfied with the decision of the Assessor being entitled to be present, and to explain, at the discussion on such appeals, the grounds of his de-

-No party shall be entitled to appeal on the

III.—No party shall be entitled to appeal on the ground that others are not so highly assessed. IV.—Schedules, according to the annexed form, shall be issued by the Assessor, to be filled up by all persons liable to be assessed.

V.—When persons neglect to fill up and return their Schedules, the Assessor shall be empowered to lay on the assessment, according to the best of his judgment and information; and, in the event of such parties appealing, they shall be charged ten per cent. additional, on the assessment settled by the appeal court.

VI.—The Assessor shall be entitled to all legiti-

The Assessor shall be entitled to all legitinate means of information, for ascertaining who are residenters in the parish, and what property is

are residenters in the parish, and what property is liable to be assessed.

VII.—Notices, intimating the amount proposed to be assessed on each individual, and the period within which he must appeal, shall be sent round amongst the rate-payers in the usual manner. When the assessment-roll is made up it shall at least lie fourteen days at the Collector's office, for the inspection of the rate-payers, previous to the court of appeal; and, thereafter, to be patent to the rate-payers at all seasonable times.

VIII.—That a general meeting or head court of the rate-mayers while he held annually at which a

rate-payers at all seasonable times.

VIII.—That a general meeting or head court of the rate-payers shall be held annually, at which a report shall be made of the state of the poor, the amount of assessment levied, arrers due, and the general working of the system.

IX.—That such further rules and regulations may from time to time be made by the Magistrates and Council as may be required: provided these do not encroach on, or alter, or abrogate what may be deemed fundamental rules.

The squatters are returning to the runs they had formerly been obliged to abandon.

THE INCOME TAX AND THE AUSTRALIAN ABSENTEES.

The Australian absentees in England it appears are subject to the income tax it appears are subject to the income tax amounting to 7d. in the pound on the proceeds of their property here; this we suspect will bring some of them back to New South Wales. A gentleman lately arrived had just resigned his lodgings in London, when he was applied to by one of the commissioners, to ascertain the amount of his income, derived either from property in England or elsewhere. He congratulates himself on having escaped the impost by ceasing to be a resident less than an hour before the application. We have just learned, that a young man employed by a house in Sydney as their agent, and paid by them a yearly salary, has applied to his constituents for indemnity from the impost. Several extensive Australian proprietors now in England, we fear, in these horrid bad times, will find it a rather serious inroad on their resources.

SUICIDE .--Mrs. Eliza M'Kenzie, the wife of Captain M'Kenzie, of the barque Mary Gray, put a period to her existence on Sunday evening, by cutting her throat with a pair of small scissors, having died before surgical assistance could be obtained, and within a very short time after committing the rash act. She had been depanged during the day, more especially during the short absence of her husband, who went on shore in order to procure medical advice. At length, however, by the persussion of the second mate, she retired to her state the second mate, she retried to her state room for the purpose of taking some rest; but she had not been there long before the second mate, hearing something like a gurgling noise, ran in and found her standing up with her back against a berth, and the blood flowing coplously from a wound in her throat. On sacing this, he laid her on a chest, and endeavoured to staunch the flow of blood by fastening a towel and other bandages about the throat; and having called some of the other men to his assistance, he ran on deck and sent ashore for medical aid. Before this aid, however, could arrive, the unfortunate woman had expired; a pair of small scissors covered with blood, were found lying near her. From the appearance of the cut it was evident that after having driven in the point of the scissors, she had taken three distinct cuts before throwing them down, The wound was therefore large, and such as could not fail to ensure a speedy death.
