#### COLONIAL POLITICS.

FREE TRADE.

If Noah had shut himself up in his ark and let his family eat nothing but what could be grown upon his decks, he would soon have had an outery against population and an Emigration Committee!!! and Shem, Ham, and Japhet would have been "distressed manufacturers." It can make no difference except in the size of the experiment, whether men are confined to the corn of an ark or of an Island.—Colonel Thomson's catechism on the corn laws.

We have now entered on the subject of restrictive commercial legislation. In our last we briefly adverted to the arguments of Mr. Berry, in favour of a protective duty on corn. The tenor of Mr. Berry's lengthy dissertations goes to associate the present monetary difficulties with the absence of such a tax as cause and effect. Nothing, however, beyond the relation in point of time has been adduced to establish such a connection. Mr. Berry has failed, or rather has not attempted, to show that commercial depression is uniformly attendant on such a state of things as has hitherto obtained in this Colony: or that England, during the period when a restrictive commercial policy was adhered to, was free from such vicissitudes as that which we are now suffering. When Mr. Berry shall have established these two propositions, then, but not till then will the alleged relation between free trade in corn and the present monetary depression be satisfactorily established.

Among the quack politicians of Mr. Berry's school, the imposition of a corn law is gravely proposed as the grand panacea for all the ills under which the Colony is now labouring; and as it is likely to receive no small degree of favour in the New Council, it becomes of importance that the question should now be studied in all its bearings.

We have quoted above a passage from Colonel Thompson's celebrated catechism, which sets the real merits of the queston in a very forcible light. It is our intention in the present article, to review a few of the more prominent arguments pro and con, and to point out the fallacies that are every day promulgated on this subject by our colonial politicians.

An argument from an analogous case in favour of unrestricted trade in grain has just met our eye, in a late English periodical, with which we shall preface the few remarks we have to offer. It goes to what we consider the very root of the subject. The argument, our readers will perceive, precisely corresponds with that of Colonel Thomson:—

Thomson:—

About a century ago numerous bills were introduced into Parliament for making and improving roads, especially those leading to and from the metopolis: the landlords and farmers of the adjoining country petitioned against these improvements, on the ground that they would open the way for agricultural monopoly which they then enjoyed of supplying the Loadon market: they urged that, in consequence of high rents, high priced labour, and other burdens upon land, they could not maintain a competition with the more favoured districts at a distance. Had their opposition been successful, the rapid increase of London would have been retarded, for her food market must have been scantily supplied. But the roads were made, produce from a distance was plentifully upplied, vast imports were made to send back in exchange for those agricultural productons, spreading wealth and means of enjoyment all over the country;

but what was the effect upon the immediate surrounding districts? Was the land abandoned as valueless P Did it all become a dreary waste? Is London surrounded by a belt of desert? No; in consequence of the unexampled increase of that city, which could not have been had she been imperfectly supplied with food, the whole of the surrounding country for miles and miles is scattered with hamlets and villages teeming with population, alorned with the villa of the merchant and the box of the citizen, separated by fields of artificial fertility, superior perhaps, to any in the world; and the dreary heath and trackless wild, once the robber's haunt, the traveller's dread, are now smiling with fertility, or, perhaps, included as suburbs of the great metropolis; and it would be a curious calculation to determine how much the landholders have been benefited against their will; how much more rent is now paid for the little slips of garden or building ground than could possibly have been paid for ordinary culture had the increasing population of London been compelled to go to a distance for food instead of sending for the food from thence. The short sighted policy apparent in the outery against the promotion of internal communication, experience has now shown to be equally characteristic of the outcry for protection to the agriculturists which produced the English corn laws; which politicians of every shade in the mother country, from the ultra tory to the radical, now unite in condemning as an evil, although in the mode of applying a remedy for that evil a great diversity of opinion exists. They were but a temporary expedient at the first, and adopted for a selfish and immediate object (without a moment's regard to remote results) by the aristocratic land holders and law-makers of the day. They answered their immediate purpose; but like all other legislation for a temporary emergency, in which the sound principles of political economy are sacrificed to present expediency, they have been found ultimately productive, if not of positive injury, at least of no positive advantage to those for whose interests they were in the first instance designed.

The sensible remarks of our old friend, Colonel Thompson, on this point, are deserving of serious attention. He says—

"A flush of employment was given to the farmers when the Corn Laws were imposed. But what is become of it now? And is the final consequence to the farmers anything, but that they are four where they ought to have been three, and that the four are worse off than the three? They are worse off, because farmers, like other men, will have children—nay, they are rather more given than most other people to the practice. But the means of providing for children are cut off. Jack, and Tom, and Harry, naturally each want a farm a-piece, if they could get it. But are they likely, or is it possible that they should get it? It is clear that nothing can be done for them, but wait for the old man's death, and then either two of the three must shift for themselves, or they must subdivide the farm, which in no long time will bring them or their posterity to be day-labourers. Now, before the Corn Laws, the world (when fighters would let it) was open for men to advance their fortunes in. The myriads who raised themselves by manufactures and foreign commerce though they did not go abroad themselves, were examples of this truth. The country was a growing country; no man had said to it, "Hitherto shalt thou grow, and no further." But all this is altered now; and the farmers, like other people, are sufferers in the end for the great injustice."

Now, we are always disposed to bring every political theory to the test of practical experience, where such a test is available; and with such an example as that of Great Britain before our eyes, we cannot

but regard it as a species of infatuation to call for the adoption here of a system which experience there has proved to be radically evil. We ask any reasonable man whewhether with such an example before himeven granting that the imposition of a bread tax (introductory as it must necessarily be of an artificial and unsound political state,) should be productive of a temporary activity in the agricultural interest-he can so far forget what is due to the great and permanent interests of society as to countenance the adoption of a system, evil as experience has shown it to be, of which Great Britain now finds it so difficult to disencumber herself as the altered circumstances of society demand.

But it is contended that our case is essentially different from that of the Mother-Country; and however injurious corn laws may be there, where the great manufacturing and commercial interests, who form the main stay of the nation's prosperity, are hampered in their operations by the existence of such restrictions on the interchange of commodities, the circumstances of society here are widely different, and no such interests are opposed to the adoption of such a measure, remedial as it is alleged to be in its immediate, if not in its remote results.

The difference, however, is more imaginary than real. The only real difference is, that we are in a position to profit from the experience of the Mother Country, by adopting such a course of legislation as has proved of permanent rather than of temporary utility.

We may not have widely ramified interests existing, to which the adoption of a restrictire system threatens immediate and extensive injury; but these interests art in process of formation, and their full developement will necessarily be retarded by the adoption of a restrictive policy. There are besides classes in the community whose interests are equally entitled to protection and consideration, and the protection given to the agriculturist would be to these the infliction of positive injustice.

But it has been alleged (and repeated notwithstanding its manifest absurdity) that if the agricultural interest is properous, a greater activity will prevail through every department of industry by the expenditure of the increased revenues derived by the agriculturists from their produce. Those who use this argument, however, forget that the increased revenue referred to, is drawn from the community at large, and that it would be quite as likely to be employed in promoting internal industry if allowed to remain with its original owners. It should be remembered that no new capital is created by protection. A different distribution of the existing capital among the various members of the community is all that is aimed at: and by that object being forcibly effected, and the natural course of things being for that purpose thwarted, a chance of a more judicious and productive outlay on the part of the non-agricultural classes of their original portion of that capital is lost.

It is again urged that the question here bears a totally different aspect from what it does in the Mother Country: inasmuch as the English merchants carry their goods to a market where corn can be received in exchange-but we have no such advantage-our vessels go to America in ballast, and we purchase our cargo with hard cash, so that the Colony is drained of its circulating medium. This is the grand argument of the advocates of a restrictive policy. "Keep the money in the country"-the constant cry of these sagesmay sound very wise in the ears of the unreflecting: but those who have studied the subect regard it as the very reverse. The old fallacy, that " money is wealth" lies at the bottom of it, but money is not wealth, but its representative; and it cannot be better employed than by sending it out of the country, if by that means a greater quantity of those commodities which constitute either the necessaries or the luxuries of life can be obtained for it, than by retaining it at home. If the quantity of coin in circulation is thereby for the time diminished, what is the consequence? Why, a fall in the moneyed price of all articles is the necessary result; but that is all and but for external liabilities which we have no right to incur, our circumstances are none the worse. But the Americans do not take our goods in exchange! That is a great and a manifest error. They take our cash, which we have purchased with our wool; and where is the difference between doing so and taking the wool at first hand? All that we have to do in the matter is to see that we get value for value, as much in exchange for our commodities as we can.

But the colonial opponents of free trade in corn are mistaken in supposing that there is anything different in this respect in our circumstances, from those of the Mother Country. We find precisely the same case put and answered by Colonel Thompson, in his own quaint effective style:—

"That the people on the shores of the Baltic consume none of our commodities. They take our gold, and they proceed to France and the Mediterranean and purchase wine, brandy, and fruits. They buy none of our muslins. Linens they get at Hamburgh; and hats, hosiery, and woollens, in France and Holland."—Watchman.

"Suppose they do take gold. The gold must be bought with our commodities; unless it can be shown that it is given to us without. Put the case that the people of the Baltie would take nothing from us but Turkey coffice. What would be the result, but that English goods would be sent to Turkey for coffee, instead of being sent to the Baltie direct? A trade in gold is as good as a trade in coffee, or in anything else."

What will our balance-of-trade-economists say to this? Where are the innovations of these modern political philosophers to end?

But the question, we are told, resolves itself into this, "Is this country to be an agricultural country, or is it not? For if it is, it can only be by means of protection."

To this question we have only one answer.

certainly not; if the object can only be attained by means of protective duties. But we are confident that it can and will be attained in process of time without the intervention of such means at all. Agriculture in many parts of the Colony can still be successfully prosecuted, notwithstanding American competition. Where it cannot it should not be attempted. The dictate of common sense is, "that our industry should be directed to the production of such articles as are attended with greater final advantage, in preference to those which are attended with less," and this will be the certain result of leaving things to their own natural course-

Mr. Allwood's third lecture was delivered at St. James' Grammar School, to the Church of England Book Society, on Wednesday last. The subject of the present lecture was the testimony of the early fathers on the subject of the Papal claim to universal jurisdiction over the Church of Christ. The points Mr. Allwood endea-yours to establish by reference to the early fathers-as witnesses to the actual constitution and government of the Church in their own times—are, that the apostles were by them regarded as equal in authority; and that all who held the Episcopal office, had and excercised equal and independent jurisdiction. These points Mr. Allwood uncontrovertibly proves—and shows that although the Church of Roome, from its position in the centre of the civilized world, necessarily acquired at a very early age extensive in-fluence among the Churches, any superior jurisdiction now alleged to be vested in that Church was generally repudiated throughout the Christian world in the early ages. For the Christian world in this purpose he quotes Irenaeus, Tertullian Origen, and Cyprian, whose concurrent testimony is such as cannot by possibility set aside. We can only afford space for two brief quotations from those advanced by the lecturer. The first is from the opening address of Cyprian to the Council of Carthage:—

It now remains for each of us to pronounce It now remains for each of us to pronounce his judgment on the present question; judging no one, and denying to no one the right of communicating his opinion; for none of us has elevated himself into a Bishop of bishops, nor does any of us endeavour by the tyranny of his censures to reduce others to the necessity of agreeing with him; since it is the right of every bishop to judge for himself, and to exercise his own authority, and since none can judge another any more than he can be judged by nnother. But let us all expect the judgment of our Lord Jesus Christ, who, and who alone, has the sole power, both to set us in the place of Governors of his Church, and to pronounce judgment on our proceedings. ment on our proceedings.

The second quotation is from a letter addressed to Cyprian, by Tirmillian, bishop of Cæsarea, in which the bishop of Rome is apostrophised in the following terms—indicative of anything but that respect to which his holiness as the infallible successor of Peter, the first of the apostles, and keeper of the keys, must necessarily have been entitled :-

entitled:

You fear not the judgment of God, while you hold out the witness of your approval to heretics against the Church, though the Scripture saith 'a false witness shall not go unpunished.' Verily you are worse than all the heretics; for when perceiving their error, they come over to you, that they may receive the true light of the Church, you rather support their errors, and obscuring the light of ecclesiastical truth, involve them in a darker night of heretical darkness. Of what dissention and division throughout all the Churches have you secumulated on your shoulders by cutting yourself off from so many flocks? For you have cut off yourself. Be no deceived; he is in truth the schismatic who has become by his own act an apostate from Church unity; for while you imagine that all can be cut off from you, you have cut off yourself alone from all.'

We entirely concur with Mr. Allwood, in

We entirely concur with Mr. Allwood, in the soundness of the principles he has on the present occasion elucidated, with one single exception—the construction he puts on the Episcopal office. We hold that Mr. Allwood is as much a Bishop in the scriptural sense of that term as his Diocesan, or even his Grace of Canterbury Primate, though he be called, of all England and Metropolitan. And we have no doubt if Cyprian were here to give his opinion it would go to corroborate ours.

By the bye there is another particular in which we must dissent from the reverend lecturer. We cannot conceive how a com-

bination of fallible individuals can make an infallible body, "Can every part depend, and not the whole?" asks the poet in reference to another subject, but the duestion is equally applicable here. We do not believe infallibility to exist any where on earth. If Mr. Allwood does, it is an absurdity in reason, and a heresy in religion. But it would seem from the following passage that something of the kind was passing through the mind of the lecturer :-

passing through the mind of the lecturer:—
In appealing to these early Fathers, we do not regard them as ultimate authority. We look upon them collectively as witnesses to certain facts or truths held by the Church in their age. Like ourselves, individually they were but failible men. We regard their opinions with deference when we read of their zeal, and self-denial, and devotion; but we look upon the sentiments of any one Father upon a point on which he differs from, or has not the consent of, the other orthodox Fathers of the Church, as private sentiments—we attach to them no authority.

Where their witness is unanimous, there we hear
the voice of the Church—where their sentiments
are not in unison, they carry only the weight which
we attach to the individual opinions of, as it may be, good, and holy, and devout, but still, fallible

What they are individually we ceive they must be collectively. By the laws of evidence the testimony of many witnesses, independent of each other, to a fact to which they were competent to tes-tify, necessarily strengthens our belief in its actual occurance; but the belief of ten more in a manifest absurdity, will not render that absurdity one whit more rational; and the belief in any doctrine alleged to be Christian, however, extensively that belief may have prevailed at any given period, is no evidence of its being a Christian doc-trine, unless it be found in the pure and perfect standards of the Chiritian faith. BARER AND OTHERS v. MILLAR.

Kirk V. CONCLY.

The defendant pleaded that he had been induced to make the promissory note when in a state of intoxication, and that no consideration had been received by him for it; that the person in whose favour it had been drawn (Awl, a minor) had handed it to the plaintiff for no consideration, and that the plaintiff merely acted as the trustee of Awl.

Verdict for the plaintiff, damages 401, 000K v. PHILLIPS.

The plaintiff in this case was an attorney of the court, and the defendant an accountant, acting as rustee to the insolvent estate of William Sharp, hair-dresser and perfumer, late of George-street, but now a prisoner in Woolloomooloo gaol. The declaration charged the defendant with having uttered and reiterated a gross and malicious libel against the plaintiff, which was calculated to do the latter serious injury in his profession as an attorney, by imputing to him that he had put forward a factitious claim, as a creditor of Sharp; and also, directly conveying the impression to those who leard the words complained of uttered, that the plaintiff, by swearing an affidavit of the debt he claimed, had committed willful and that he had put forward a fictitious claim, as a creditor of Sharp; and also, directly conveying the impression to those who heard the words complained of uttered, that the plaintiff, by swearing an affidavit of the debt he claimed, had committed wilful and corrupt perjury. The defendant pleaded not guilty. A witness named Oram, at present employed as a clerk in the office of Nicholls and Williams, was then produced for the plaintiff, who deposed that, in consequence of an advertisement which lately appeared in the Heradd newspaper, intimating that Sharp's property was to be sold by the defendant for the benefit of the creditors, he (Oram) went to the adjoining court-room, where the Chief Commissioner of Insolvent Estates was sitting, and applied to him, in order that the sale might be postponed; that while he was making the application the defendant, who happened to be in court, said the words complained of to the Commissioner, in the hearing of nine or ten persons in the court—viz. —" That the plaintiff had put in a fictitious claim against Sharp's estate." Oram then told the defendant than he had made a serious charge against the plaintiff, an attoracy of the court, and that, unless the same was retracted, he would inform O'Cock of what had been said; when the defendant said he might do as he pleased, for he was prepared to prove that the claim, or the greater part of it, was fictitious.

THE TRUSTERS OF HENRY MOON P. C. E. JACQUES

This was an appeal under the Insovent Act, section
36, by the trustees of Henry Moon, against a decision
of the Cheif Commissioner, for having admitted a bebt
for wages as a clerk, as proved by Charles Edmund
Jacques on the 13th of April last.

The Court considered it a wholesome rule, that
where a party claimed a preference for services as a
book-keeper, his efficiency as such should be determined by the accuracy with which his own account was
kept in the books under his control; and in this and
similar cases where such accounts did not properly
appear in the books, the Court would not only be
protecting creditors against imposition, by insolvents
acting in conjunction with their clerks, in refusing to
allow such claims where the clerks' own accounts
with their employers did not as in the present instance,
appear to have been properly kept. There ought to appear to have been properly kept. There ought to have been a wages book kept by the respondent, for his own security, and as such had not been the case, his claim to a preference must be rejected. At the same time his Honor was of opinion that by its rejection, he was sufficiently punished for not keeping his own account properly, and therefore each would have to pay his own cost,

EX-PARTE THOMAS ASHTON—THE WINDSOR REVISION

EX-PARTE THOMAS ASHTON—THE WINDSOR REVISION COURT CASF.

This was an application for a mandamus, calling upon the magistrates and assessors of Windsor to assemble for the purpose of reconsidering the claim of Thomas Ashton to have his name inserted in the electoral lists, or commanding George Thomas Wyatt, the Clerk of the Court of Revision, to insert the name of Thomas Ashton in the list, as a person entitled to vote at the election of members of council for the

or tenties Asimon in the iss, as a jesson tentied to vote at the election of members of council for the Cumberland Boroughs.

Mr. Purefoy appeared on behalf of Thomas Ashton, and applied for the writ npon three different affidiavits. He then read the affidavit of Ashton, which stated, that he then resided, and had resided for one year and ten months, in a dwelling-bouse in Lennox-street, Windsor, of the clear annual value of £20; that he claimed to have his name inserted in the list in virtue of such qualification; and believed that notice of his claim was duly served upon Wyatt, the Clerk of the Court, on the 22nd day of April, and that the notice was, in substance, in accordance with the form and spirit of the statue. That in pursuance of the notice of claim he attended the Court of Petty Sessions for the revision of the

the Clerk of the Court, on the 2Zard day of April, and that the notice was, in substance, in accordance with the form and spirit of the statute. That in pursuance of the notice of claim he attended the Court of Petty Sessions for the revision of the electoral list, on the 6th of May, and was examined by the magistrates adjudicating, and proved his qualification to be retained; but although notice was admitted by the clerk to be in his possession, and had been served within the time, the magistrates refused to insert his name unless a written copy of the notice was produced in Court, and proved. Mr. Windeyer remarked, that the ground on which the application rested was, that the ground on which the application rested was, that the grievance which Ashton now brought before the Court was one which presented no form of remedy, except by its prescribed; and the same clause them goes on to prescribe what the Town Clerk or person in his place shall do with these notices—make up his list from them, &c. It is given upon affidavit, that the present applicant made such a notice, which was served upon the clerk, that when he went before the Magistrates to prefer his claim, it was admitted that he had the notice in in his possessession. It was on this ground alone his client sought the interference of their Honours, and he hoped that they would direct the Clerk of the Revision Court to enter Ashton's name on the list,

Mr. Fisher submitted that it was quite sufficient to show that, in this case, there was a legal right to the secretise of the franchise; and that the court could authorise the clerk, lawfully, to put the applicant in the position he had a right to. It would not then the position he had a right to. It would not then the an illegal act on the part of the clerk, from the fact that the court could not direct the performance of an illegal act. The clerk could not, without the necessary forms, insert the name; but when the court, by virtue of the plenitude of its jurisdiction gare such directions, from that moment it became lawful. The Chief Justice was of opinion that that might become an ulterior question, if an unsuccessful candidate thought proper to petition the Legislative Council against the return of a successful opponent. The matter might then be referred to a committee of the house, who might reject this man's vote because he had not compiled with the necessary forms.

Mr. Fisher did not think that could be the case, from the reading of the 44th section, which was as follows;—"And be it enacted, that the court shall not have power to enquire into the correctness of the register of any electoral district, or into the qualification of persons whose votes may, on the day of election, have been either admitted or rejected, but simply into the identity of the persons, and whether their votes were improperly admitted or rejected, assuming the register to be correct." So that the Court of Appeal, as suggested by his Honour, as in the case at home, could have no existence here.

Mr. Justice Burton said, there was another point which he thought should be fully argued; there was no enquiry as to whether a person's vote should be objected to if he tendered it at the day of election.

Mr. Justice Stephen did not see any portion of the Act which stated that a person was not entitled to vote if his name was not on the list; there was no such

if his name was no out the expres provision.

Mr. Fisher said, he would be happy to abide by his Honor's view of the subject.

The Chief Justice observed, that it was not pretended that the applicant had no abstract right to rank

The Solicitor-General raised some technical objections to the affidavit, which were for the most part overruled by the Court.

#### CITY COUNCIL.

Yesterday the City Council met for the despatch of business, his Worship the Mayor in the chair. After the reading of the minutes, the business of the day was proceeded with. Alderman Flood moved, that the council resolve itself into com mittee, for the consideration of certain accounts that had been presented against the Corporation, which, it appeared, the finance committee had neglected to examine. This, it was contended, was just equivalent to declaring the finance committee, to whom such matters had hitherto been referred defunct, or at least totally inefficient; and, on an explanation being offered why the committee had not met, the worthy alderman withdrew his motion. A letter to the Mayor from Mr. Leon, oil merchant, withdrawing his lighting tender, was then read-The reason for such withdrawal was said to be, that, instead of deciding on the tenders when opened, on their respective merits, the council had entered into negociations with one of the contracting parties without having come to any decision. Mr. E. S Hill and Mr. G. Moreton were tendered to the council and accepted as sureties for Mr. Hilley, one of the recently appointed collectors of rates. The furniture com-mittee was requested to make enquiries as to the price at which an iron safe could be obtained for the safe keeping of council documents. A lengthened discussion ensued in consequence of Mr. Holden having called the attention of the council to an advertisement, signed by the Town Clerk, intimating to the public, that remonstrances against the rates of Assessment would be entertained by the council on Monday; but those only of which previous notice had been given. He was aware that in many instances the assessment was much too high; but the parties aggrieved had been by surprise, and he thought that on the first occasion of municipal taxation, the greatest latitude should be allowed in making complaints; he had understood that viva voce remonstrances would be entertained, and he was not aware of any authority that had been given to the Town Clerk to intimate to the contrary. (The town clerk read the resolution adopted at last meeting). Mr. Holden would move then, that viva voce complaints should be entertained. Alderman Flood protested against such a proceeding as altogether irregular; the motion was nothing more than the amendment that had been moved at a former meeting, and the Council by entertaining it would only stultify themselves. Alderman Broughton contended, that the motion required previous notice, and could not now be entertained. Mr. Holden gave notice accordingly, and withdrew the motion. It appeared that the complainants had been employed on board a vessel named the Favorite, which had been lost at the Richmond River; siter her going ashore they obeyed the orders of the Captain in preserving a part of the wreck, which has been brought on to Sydney in the Northumberland. The defendant being owner, had been applied to for the amount, but he had refused to pay it, the wreck not having been sold. The bench ordered him to pay the full amount of 141, 182s, with 51. 3s. costs.

The charge being admitted by the defendant, the Bench sentenced him to pay a fine of 251, with 40s. costs, and the gunpowder to be foresited.

Mr. Robert Russell appeared on summons, charging him with having committed a violent chassault on Mr. Dunlop. Complainant stated, that on the 9th May, he had gone into a boat from Rostron's Wharf, for the purpose of looking at some spars, which boat he considered belonged to Mr. Rostron. After getting some distance from the shore, defendant called out to him to return, and upon his refusing to do so, he followed in another boat with seme of his workmen, and on coming alongside, threw him overboard, and held him under water for some time. From a blow, received either from the fist of the defendant, he had sustained serious injury. The counsel for the defendant (Mr. R. Johnson) stated, that the boat had been taken with the knowledge that she longed to Mr. Russell; and, as she was aground when Mr. Dunlop was thrown overboard, it was impossible for him to have been kept under water; that the plaintiff had been the aggressor, having raised a bludgeon to strike the other, who then threw him overboard in his own defence, in a place where the water was about eighteen inches deep. The beach considered there was sufficient evidence to bring the matter before a jury, and committed the defendant to take his trial for the assault, but admitted him to bail, himself in the sum of £100, and two sureties in the sum of £200 each.

#### COMPOSING AMD DISTRIBUTING MA-CHINES.

CHINES.

Our paper has, within the last two months, contained accounts of the Patent Composing Machine, the invention of Messrs. Young and Delcambre, The last account, which appeared five weeks ago, gave, it will be recollected, a brief description of the machine and a statement of the quantity of composition which it turned out under our own eye, in a given time. In the interval between the appearance of our first and second notice of the machine, but after we had seen it we received information that there was in existence a machine that did all that Messrs. Young and Deleambre's machine did and much more. We were invited to inspect it as we had inspected the first; but as we must have undertaken a journey to London on purpose, we were compelled to forego the pleasure of inspecting the machine personally.

Messrs, Young and Deleambre merely undertake

pose, we were compened to lorego the pleasure of inspecting the machine personally.

Messrs. Young and Delcambre merely undertake to furnish machines for composing: Captain Rosenborg, a native of Sweden, undertakes to supply machines for distributing as well as composing. No practical man who has seen the first composing machine can doubt its efficiency, or that it can set up as much matter in one hour as will take an expert compositor six. Now, the second machine, if we may rely on the statements published of its performance (and we are not, after having seen the performance of Messrs, Young and Delcambre's machine, disposed to doubt them,) sets up as much matter in one hour as will take an expert compositor nine hours; while the Distributing Machine, peculiar to Captain Rosenborg's system, distributes a given quantity of matter in the same time that a first-rate hand can distribute it; thus leaving the gain in the composition without the slightest drawback, which is not the case with the composing machine we inspected.

We understand that Captain Rosenborg's Com-

composing machine we inspected.

We understand that Captain Rosenborg's Composing and Distributing Machines are about to be put to the practical test of their efficiency and certainty in the office of Messrs. Clowes and Son, the most extensive in London. The journeymen have styled them "The Infernal Machines", and view them with feelings of alarm. We shall, we bolieve, be enabled to give a report of the progress of the trial, the issue of which must be particularly interesting, to newspace proprietors. newspaper proprietors.

Meanwhile, we transcribe the following account of the machines from the *Illustrated London News*, which contains an engraving of the Composing and one of the Distributing Machine.

"In one of our early numbers was given an account of a new mode of composing types, the invention of Messrs. Young and Deleambre. We have now the pleasure of presenting two views, one of a Composing and the other of a Distributing Machine, both invented by Captain Rosenborg, and certainly superior, in every way, to any previous ones.

superior, in every way, to any previous ones.

"The setting up of the types, which Messrs. Young and Delcambre were able to do at the rate of 6,000 an hour, Captain Rosenborg states he can do at the rate of (at least) 10,800; and the distributing of the types, which, under Messrs. Young and Delcambre's arrangement, furnishes occupation for four hands, (boys.) Captain Rosenborg does by means of one, with the aid of machinery.

"The mode of working with the working wor

arrangement, furnishes occupation for four hands, (boys), Captain Rosenborg does by means of ons, with the aid of machinery.

"The mode of working with the machine is as follows:—The chief compositor, who sits at the front of the machine, having his copy before him, performs upon the keys as he reads. By the action of the keys, the corresponding letters are forced out from their respective compartments, and are laid down upon an endless belt or chain, which is constantly passing through the middle of the machine, from the right towards the left. By the motion of this chain, the types, when liberated and placed upon it, are very quickly conveyed into the receiver, where, by the action of a small eccentric, which is revolving at a considerable speed, the types are deposited horizontally one above the other, in the same order as the keys are performed upon, and are thus formed into lines, the lines been supported by a T shaped slider, which is made to recede in the same proportion as the types secundate upon it. As each line is completed, (of which the compositor is informed by the dial, and warned by the bell), the compositor takes hold of a small wenab hy his left hand, (the figure in front of the receiver, c) by turning which, the line thus completed is lowered to the bottom of the receiver, while, by moving with his right hand a lever, (not seen in the figure), the line is removed from the receiver into the justifying-stick d, the assistant compositor (as shown in fig. 1, at the left hand of the machine) detaches, with his left hand, the upper end of that stick, (its lower end being moveable upon a fulcrum, as represented at g,) and, having lowered it into a horizontal position, he reads the line (the types standing now in a vertical position). Having corrected such faults as may have occurred during the composition, he, by removing a slider, which constitutes the bottom of the justifying stick, causes the line of type to drop down at once from the stick into the galley, e, where he spaces it out.

"The principal feature of nonely in this machine is the endless chain on which the types are deposited, and by which they are conveyed into the receiver, and the advantages are, the types are carried forward in a straight line by the endless chain, free from all chance of disturbance, and subject to little or no friction; and that as many letters may be set at once as happen to follow in uninterripted alphabetical sequence; and, in practice, there is a vast number of words and syllables which the compositor soon learns to dispose of in this way, by one stroke of the keys. For example, act, add, all, accent, adopt, enuy, are words the letters in which, following in their natural order, may be set up by one pressure of the hand on the keys; the endless chain carries the types forward in the order in which they were deposited upon it, and nothing can occur to disturb that order. So also with such syllables as ab, eff. dem., opp, and iy. The sarriermed) may be thus illustrated. The word accentuation contains twelve letters, and would require

nty-four movements of the arm of a compositor to set up in the ordinary way; but with Captain Rosen-borg's machine it is set up with only three strokes on the keys, as thus, accentu-at-ion.

"Captain Rosenborg states that he has proved, by actual trials, that his machine is capable of delivering, or clearing out types, (supposing them to be composed without regard to order of sequence,) to the amount of 400 in a minute, or 24,000 in an hour. Already a young man, with only a few months' practise, and without a previous knowledge of printing, is able to set up about three lines of brevier in a minute, each line containing about 60 letters and spaces, (this we witnessed,) and, assuming that he is able to do so for a continuance, that is equal to about 10,800 in an hour.

an hour.

"We now present the view of the Distributing Machine, by which a lad can distribute, and replace in the Composing Machine, 6,000 letters in an hour; but this would offer no hindrance to the general operations of any printing-office adopting the system of composing by machinery, for there might be as many more distributing machines employed as composing machines, or the relative speed of the two required; for instance, three of the one for two of the other, five for three, and so on.

The cost of Captain Rosenborg's two machines must, we think, be greater than that of Messrs. Young and Delcambre's one; but Captain Rosenborg himself is of a contrary opinion. The machines lately shown at work in Howard-street, Norfolk-street, Strand, are the most complete ones of the sort, and what they may have cost furnishes, of course, no criterion by which to judge of the price at which they could he manufactured in considerable numbers for sale. They are now in Hull for some further improvements, and will be again submitted to inspection in London when the alterations and amendments are finished."—Morning Chronicle.

The Town Clerk mentioned that he had received a letter from Mr. Morris, whose tender for the repair of Kent-street had been accepted, intimating that he could not find the necessary securities; whereupon Alderman Broughton moved, and Mr. Holden seconded-"That fresh tenders be invited for the performance of the necessary repairs in Kent-street, according to the plans and specifications of the City Surveyor."-Carried.

A discussion on the lighting of the City again arose, in consequence of a suggestion from Alderman Allen, to the effect that a correct copy of the late supplementary report of the Lighting Committee should be sent to the Gas Company. Mr. Smidmore moved the resolution of which he had given notice, "That there be no alteration in the present lighting of the City for the remain-der of the year."

An amendment was moved by Alderman Allen "That the Lighting Committee be directed to invite tenders for 100 addi-tional gas lamps, to be placed in such parts of the city as may be considered most advantageous;" but after some discussion both motion and amendment were withdrawn, and the following motion by Alderman Broughton adopted: "That a copy of man Broughton adopted. That a copy of the Lighting Committee's Report be sub mitted to the Gas Company, requesting them to inform the Council if it be their intention to amend or reform their tender, and that the consideration of the Lighting Committee's Report be deferred till the next meeting of Council.

Alderman Flood then brought forward his motion, "That the council do employ about thirty men for improving the streets of the city, with an efficient overseer to superintend the same." Mr. F. urged at considerable length the advantage that would accrue to the city, by having the men employed in this important work under their own immediate control; and referred to certain accounts, lately presented to the council, to show that the proposed plan would also be far more economical. He had been placed in his present position by his constituents under the impression that he would look strictly into the public expenditure on account of mechanical operations: and he would not consider himself doing his duty to those constituents, if he allowed such loose and unsatisfactory accounts as those referred to, to pass without animadversion. Alderman Wilshire thought, they should set the collectors to work and collect money before they devised means for spending it. An amendment by Mr. Hunt in favour of the contract system fell to the ground, and the original motion was carried.

The following sureties were tendered and accepted on behalf of the collector of rates :

For Mr. Rowley, Messrs, David and Richard Hill, of Pitt-street, were accepted as sureties for the due performance of his duties as collector. For Mr. H. K. Neshitt, Mr. A. Hollinshed, of Kent-street, and Mr. Isler, of Hunter-street. For Mr. Austin, Mr. Kellick, of Phillip-street, and Mr. A. H. Austin, of South Head Road.

After some discussion it was determined, that the Council should sit on Monday next, at twelve o'clock, (for the hearing of appeals against the Assessment, and the Council adjourned to Friday.
