#### THE BISHOP'S CORROBBORY.

THERE was a public meeting held last Friday evening, if not of the sable tribes of Sydney and its vicinity, at least of the men in subles who support Bishop Broughton in his crusade against General Education. The Bishop of course presided at the Corrobbory, which, we have been credibly informed by parties who were present, and who attended to spy out the nakedness of the land, was as tame an allair as could well be imagined; the attendance being very limited, and the public generally appearing to take no interest whatever in the matter. There was one point indeed in the Natural History of the Colony sufficiently cleared up at the Corrobbory, of some importance to the philosopher. It has long been a matter of uncertainty therefore whether the blacks of this country are cannibals: but there could be no doubt of the fact as to those at the late Corrobbory; the only dish, of which all partook with evident gusto, being (horribile dicted that unfortunate man Dr. Lung, whose efforts and services in the cause of General Education had it seems marked him out as a fit and proper person to serve for a meal for the whole Sydney tribe. It was difficult, says the bishop, to say whether it excited most anger, grief, shame, or surprise, to find a serious question proposed to be thus dealt with and by an assembly of legis whether it excited most anger, grici, shame, or surprise, to find a serious question proposed to be thus dealt with and by an assembly of fegisitors; and the just claims of the Church of England sacrificed in subserviency to such a minority as tors. As he had been led to name the Church of England, he would say that he had no intention of entering into any defence of its character and conduct. However these might be arraigned, he was resolved, and he was sure he should be supported in the resolution, not to notice any such attacks, unless they presceded from persons for whom they could feel respect. But his experience in life had shown him, that if there were a man who had forfeited all title to respect, who seldom made an engagement but to deceive, or an assertion but to be contradicted, that man was sure to be found taking the lead in hostility against the Church of Englend. Now nobody who knows anything of the past history of the education question in this colony can doubt for a moment who this full-length pertrait was meant for. Libellous and false, as it is, and without the shudow of a foundation, as a description of the individual for whom it was intended, the bishop knew well that all who heard bim would apply it exclusively to Dr Lang. And what is the ground-work of his whole charge? Why, so early as the year 1829, Dr. Lang, quite voluntarily, and in pefect sincerity, expressed to Bishop Broughton, who was then only an Archdeacon, as it is called, his entire willingness to co-operate for the advancement of education in the colony, with himself and the other Episcopal clergy, on anything like fair and equal terms, rather than with persons who avowedly threw religion out of the question altogether. In short, although it was rather Grammar schools than common schools that were then talked of, Dr. L. did precisely what the other Non-Episcopalian ministers of 1836 did in precisely similar circumstances. Immediately after this interview the Archdeacon happened to leave Sydney on a pretty long tour in the interior, and as it had become necessary for Dr. Lang to act in the matter immediately, he waited, in the Archdeacon's absence, on Mr. M'Leay, the Colonial Secretary, to ascertain the nature and constitution of a Grammar School for Sydney the Archdeacon had then on the tapis. And when

sively on Episcopalian principles, that the Archdeacon, as king's visitor, wou d have the entire control of it, and that no other minister of religion could be permitted to participate in its management on equal terms, he found at once that the Archdeacon was not the man for him, and therefore took the only other course that remained for him immediately. Hinc illue lachrymae! For a few weeks thereafter, when the Archdeacon had returned, and Dr. L. and his brother were walking together along Lower George-street, the Archdeacon, who was walking in the opposite direction, and would otherwise have met them full in the face, no sooner observed Dr. 1., than he instantly diverged from his straightforward course, and crossed over to the opposite side of the street ! Mr. Andrew Lung observed the manœuvre, and when he mentioned the circumstance on returning home to Mrs. L. sen., his late mother, the old lady merely said, in the Doric dialect of the land of Burns, what we cannot help repeating in reference to the bishop's calmanious speech at the corrobbory-" Pair cruikit body !"

Now for the Rev Mr. Walsh. Let us see how he bandles his waddy. He is speaking of General Education as something which he thinks either calculated or designed to put down the Church of England.

Any thing to put down the Church of England—and therefore anything, whether true or not, wherewill to revike her. So one honorable member, who certainly should have been either a Pope or a Lawyer, rather than what he is, said the Church of England had done nothing for education for the hast three hundred years. Very likely not, in that gentleman's estumation, who certainly did not agree with the Church of England as to what cdu cation is. She had indeed done nothing that he would have her to do; but all must know that he speke untruly. The assertion however suggested the remark, that here at least the Church of England had not been idle; here for some time she was the sole, and was still the principal source of education. principal source of education

Dr. Lang must be greatly obliged to Mr. Walsh for his high opinion of his ability either for the Popedom or for the Bar, although he happens not to be a caudidate for either of these offices at present, any more than his friend Mr. Walsh himself. But Mr. W. himself spoke untruly when he accused Dr. Lang of saying absolutely that the Church of England had done nothing for education these three hundred years, He spoke comparatively, and proved to the satisfaction of every candid person, that taking into consideration her enormous wealth and her means of influence, she had done less for Education in England and Ireland during the last three centuries, than any Christian Church in similar circumstances had ever done since the days of the Apostles. Of course she was the principal source of education here in the days of the Church and School Corporation, when she had a seventh of all the land in the Colony, and an unlimited credit besides. But what sort of a source of education was she then? Why she had not a single school in the Colony where a boy could be taught the rudiments of Latin or the elements of Mathematics !

Come we now to the Rev. Mr. Allwood, from whose speech we must make the following rather long extract :-

members, in his speech upon education, was reported to have said, that "he was enabled to state as a positive fact that the Protestant Episcopal Chirch in America willingly con-curred in a system of education, the basis of which was the unrestricted use of the Hoty Ser plures without note or comment, creed or catechism, not only in the common schools, but equally so in the Sunday schools also (From which it was evident that they would most cordially oppose the Irish system, which forbids the unrestricted use of the Holy Scriptures): and he goes on to say, that he was astonished to find, from the answers of your lordship and myself before the Select Committee of Education, that we questioned the fact. That to satisfy himself on the subject, he went to the American Consulate, and learned, from the American Consuland another American gentleman whom he tound with him, that, as far as either of these gentlemen had heard, the system either of these gentlemen had heard, the system had never been objected to by the American Episcopal Church. In his (Mr. A.'s) evidence before the Committee, the question was put to him by Dr. Lang—"Are you not aware that the Episcopalian Church in America goes cordually with the system, not merely for the week day, but for the Sabbari instruction, bis-d on the use of the Scriptures alone?" To this he the use of the Scriptures alone? To this he had replied, "So far from being aware of this, I am prepared to say from my own personal knowledge of the Episcopal Church in knowledge of the Episcopal Church in America, that such is not the case. I have known a great many of the Episcopalian clergymen in all:parts of the United States; I have had every opportunity of tearning their sentiments, and I have invariably heard them speak of the system of Education in the nitional schools of England, as once to be highly prized," This reply was not made at high prized. This is own personal knowledge. He had travelled through a great portion of the United States—he had had the aequaintance of the clergy in all parts of the Union, and he repeated again the assertions which he made before the Committee as to their sentiments. It was a cause of mutual rejoicing to both It was a cause of mutual rejoicing to both branches of the Christian Church, that the tranches of the Christian Courte, that the Church of England, and her daughter in the Episcopal Church in America, were one inopinion and in love, bound together by the strongest bonds of Christian sympathy. This was a truth which was well known to all conversant with the real state of the two Churches. It was true that an American authority on this side of the water had been entrated against him; but without any wish to disparage the opinions of the gentlem in who had been ap-appealed to, he would submit, whether a Clergyman like himself, travelling through America, anxious to obtain information as to America, anxious to obtain information as to the opinions of the Church there, received everywhere as a brother and fellow-labourer, was not as likely to know what their sentents were, as an American Consul in New South Wales? Had it been a matter of tariff, nullification, or repudation, he should have bowed to such an authority; but in the present case, he must still hold to the opinions which he had expressed, and the gentleman must pardon him if he thought that it was just possible that an American Consul might know as little of the sentiments of the Episcopalian Church in America upon this point, as his friend did of the doctrine of the canonical obedience of the Church of England. Whilst on this point, he wou'd read an extract from "Baird's Ra'ig on in the United States of America", published in Glasgo \*, in 1842-3 The writer was a Presbyterian Minister, and his work had been recommended to the notice. his work had been recommended to the notice of the public by three Presbytrian Ministers of Edinburgh. At page 342, speaking of the Sunday School Union, he said:—"Besidesthis great Society, there are other Sunday School Societies, not less efficient in their respective spheres. The Episcopalian have theirs the Baptists theirs, the Episcopalian Methodists theirs, the Lutherans theirs, and so forth. All the Denominational Sunday School Societies publish books for their own schools, and in these they set torth and define the Societies publish books for their own schools, and in these they set forth and define the peculiar views they hold respectively on points of doctrine and discipline." How this accorded with the assertion that the Episcopalian Church went co-dially with the system based on the use of the Holy Scriptures alone, without note or comment, creed or catechism, not only for the week day, but for the Sabbath instruction, he must leave to the gentleman who made the statement to explain. statement to explain.

was not so much an opposition to Lord Stanley's system as to any General System whatever. And his reference to the Ep.scopal Church in America was made for the express purpose of shewing that, while Bishop Broughton set himself against a General system on the basis of the Holy Scriptures in the authorised version, such a system was willingly concurred in by the American Episcopal Church; and the inference he evidently wished to draw from such a fact was that it was not the Bible in any version that Bishop Broughton wanted-for he would'nt have the Bible when actually offered him on the basis of the British and Foreign Society's schoolsbut money and power. Dr. Lang's authotity for the statement he made as to the concurrence of the American Episcopal Church not merely in the common school system of that country, but in the General Sunday School union, in which the Bible is the only manual of religion, was the Rev. Dr. Tyng of Philadelphia, one of the ablest men of the body, and the Editor of the principal Magazine of the Evangelical portion of the American Episcopal Church. And although it may suit the modern theology of the Episcopal communion in this Colony to attempt to throw ridicule on the idea of referring to intelligent laymen for information on any subject relating to religion or ecclesiastical affairs, we are decidedly of opinion that Mr. Williams, the American Consul, and his friend, Mr. Wilkinson, were quite competent to testify to the plain matter of fact as to whether there were or were not separate Episcopalian schools in the States of New England and New York. Of such schools these gentlemen never heard, and they never heard of any objections to the common school system of their country on the part of the American Episcopal Church. The fact that besides the great Sunday School Union for all denominations of American Protestants, there are Denominational Sunday Schools for a portion of the Episcopalian, Methodist, Baptist, and Lutheran communions, is no argument whatever against Dr. Lang's position that the American Eviscopal Church concurs most willingly in the common school system of the country. The only matter of wonder is that so large a portion of that communion concurs, as Dr. Tyng publicly stated that it did in Exeter Hall, in the General Sunday School System. No doubt many American Episcopalian clergymen would prefer an exclusively Episcopalian school system, just as Dr. Lang and other Non-Episcopalian ministers would prefer the British and Foreign or the Scotch School system for the colony; but they can't get it, the thing is hopeless, and there's an end of it. Mr. Allwood has therefore entirely failed to bring forward a single syllable to controvert Dr. Lang's main fact, and we think he has scarcely dealt in common candour with his argument.

We have something more to say on the sentiments put forth at the Bishop's Corrobbory, but we have fairly exhausted our space for this week. In the meantime let us press upon the friends of General Education the necessity of being up and doing. The enemy is not only numerous and active, but completely organized. In our opinion there is only one way of answering all his arguments, his calumnies and misrepresentations; and that is by the establishment of a Model School in Sydney, in which the Stanley System may be seen in full and beneficial operation, and all the impudent insinuations of interested parties about its in ligious and infidel character and tendency silently related on the spot.

TO THE PRESBYTERIANS OF MEL BOURNE AND ITS VICINITY. Sydney, 29th October, 1844.

CHRISTIAN FRIENDS AND BRETHREN-YOU will all doubtless have heard, ere this reaches you, of the result of the late annual Meeting of the Synod of Australia. After all the pompons fanfaronade about the Free Church in certain quarters, both with you and with us, the affair has ended merely in a Resolution to retain the Government-salaries by all means and at all hazards. Not that I have any idea that these salaries would have been at all endangered by a bold and vigorous movement on the part of the Synod in favour of the Free Church ; for I am decidedly of opinion that if such a move ment had been made by the pretended friends of the Free Church in that body, their salaries and Church-property would most willingly have been secured to them by the Colonial Legislature. Had the Synod-men, therefore, had " faith even as a grain of mustard seed," they would have said to that mountain of difficulty which their own fancies had conjured up in the direction of the Free Church, " be theu removed, and be thou cast into the sea? and the thing would have been done, if not forthwith, at least very shortly. But I am truly sorry to say, for the credit of the Colonial Presbyterian Church, that they shewed them. selves to a man utterly destitute of that high and honourable principle which animated the Free Churchmen in Scotland, those worthy successors of the heroes of the covenant, on the ever-memorable occasion of the Disruption of the Scottish Establishment in the year 1813, Contrast the conduct of our Colonial Free

Church-men-in remaining, precisely as they were, in a state of incorporating union with the State Church of Scotland, (for it is absurd to pretend that they are not so, as is attempted tobe done by some of these Colonial shufflers.)with that of the whole thirteen of the General Assembly's missionaries in India; all of whom without one solitary exception, declared immediately for the Free Church, and relinquished the valuable buildings belonging to the State Church in which their mission had previously been conducted, retiring to their own hired houses" with their consciences unsullied and their honour unstained-contrast, I say, the manly, honourable, Christian and heroic conduct of this glorious "band of brothers," with the pitiful evasions of our pretended Free Churchmen, and ex plain, if you can, how it has come to pass that Divine Providence has sent us such miserable specimens of Presbyterian humanity to lay the foundations of a Christian Church in this land. During his visit to Sydney to attend the late meeting of Synod, the Rev. Mr. Mowbray, of Campbellfield, Port Phillip, has, it seems, re ceived an invitation from certain parties here to form a Presbyterian congregation in this city Now as you may probably be mis informed from other quarters both as to the origin and the object of this man couvre, I beg to inform you that it has originated with Mr. Thomas Barker, Dr. Wallace, and Mr. John Gilchrist-three gentlemen who for many years past have belarged, not to my congregation, but to that of the Rev. Dr. M'Garvie, one of the Synod's own ministers in Sydney; the other of the two they have here being your acquaintance Dr Fullerton, the worthy correspondent of the

therefore, as I have no doubt you will that the manœuvre of these gentlemen, in inviting Mr. Mowbray to Sydney, is to be understood as the result of a defection from my congregation. On the contrary, it is merely to be regarded as the solemn testimony of General Education to carry that object of the whole three"that the Synod of Australia has no minister in Sydney to whose congregation a respectable Presbyterian can attach himself with any satisfaction" - a truth which I confess I have no intention to dispute.

Attempts will no doubt be made, as I am aware they have been already, to strengthen the faction-Young Sydney, I suppose we must call it, after the example of Young Eugland and Young France-by gaining adherents from all quarters, and especially from my congregation; for Dr. Wallace: in particular, (who, I understand, was prime mover in the matter, and who invited Mr. Mowbray up to Sydney some months ago) has been quietly endeavouring for a considerable time past to carry off certain influential members of my congregation-a species of procedure which he may perhaps be better able to reconcile with the duties of a christian and a centleman than I am. And such efforts will, I have no doubt, be successful in some instances, partly from family connexions and partly from the love of novelty and the natural fickleness of men. Now it is this particular feature of the case, its bearing on my congregation, that has given it peculiar favour in the eyes of the Synod, and particulary in those of the Rev. Mr. Forbes of Melbourne. In ordinary circumstances these gen tlemen would have reprobated and condemned any attempt to excavate a voluntary congregation out of one of their own State Church congregations; but an attempt to break up my voluntary congregation has so much to recommend it in that quarter that it must by all means be encouraged.

I confess that if Mr. Mowbray were a mar of very delicate, I will not say Christian, feelings, he would hesitate a little before accepting an invitation that has originated in a positive accession from one established congregation, and that rests its hope of success on the prospect of breaking up another. But Mr. M. has been offered £200 a year to come to Sydney, and it seems he has only £100 a year at Campbellfield, where his congregation, as is alleged, consists this fly of poor people - people who, of course, have no souls to be saved and whose spiritual welfare may therefore be safely sacrificed by their loving pastor for £100 a year! It is thirteen years now since I published my opinion of the heartless and unprincipled character of such translations, in Notes to a Sermon preached in Glasgow in the year 1831. and I have no intention to say anything fur ther on the subject at present.

Mr. Mowbray, I understand, has also been buoved up with the expectation that his friends here will get my church for him by and bye, as well as the Government salary I threw up in the year 1812; but Mr. M. must be a very sanguine young man indeed if he believes any such nonsense. He may rest assured I am too old a hand in this Colony for anything of that kind to succeed. Let him come here when he may, he must come as a Voluntary Minister, depending exclusively for his subsistence on the liberality of the Christian public; for it is vain for him to think he will ever be allowed to

touch the salary I renounced.

Now if Mr. Mowbray were a man of really popular talents, I would say to him, " come to Sydney by all means as a Voluntary Presbyterian minister, for yet there is room." Indeed it is now more than seven months since I sent for a minister of this description for the city my self, whom I expect out from Scotland by and bye to co-operate with me in Sydney and its vicinity. But Mr. M. is not a man of popular talents. He and all his father's family be longed, not to the Established Church of Scot land, but to the Relief Church at home, in

which it is well known no preacher without popular talents can ever hope to succeed; and was the fact of his not possessing such talents that led him into the Establishment, where, as is equally well known, they are not so indispensable. Now although Mr. Mowbray may pass muster with his Sydney friends for a time while the charm of novelty and the spirit of faction continue to operate, it is quite possibl. that he may not be a fit and proper person for the Voluntary System in this city, and that some of those who may perhaps welcome him now will in all probability be the first to leave him for my man, the thorough Voluntary, when he somes.

Let Mr. Mowbray then beware of trusting to a broken reed that may yet pierce his hand. In regard to his principal supporters, Mr. Thos. Barker is a gentleman whose name will probably carry great weight with it at a distance. He made a splendid fortune in this city a few years ago by selling flour to the poor at a famine-price in a time of drought and scarcity. But fortunes made in this way seldom last long, as Mr. B. has in part at least experienced already. In his humbler days he was a member of my congregation; but observing in the year 1832, that his affections had somewhat cooled (for no reason I could assign, as I never fell out with him) and hearing that he had expressed a preference for another minister, the Rev. J. M'Garvie, who had officiated for me during my absence in England, I went to him personally, and recommended him by all mean to take the man of his choice by the hand pledging myself to do my utmost to assist in getting up a Church for him at the other end of the town, where I thought it was needed at the time. It is quite a matter of course in my past experience that such a good deed, which very few in my circumstances would have done should be repaid with ingratitude by the in dividual to whom it was done; but Mr. B. took my advice on the occasion, and attached himself to the man of his choice till he thought fit to quarrel with him, which I am sure he can never say he did with me. a year or two ago. Since that time he has been making as many revolutions in the religious world as the vanes of his own windmill-being a State Church Presbyterian to-day, an Episcopalian to-morrow, an Independent the third day, and a Voluntary Presbyterian the fourth. when people contract these locomotive habits in Church-going, there is no saying where they will stop when they once begin their travelslike the unfortunate Mynheer Van Damm of Rotterdam, who had a cork leg made for him by a famous mechanist of that city, which went by clockwork, with such nicety and self decision, moreover, that Mynheer actually preferred it at first to the other. But the mechanis, having unfortunately neglected to provide means to "stop her," the cork leg continued to march on when its companion had grown tired, and carried the entire Dutchman along with i, whether he would or no, to the astonishment of all Holland, which he soon left far behind him; insomuch that he is marching yet, as the story goes, but where or whither nobody can tell.

As for Mr. Gilchrist, one of the other three principals in this manceuvre, it so happens that he is also one of the principal parties concerned in getting up the Bank of Australia Lottery Bill, a measure which I have no hesi. tation in saying, has gambling and swindling writ large" upon its forehead, and which seeks to procure the sanction of law in Aus. tralia for practices that have long since been proscribed and reprobated by all classes of politicians in England. But the Church scheme may perhaps sanctify the Lottery scheme, and both may float together.

In coming here, however, Mr. Mowbiav has a better prospect than most people imagine-One of the eight ministers who voted for mydepo sition has recently got himself into an awkward scrape, which, although his brethren here are endeavouring to hush it up, is likely to end in a vacancy soon; in which event Mr. M. may probably have a suitable retreat provided for him in the Middle District after all, with a better Government salary than he is likely to get at Port Phillip. The ease I allude to is no secret here now. It has got into the records of the police office of the district, and has been publicly talked of in various quarters in Sydney; the only excuse that is made for the reverend gentleman's very exceptionable procedure being, that he was d-But the men who pretended to depose and degrade me, merely for renouncing my Government salary,

#### FREE CHURCH.

ADDRESS OF THE REV. MR. MONOD, OF PARIS, TO THE ASSEMBLY OF THE FREE CHURCH OF SCOTLAND.

(From the Edinburgh Witness, May 39.)

Monday, May 27. WALDENSES.

(Continued from our last publication.) " A minister of the gospel, Tthe agent of our society, placed in an entircly different part of France, communicates to us as follows :- ' I have the pleasure to inform you, that I have preached on the 9th of this month at J in the ancient convent of the Annonciade, in presence of thirty Protestants, twenty-five Israelites, and more than 200 Roman Catholics. The Mayor whom I saw, in order to forewarn him of my design, made me perfectly welcome, saying to me that the charter ought to be a truth for religious liberty as well as for every. thing else. All those who assisted at my preaching, expressed the desire to hear me ugain, and to see evangelical religion established amongst them. In the same district, -, thirty-four families at R \_\_\_\_\_, and B asked me carnestly for regular instruction, When I visited these two communes, I had every evening more than sixty auditors, not withstanding that the place and hour of the meetings changed each time; but they followed on my track -so desirous were they to lose ino opportunity of hearing me.' Since this letter, our friend has addressed to us several others, which prove that the interest in evangelical truth spreads from locality to locality. Thus, for example, in the three places where our friends first went, they now reckon 500 persons firmly decided to embrace religion such as it is taught in the Bible. Several of them speak of making sacrifices for the building of a church; at their head is a Roman Catholic family, who offered to give 500 francs towards that end. There, as in many other neighbouring places, the Holy Scriptures are bought and read, and the singing of the praises of God in a language which they comprehend attracts and wins their hearts. A lady who played the organ professionally in the parish church of one of these small towns, distinguishes herself above all for the zeal with which she seeks to evangelize all who surround her, exercising them in the singing of our finest

"On the morning of Sunday the 31st of March, the Abbe arrived with two children. belonging to the choir, and followed by a horse carrying all that was necessary for celebrating mass in the open air; for notwithstanding all his solicitations, he had not been able to succeed in having a barn for the performance of that ceremony. He established himself then under a walnut tree, upon a piece of sward adjoining a large barn, lent and prepared by the inhabitants for the preaching of M. Roussel. Now, as the hour of the mass nearly coincided with that appointed for the evangelical worship, the sward was covered with people, who, without appearing to remark what passed beside them, conducted themtelves so as not to disturb the Abbe in the exercise of his functions. Then the door of the place of worship being opened, every one took his place without hurry, but with the greatest order. Then M. Roussel commenced the service in presence of 400 persons, i. e., the whole of the community, for not a single inhabitant, no, not one, remained at home. now copy the letter of our friend, from which o have drawn the preceding details :

" I wished, dear brother,' writes M. Rous-...l, to give you a succinct and almost cold sarrative of what passed yesterday; but if I and describe it to you such as I felt it. I rould say it is one of the sweetest days of my life. There was an admirable assemblage during service, and long, peaceable, happy conversations afterwards on all that passed. I do not hesitate to say, that the Spirit of God hovered over the village. In visiting the hamlets in the afternoon to see my auditors of the morning again, I found everywhere the frankest expressions of cordiality and happiness. A peasant said to me, ' See, before you came, our eyes were like that (putting his hand before his eyes), and now we see as down there! and clear as there!' with his finger be pointed to the horizon where the sun was setting, kindling the clouds into flames '"

In another place, continued M. Monod, 600 persons have turned from Popery to the gospel. There, the neighbouring priest came one morning, the 31st March last, carrying the nost and all implements necessary to say mass. He could not obtain a place in the whole village wherein to put up the host, and at last he was obliged to establish himself under a tree in an orchard. Not one man in the village turned out to hear him say mass, while 400 of them were collected about Mons. - . There is another document, a very short, but, as I think, a very remarkable one, showing the nature and reality of the movement of which I speak. Among a number of petitions addressed to the Chamber of Deputies, was this one, signed by 100 Roman Catholics : -

We, the undersigned, proprietors and inhabitants of the Corporation of St. Laurent, and of Cannes, district of Grasse, department of Ver, all members of the Roman Catholic Church, have the honour to represent to the deputies,

ist. That we entertain somewhat more than doubts regarding the religion which the priests teach us, being fully convinced that they have inculcated on our fathers, under pain of being dehvered over to the secular courts, dogmas contrary to, and not ordained by, the Word of

" 2d. That we desire, with our whole souls, to recover our religion such as Jesus Christ has instituted it, such as the Apostles have taught it; and to that end we desire to unite ourselves to the Reformed Church called Pro testant,

" But considering that we cannot unite our selves thereto in worship without seeing the municipal authorities, urged on by the priests, unceasingly menace us, by raising a verbal process against us, and bringing us under the article 294 of the penal code.

" We come, in consequence, humbly and respectfully to solicit our nonourable Deputies to determine whether the Article V. of the Charter has the force of law within our dear country, or at least to give it an interpretation which will put an end to the tyranny which

weighs us down." This shows the nature and reality of this movement, and I think it will be of interest to you all, for France is the stronghold of Popery. If Popery were overthrown in France, ah ! how soon would it disappear in other conntries, where it seems to reign more undisturbed But, sir, what we have to do, that we must do quickly. W: know not how long we may be permitted to carry on the good work, Rome is always Rome. Wherever she has the power, she has always the will to persecute. Do you not see this in the late news from New Zea. land, and all places where her power can reign unmolested? I may apply to her yet the words of Holy Writ: she is always " the mother of harlots," and "drunken with the blood of the saints." I expect persecution to happen in France-violent obstacles against our carrying on of the work of mercy; for a day will come when the cry shall be heard, " Babylon the great is fallea, is fallen!" If we would do our duty, then, we must do much. I ask my Christian brethren in Scotland whether they will join with the holders of their faith in France against their common enemy-infidelity and superstition? (Loud applause.) I know you have much to do at home; but I know also, that love never faileth-that love knows no limits-that leve can work wonders. 1 know that our blessed Lord Jesus Christ, though he was rich, yet for our sakes He became poor, that we through his poverty might be rich." I know that " if there be first a willing mind, it is accepted according to that a man hath, and not according to that he hath I know how that God " bestowed grace" on the Churches of Macedonia-how that in a great trial of affliction, the abund-

ance of their joy and their deep poverty

abounded unto the riches of their liberality;" and I know that God can bestow the san grace on the Church of Scotland - that he " is able to make all grace abound toward you; that ye, always having all sufficiency in all things, may abound in every good work." This, Moderator, gives me faith and courage not to ask the £2000 that Mr Macdonald has obtained over and above £50,000-(laughter)but that you will merely allow me, following Mr Macdonald's example, to present to you v very easy and short calculation. (Cheers and laughter.) You have 700 churches in Scotland. Well, suppose we were to get £1 a year from each-(renewed laughter and cheers.) Oh! I must put it in another way. I am told that the members of the Free Church are nearly a million -am I mistaken? (No, no.) Well, a million of members giving us each only a halfpenny a year, would give us £2,000. (Loud cheers.) Yes, a million of halt-pennies would make more than £2,000, and that is far beyond anything we seek or expect; though, if wo could get them, I can tell you they would be well employed. (A laugh.) But, n y brethren, if you have no money to spare us, I have to ask you for something far better than your money-(hear) -something that will help our work more than money can; for money with-God's blessing can do much in everything without money. We ask you for your prayers, for your brotherly affection and sympathy and if my visit to your country should have no other effect than the connecting of Christians in Scotland with those in France, by means of prayer and love, I should for ever bless God that I came here. (Hear) I will have much to say when I return to my people and my own church, of what I have seen, heard, and experienced among you. Oh, how I wish that all those who do not understand, or who do not approve of the position you have been compelled to assume, had been present, as it was my privilege to be here, on Friday last Ah ! they would have seen, they would have heard, they would have felt, that the Spirit of God-the Spirit of our Great God, in his son Jesus Christ-is with this Church-(hear)that this is not the work of man-that the whole will turn out to be the work of God in deed, and that nothing can overturn it. You have shown, sir, all faith and faithfulness, and will yet triumph through the power of Him who manifests His strength in our weakness over presently insurmountable difficulties and obstacles. The mountain has been overturned and cast into the sea. Blessed be God, who has given you grace to go forward, and no. fear to take up at once the whole of your work It strikes me much-it gives me great confi dence in your ultimate success-that your Church has taken up the whole work-the enetenation of ministers - the building of churches, of schools, of a coilege-the necessities of the poor-missions abroad and at home ; and now this evening, I hope, you will take up the Continent. You have left nothing be hind; and how has the Lord blessed you all ready, and how will be not yet bless you causing you to go on through faith in him ! must thank this venerable Assembly for the resolution that it passed a few days ago to open its pulpits, and even the Church, to the other faithful ministers of our Lord Jesus Christ. This is a great step to Christian union, of which we talked this morning, and the Lord will bless you for it. It has been my privilege to preach twice in the pulpits of the Free Church since I arrived on these shores . and I have received a testimony of love from my brethren that sunk into my heart, and called forth my warmest gratitude. Take courage, my dear Christian friends; go on in the Lord-go on with faithfulness to your selves, and charity towards those who do not go along with you; so long as your Church shall possess that faith so warmly expressed by Mr M'Donald, and so warmly responded to by the whole Assembly -so long as you have that faith, fear not, fear not. Here is a new era in the history of our blessed and glorious information. God hath indeed worked miracles among you, and put His seal to your joy. May He endow all the ministers and members of this Church-may He enrich you all abundantly with His spirit, and strength, and wis dom; and may you avoid the manifold soares that beset you! May He direct, by His spire! the steps of every one of you in the way wherein He calls you to go for the glory of His

holy name, the advancement of His kingdom,

and the salvation of many souls. M. Monod then sat down amidst cordial applanse.

Dr CANDLISH said, notwithstanding the importance of the subject, he would not take up the time of the Assembly by any remarks, but would simply content himself with reading the following re-olution :-

" The General Assembly having considered the overtures, and having also heard the Rev. Monod of Paris, on the su' ject of the religious state of France, as well as of the Continent in general, resolve-

" That this Assembly express the high gratification which they have received from the presence of M. Monod among them; and, from his interesting statements, desire to welcome him as an esteemed brother in the Lord; and to hid him heartily God speed; and request their Moderator to return to M. Monod the thanks of this house. Farther,

" That the Assembly recognise the duty incombent upon this Church, to take a more lively interest than she has hitherto done in the state and condition of Christian Churches on the Continent, and in the east.

" That, with a view to the cultivation of a closer intercourse and fellowship with the Churches and the people of Christ in these parts of the world-for the purpose, also, of sympathising with them, and, as far as possible, aiding and supporting them in the trials and persecutions to which they are exposed at the hands of the Papal power and of civil tyranny: and farther, that an opportunity may be afforded to the members of this Church to contribute of their means, as God has prospered them, to the means employed for the promotion of evangelical truth -a Committee be appointed, with instructions to open a correspondence with the Churches above referred to-to receive and administer whatever funds may be entrusted to their care-and to take occasion, as they see fit, to solicit the interpoposition of the Government of this Christian and Protestant country in defence of the liberties and lives of those who suffer for conscience' sake -Convener, Mr Lorimer, of Glasgow."

He would have, as he said at the outsets simply contented himself with reading the resolution, but a very small slip of paper had been put into his hands while he was doing so, that he considered ought to be read to the Assembly. It was as follows : -" What would you think of putting the plate at the door to. night for Mons. Monod?" (Loud cheers and laughter.) In reference to this document, ha merely acted as the vehicle of communication He would only remind the Assembly, that whatever was put into the place would not be for Mons. Monod, but for the great cause he had that night pleaded, in a way that some of them would not speedily forget. Whatever was to be done with this communication, he would leave for the Assembly to determine, but he had done his duty in communicating this interesting document to the Assembly,

The Moderator being being then called on to convey to M. Monad an expression of the feelings of the Assembly, addressing him, said, -1: is with great pleasure I assure you of the high gratification the Assembly has had in your presence among us, and in the important intelligence you have communicated. Frotestant Church of France, of which you are the representative, engages our deep concern and regard. The student of history can never forget the distinguished position held by Christ's servants in that country in the period immediately following the Reformation in Germany-the admirable specimens of indi. vidual character found among them - the honourable and faithful testimony borne to the truth-and, at a later period, the nobly array of martyrs, whose blood was poured out like water in France, and the myriads of confessors who chose to suffer affliction, to surrender their home, their country, their worldly all, rather than violate their conscience and deny the faith; of whom some found an asylum in this city, and have left their memory still retained by the localities given them to inhabit. We wonder not that, when France had been bereaved of these, the best and worthiest of her sons, religion pined away, and was lost in almost universal idolatry and supersition; while the feeble and often unfaithful Protest ants that remained in the inauspicious soil soon fell from the principles of their fathers, and sank into worldliness and scepticism. It refreshes us to learn from you, that a revival

has been granted-that among your four or five hundred pastors, a goodly number, approaching to one half, are faithful preachers of the gospet-and that the cause of truth seems advancing in many ways. I congratulate you on the share you yourself, and the members of your family, have had in this good work. You have secured a place in our memory and in our prayers; and I trust the appeal you have made in behalf of the Society you advocate, will not be without good fruit among us, and that the precious seed sown by that Society will yield abundant increase unto eternal life.

#### THE MISSIONARY SHIP "JOHN WIL-LIAMS."

(From the Hobart Town Co.rier.)

Turs beautiful vessel, which arrived here last week, belongs to the London Missionary Society, which was formed last century for evangelizing the heathen. The founders of this noble institution desired to unite christians of all denominations in the good work; they declared that names, sects, and parties should have no place in the society, and that their only aim would be to promote the temporal and eternal welfare of their fellow creatures. How ever, Wesleyans, Church of England men, and Bantists soon concentrated their efforts for similar ends in societies connected with their own peculiar views, and thus the Independents mainly are left to carry on the operations of the institution in question-however, the catholic spirit of the society is still preserved, and all are invited to unite in the good work, though almost none but independent missionaries have offered themselves, or have gone forth from its to spread the knowledge of Christ among the heathen. The first object sought by the society was the conversion of the South Sea society was the conversion oi the South Sea Islanders, and accordingly a vessel called the Duff, sailed in August, 1796, with twenty-nine missionaries for Tahiti, which they reached in March of the following year. After many years of self denying labours the missionaries succeeded, by the grace of God, to reclaim the inhabitants from Luorance and supersition to the knowledge and practice of the chustian religion. A well regulated monarchial government was stablished, and a British consul ment was (stablished, and a British consul appointed by our government to reside on the is ands. Great Britian had been the means of is ands. Great Britian had been the means of bringing about this happy state of things, but she claimed no dominion over the little state, but rejoiced to see it advance in civilization and prosperity. However, lately, some French Roman Catholic priests arrived on the island with a view to introduce their errors. Queen Pomare exercised her undoubted right, and ordered them to leave the island. This gave offence to France, who sent a man-of-art there; intimidated the Queen; and after levying contributions forced her to sign a treaty, by there; intimidated the Queen; and after levying contributions forced her to sign a treaty, by
which a Freuch protectorate was set up in her
dominions. After having suffered many indignities from her possessors, the Queen has
left the island, and the natures have risen
against them, and war and bloodshed has
filled this once happy and prosperous island.

Tabiti, and the state of this interestic g station

The above mentioned ship Duf' was captured by the French in 1799, and in 1838 the society purchased the Canden, which, after having been employed for five years, was succeeded by the brautiful vessel now in our harbour bearing the name of the christian maryir John~Williams. Her measurement is 296 tons; she is 103 feet long: 24 feet and 8 nuches broad; has 10 state rooms; and cost £6,300, which sum was mainly raised by the efforts and contributions of the independent Sabbath school children. She sailed from London on the 5th, and from Deal on the 17th June, with the Rev. Messis. PUBLIC SALES OF COLONIAL WOOL. WE feel much satisfaction in being enabled to give a favourable report of the first series of Colonial wool of the present season, which terminated yesterday. The quantity offered consisted of 2,568 bales Australian, 1,900 bales Van Die-men's I,and, 2,491 bales Port Phillip, 1,774 bales South Australian, 243 bales Swan River, 1585 bales Cape of Good Hope and St. Helena, 251 East Indian; total, 10,512 bales. The wool was generally sound in staple, remarkably free from burr seed, and in fair condition. The sales were fully attended, and went off with great spirit at an advance on former The finest combing wools were rates. not quite so much in request as on many previous occasions, arising from a slight flatter ourselves that the result of these sales will prove satisfactory both to the growers and importers of the article. The wools from Port Phillip and South Australia were better got up than in former years, and the prices obtained, we hope will offer encouragement to further improvement. Cape wool sold at former prices : the condition, &c., of some flucks from this colony were much approved. We discovered no alteration in the prices of East Indian Wool.

"Ye a will be pleased also to announce that he further recommends that, in the prayer in-" Deer Park, June 4, 1814.

"Ye will be pleased also to announce that he further recommends that, in the prayer invariably said before mass, after the words, 'For the Queen and all that are in high stations, that we may lead a quiet and holy life,' the following words, be immediately introduced, 'For O'Connel, the father of his country, that, being delivered from all dangers, he may, with renewed energy, both of mind and body,

### THE DRAPERS' ASSISTANTS' MEETING.

A numerous meeting of the Drawers' Assistants of Sydney was held in the School of Arts on the evening of Tuesday last, Acton Sillitoe, Esq., in the chair, to devise ways and means of inducing their employers to abridge the hours of labour in that branch of business-to shut up in winter at six and in summer at seven. And surely there can be nothing so reasonable as this. It is selfish and inhuman to refuse it, and argues a determination to sacrifice both the bodily and the mental health of the young men to the god mam-mon. To confine a young man behind a counter from seven in the morning till nine at night in this exceedingly warm clunate is in the highest degree unfeeling and cruel. In many constitutions it must inevitably generate disease and lead to premature dissolution. Neither is it less de-structive to the health of the mind than to that of the body; for where is there a young man whose physical constitution could enable him to do anything in the way of intellectual exertion after fourteen hours' confinement to a haberdashery shop? The thing is out of the question; and we would therefore earnestly entreat masters generally in this branch of business to have some consideration for their employés, and not to chain them perpetually like galley slaves, to the oar. But if considerations of justice and humanity have no weight with some masters in this business, elt them look to self interest; for as it is universally admitted that there is just as much labour performed by and for society with, as there would be without, the Christian Sabbath, so it is equally demonstrable that as much labour will be performed by young men, and as much money made by their men, and as much money made by their masters by shutting at six or seven as by keeping open shop till nine. We understand that all the Drapers in Sydney but three or four have agreed to abridge the hours of labour in the way solicited. Now we are decidedly of opinion that the public ought to interfere in the matter by taking a note of these selfish and unfeeling musters and refusing to go to their shops. This would bring them to their senses very soon.

REPORT OF THE COMMITTEE OF THE ASSIST-ANT DRAPERS, Oct. 29, 1844.

Gentlemen,-Your Committee, in presenting this Report, respectfully inform you that they have met for the discharge of the duties en-

trusted to them, on six occasions.

That at their first Committee Meeting, a Memorial was crown up, and subsequently engrossed upon parchiment, of which the fol lowing is a copy :-

Gentlemen,-We, the undersigned Assistant

Orniemen, we, the undersigned Assistant Drapers, respectfully memorialize you upon the subject of closing your several houses of business at an earlier hour than at pressort. While your Memorialists take a deep interest in the welfare of their various employers, they cannot help feeling how much it would benefit has the meals and result benefit her themselvent and result here. benefit both themselves and you, if business ceased at Seven o'clock during the Summer months, and at Six o'clock during the Winter months.

Your Memorialists are aware, that many of Your Memorialists are aware, that many of their employers wish to close at an earlier hour, and are fully convinced that the same amount of business, with the same profit and with less expense, can be transacted as during the present late hours; and, at the same time, that much moral, physical, and intellectual advantage would be reaped by your Memorialists; that employers will be for a time released from the barass of histogram. from the harrays of business; and the assistants be better fitted for the duties of the following

Your Memorialis's, while they request it as

be better fitted for the duties of the following cay.

Your Memorialists, while they request it as a boon to themselves, are thoroughly satisfied that their employers will be equally benefitted. The prayer of your Memorialists therefore is, that you will unanimously agree to close your establishments at seven o'clock during the Summer months, commencing on the 1st September, and at six o'clock during the Winter months, commencing on the 1st March, Saturday@vienings exerpted.

a Your Memorialists as in duty bound will ever pray, &c., &c., &c., &c.

This Memorial was signed by the Assistant Drapers, eighty seven in number.

A Deputation was then appointed to wait upon the various Proprietors, requesting their signatures to a document, agreeit g to close their respective houses of business at 7 o'clock during the Winter months, and at 6 o'clock during the Winter months, and at 6 o'clock during the prayer of the Memorial addressed to us by the assistant drapers, to close our respective houses of business at 7 o'clock during the Summer months, commencing on the first day of Marich.

The present profits will not allow of this additional expense, and therefore in the event of my adopting the plan proposed, I should be obliged to reduce the salaries of the parties now in my employment.

Secondly—Because the greater part of the trade have cut down the profits of the busin ness to their present small annour, by exposing goods in the streets from first floor windows, by the injurious practice of ticketing, and by other underhand systems, and have thus deprived me (for the reasons stated in my first objection) of the power of complying with year request, I will, however, add, that should

the trade be willing to bind themselves to conduct turiness in an homograble and fair manner, I believe a living profit might be obtained upon a smaller return, and I should then be quite willing to sign an agreement to close my shop at six o'clock corer croing.

The Report of the Provisional Committee

The Report of the Provisional Committee having been read and amended, it was ununimously adopted, as follows:

The Provisional Committee appointed at the Meeting of the General Education Committee of the 19th Instant, to draw up Rules for the government of the Society, which it was then agreed to form, having met accordingly and taken the subject into consideration, hereby recommend the following rules for the adoption of the General Committee:

1st. That it is expedient and necessary that a Society be formed, to be designated the "National School Society, for the City of Sydney and County of Cumberland."

2nd. That the object of this Society shall be to use its best exertions to carry out the views of the Legislative Council, on the 10th instant, recommending Lord Stanley's system of National Education in this Colony by establishing and supporting Schools on the National System, within the City of Sydney and County of Cumber and, wherever such schools are urgently required, and sufficient funds can be raised in addition to grants from the Boad of Education for their establishment and sapport.

3rd. That an Annual Subscription of One

and support. d. That an Annual Subscription of One Pound sterling, payable either in advance or by quarterly instalments, shall entitle the subscriber to the rights and privileges of Membership in the said Society.

th. That a General Meeting of the Society shall be held annually, early in the month of January in rech year, at such time and place as may be fixed on by the Committee of Management, for the election of office-bearers, and for such other business as may come before it.

That a Special General Meeting of the in That a Special General Meeting of the Society may be held at any time on any occasion of conergency, on the requisition of at least ten Members addressed to the Secretary; ten days notice of such meeting being previously given through the Colonial Press.

6th. That the business of the said Society the That the business of the said Society shall be transacted by a Committee of fiftern Members (exclusive of a Transacra and Secretary, who shall be Members ex officis, of which Committee five shall be a quorum; the said Committee and officers to be elected at the Annual General Meeting of the Society, and to submit to the next Annual Meeting a detailed Report of their proceedings, including a statement of the Transacra's Accounts duly audited, during the previous year.

th. That also members of Committee shall rettre annually, by rotation, together with the Treasurer and Secretary, all of whom shall be eligible for re election.

the annually, by rotation, together with the Treasurer and Secretary, all of whom shall be eligible force election.

8. That it shall be the duty of the Treasurer to receive and keep an account of all funds accruing to the Society, to deposit the same in the Bank of Australesia, and to give cheques, signed by himself and the Chairman of Committee, payable from such funds, for all disbursements previously sanctioned by a vote of the Committee.

9th. That it shall be the duty of the Secretary to keep a record of the proceeding, and to conduct the correspondence of the Committee, to issue notices of all meetings and otherwise to be under the direction of the sommittee in all matters relating to the business of the Society.

10th. That the Committee shall meet for the transaction of business, on the first Wedns day of every month, or oftener if necessary 11th. That any person contributing not less than £25 (twenty five pounds) sterling, either in advance or by regular misulaments, within three years, towards the funds of the Society, shall be a Life Member, and have the privilege of attending and voting at all Meetings of Committee.

2th. That none of these rules shall be altered or amended, unless by a resolution passed at one General Meeting of the Society, and confirmed at another General Meeting called for that purpose.

ROME AND HER ABOMINATIONS. We hear in all directions that Rome is no longer a persecuting Church. Rome persecute! Our maligned sister! You may attribute what she is apparently justly accused of in past times to the darkness of the age, but not assuredly to her Catholic principles and primitive discipline.

How far this is a correct exhibition of the matter our readers at large know full well. But as an exhibition of what the Church of Rome is now, whatever she was in the day of St. Bartholomew, we give entire the following letter from Dr. Kalley, dated Madeira, the 4th instant, and addressed to a highly respectable friend here. Our readers are aware that Dr. Kalley has been released from the persecuting grasp of Popery, not from its tender mercy, but by means of the effective interposition of the British Government. How parties, not so defended, are dealt with, who make any departure from the integrity of the Popish dogmas, the following letter will significantly declare. Dr. Kalley says :-

"My Dear Sir,-Although very hurried I cannot allow the steamer to go without communicating to you the state of matters here:

"Last Sabbath two persons when going home from my house, were taken prisoners and committed to gaol, where they now lie, for not kneeling to the Host as it passed. On Monday a third was imprisoned on the same charge. On Wednesday several were maule with sticks and some taken by the hands and feet as in procession, and carried into the church, and made to kneel before the images, On the 21 of May, a girl brought me some leaves of the New Testament telling me, with tears, that her own father had taken two and beat them with a great stick, and then burnt them. On the same day, Maria Joaquina, wife of Manuel Alves, who had been in prison nearly a year, was condemned to death. The counts against her were, that she denied the doctrine of the trinity and the virginity of Mary, and maintained that the sacramental bread is bread, and that images should not be venerated. A gentleman who was present during the whole trial, assured me that respecting the trinity and the virginity there was no proof adduced. Respecting the sacrament, only one witness swore that he heard her say that the Host is bread. And respect ing the images, all declared that she did not say they should not be venerated, but that she did say that the Holy Scripture forbids the adoration of them. My informant was astonished that the country people should have known the difference, and given so clear evidence before a prosecutor, who put leading questions and tried to confound them. It will hardly be credited in our fatherland that such a sentence could have been given in this century, but the mother of seven children, the youngest of whom was at the breast when the other was cast into prison, is now a prisoner in the gaol of Funchai, condemned to be hanged, for having said that images should not be adored. And under such circumstances she is forbidd: n the use of the Holy Scriptures or any part of them. It is as likely that she will be actually executed, as it was that she should be condemned to death. We suppose it impossible to perpetrate such an act. also supposed it impossible that such a sentence should have been given in any part of Christian Europe in 1844.

"Yesterday a young man, a father of two or three little children, came to speak about the rage of the enemics of truth in his parish and the danger in which he found himself. On the way home, a large company, among them, as ringleaders, the nephews of a priest, belaboured him. He went on quietly, that is without answering or striking, but as fast as he could to be free of them. He is to-day in bed, all black and blue, and his brother had to flee for safety. What is done to those who perpetrate such things? Nothing. Not one is taken up for them-they are said to be encouraged. I understand that the object is to make it appear that I am exciting a commotion, but I always urge those who hear me, to follow the command of Christ, ' Love your enemies,' and that they resist not evil, but remember that they are sheep, and that their safety consists in keeping close to the Shepherd Jesus, and calling on and committing themselves to him.

"' SENTENCE.

"'In view of the answer of the jury and discussion, &c., it is proved that the accused Maria Joaquina, perhaps forgetful of the holy religion which she received in her first years, and to which she still belongs, has maintained conversations and arguments condemned by the Church, maintaining that veneration should not be given to images, denying the real existence of Jesus Christ in the sacred Host-the mystery of the most holy trinity, blasphemy against the most hely Virgin, Mother of God, and advancing other expressions against the doctrines received and followed by the Catholic Apostolic Roman Church, expounding those condemned doctrines to different persons, thus committing the crime of heresy and blasphemy punished by the laws of the kingdom; and although it be affirmed that nobody can be prosecuted for motives of religion, as a principle truly constitutional, it is necessary that the religion of the State be respected, and public morals be not perverted by words or acts that are condemned. as is expressly established in the fundamental law of the State, Art. 145, § 4 Which the accused, in truth, did not do; on the contrary, blaspheming against God and his saints, she gave over respecting the religion of the State to which she belongs, seeking to associate to her party those who nourished principles different to hers. This accusation cannot be eluded by the defence to which she had recourse, because it consists only in sustaining the illegality of the action and the incompetency of the Court to condemn in the penalties decreed by the ordinanca, book 5th, title 1st It appears that it belongs only to the tribunal ab quem, to decide a question on all accounts delicate. Attending, then, to the fact that the crimes of which the prisoner is accused are found proven in the form decreed by the law of 15th of Dec., 1774, and ordinanca of book

5th, title 2d, § 1, which says thus, " And if he be a peasant let him receive thirty strokes at the foot of the pillory, with a cord and proclamation, that the foresaid law of the 15th December imposes on those guilty of the crimes of heresy the penalty of death with infumy; observing, likewise, that now is abolished the said penalty of infamy and strokes, and that the greater punishment always includes the lesser, I condem the ac cused, Maria Joaquina, to suffer death, as declared in the said law, and in the costs of the process, which she shall pay with her goods. AN INDIAN TRACEDY.—Michigan, Nov. Y.—
The following Indian tragedy (says the Rockester Duily Democrat) is related to us by Mr. James Fowle, of this place. It occurred in this vicinity, all the parties being his mighbours:—In spring, Nogisqua, an Induan of the Potowotamy tribe, residing in this vicinity, having pawned his gun and a part of his clothing, from time to time, to a man named lobe. having pawned his gun and a part of his cloth-ing, from time to time, to a man named John N——, for intoxicating drink, the trader pro-posed to the Indian that if he would sell him a certain cream-coloured pony 'oelonging to his aquaw, and a present from her father (Baw-bish, and a chief of their tribe), he would give him up his gun and clothing, and let him have more strong drink, fror a time to time, butth the him up his gue and the more strong drink, from 'time to time, until the more strong drink, from 'time to time, until the price agreed upon was paid. To this Nogisqua agreed, and privately gave up the pony, which was sent of 'trither west. It appeared the property of the which was sent or; infiner west. It appeared that his squaw baxing some suspicion of what was going on, employed her younger brother to watch the result, and inform her, which it appears he did. Upon the return of the Indian to his camp, partly intoxicated, his squaw, highly erraged, accused him of selling her pony. She her am more apprayed at his in She berame more and more enraged at his in-difference about the affair, and at length de-clared she would kill him. He handed her his scalling and making his bosom bare, coolly ex-scalling kine, and drawing aside his hunting sinet, and making his bosom bare, coolly ex-claimed, "Kina pool!" (Kill away). She in-stantly plunged it to his handle in the Indian's breast, which caused his death in a few minutes. Her father, the Indian chief, being then absent some twenty or thirty miles east, a runner was despatched to inform him. Soon after, Mr. Fowle says, he saw him pass by his house with a sad countenance, for the place of the with a sad countenance, for the place of the murder. A heart-rending duty now devolved upon the old chief. His word was to acquit or condemn his agonised daughter, according to Indian usage from time immemorial. His daughter was the handsomest squaw of her tube, and a darling child; and the wails of his relatives, together with his own sympathies, rolled upon the mind of the chief like the rushings of the mighty deep upon the lone rock in the sweeping storm. He must judge. No other tribunal was within the Indian code of criminal iustice. The performance of this criminal justice. The performance of duty required more than Roman firmness. duty required more than from an irriners. Are Great Spirit, and the blood of his murdered son-in-law, seemed to say—" Bawbish, according to the customs of your forefathers for ages past, now decide justly." The chief, like agonised Joseph, when he made himself known to his bethern could contain himself no agonised Joseph, when he made himself known to his brethren, could contain himself no longer. His integrity as an Indian chief prevailed. He rolled his troubled eye for the last time upon his darling daughter, then upon his kindred, and upon a portion of his trobe that stood before him, and then to the great Spirit for firmness. The storm of agony in the mind of the chief had passed away, and in deep sorrow he decided that his daughter ought deep sorrow he decided that his daughter ought to die by the hand of the nearest kin to the murdered Indian, according to their custom for ages past. The person of the lather, chief and judge, then withdrew, with nothing but his integrity to console him, which the whole world beside could neither purchase or bribe. Upon inquiry it was decided that Jenese, a brother of Nogisqua, then south, near Fort Wayne, should execute the settence.
