REPORT OF THE PENTONVILLE COMMISSIONERS. From the Hobart Town Courier.

We have read with much attention the Second Report of the Commissioners for the Government of the Pentonville Prison, which has been presented to both Houses of Parliament. The recent arrival, by the Sir George Seymour, of a detachment of prisoners who have passed the regular course of its prescribed discipline, has extended the interest felt in this new experiment in penal science, to our own island. We shall now have an opportunity of contrasting its practical efficiency, as a penal means of reform, with the system of Probation discipline now in operation here, and to which it is, in some of its fundamental principles, so directly opposed. We shall be able to judge how far the salutary effects, apparently produced, are of a permanent character. We shall be enabled to

by a long course of penal exclusion from the world, will stand the test of restoration to the liberty and license of a social intercourse. The results will be looked for with anxiety by many here, and more especially by the high authorities in the parent land high, a knowledge of a trade, and the whose names are attached to the Re- possession of a ticket of-leave, will port, and who have taken so strong an interest in the establishment and arrangements of the prison, and in the ordinary effects of its discipline. We purpose, therefore, noticing, from time to time, these results, as they become gradually developed. In the mean ume, we shall lay before our readers such portions of the report as we believe will prove generally interesting, and comment, in our progress, on the parts and particulars that require observation, as connected with the system of Probation established in Van Diemen's Land, or as affecting the probable success of this novel experiment.

The Pentonville Establishment was opened for the reception of prisoners on the 21st December, 1842; so that its system of discipline has been in operation rather more than two years. This prison, by order of the Secretary of State, is appropriated to the reception of male convicts between the ages of 18 and 35, under sentence of transportation not exceeding 16 years. The term of probationary separation and discipline is fixed at about 18 months, at the expiration of which term the neophytes are transported to Van Diemen's Land, under their original sen tences; their position in "the penal c lony" to be dependent on their conduct while at Pentonville prison.

No mention is made in the Report of exiles." The class so denominated is an extension of the original proposition, and has evidently been created by the preessi y now felt by Lord Stanley of finding a speedier absorption and disposition of prisoners in the neighbouring colonies. This class, sent out with the single restriction on their freedom of confinement to the Australian colonies, is composed of those whose conduct has been most exemplary and commendable during their probationary term in the prison.

We pass over the portion of the Report which has reference to the state of the buildings and conduct of the officers," with the simple observation that both are satisfactory, and proceed to the " conduct, treatment, and condition of the prisoners."

On this head we shall quo e almost verbatim.

" The prisoner, on reception, is apprised of the rules relating to his conduct, and of the duties required of the officers in the trea ment of the prisoners. These rules, a copy of which is hung up in each cell, inform him that he is prohibited from communicating with any other prisoner; that he may at any time apply to see a Commissioner, the Governor, Deputy-Governor, Chaplain, or Medical Officer ; and that he may communicate any complaint which he may have to make either to them, or the officer set over him; that if he te des rous of sending a petition to the Secretary of State, or other su hority, he will be a lowed to do so; -that he is required to attend chapel, but that his attendance will, at his request, be dispensed with, if he be of a different nion from that of the Established Church, and in that case a minister of his persuasion will be allowed to visit him ;-that he may, on reception, send to his friends a letter stating his removal to the prison, and that he is at liberty afterwards to send and receive a letter, and recive a visit, at intervals of three months :- that at the request of his friends events of importance may at any time be cummunicated to him by the Governor ;-that any relation or friend may be allowed to see him at his request, if springsty ill, should the Governor and Medical Officer consider such visit unobjectionable; -that the officers are required to exercise their authority with firmness, temper, and humanity, to abstain from all irritating language, and not to strike a prisoner; but that they are not permitted to converse with any prisoner, except on subjects connected with their

" A notice is also hung up in each cell, giving to the prisoner important information relative to his destination at the expiration of the term of his imprisonment. He is apprised that although every prisoner will be sent abroad, the class in which he will be placed, and the circumstances under which he will leave the prison, will be entirely dependent on his own conduct. That for this purpose the prisoners are to be divided into three classes :- First, those who, at the expiration of their

Diemen's Land, to receive, on landing, a ticket-of-leave, which will confer most of the advantages of freedom during the remainder of their sentence ;-that labour in Van Diemen's Land being in great demand, and wages therefore onable them, with industry and good conduct, to secure a respectable position in society; that with this ticketof-leave they may, by a course of honest industry, acquire in a short time means sufficient to enable their families to follow them."

"The second class will consist of those who have conducted themselves well: that these, also, at the end of 8 months, will, on their arrival in Van Diemen's Land, receive a probationary pals which will secure to them only a portion of their earnings and will subject them to many restraints and privations."

"The third class will consist of those who have behaved ill: that such prisoners will be transported to Tasman's Peninsula, a penal colony, occupied only by convicts and the military guard; that they will be employed on

public works in probationary gangs, without wages, and deprived of liberty; and that their families, under any circumstances, will not be allowed to join them."

We pause here, in our quotations, to

remark on a serious error into which

the authors of the regulations have un

consciously fallen. The statement, made to every ind vidual prisoner, that " labour in Van Damen's Land is in great demand, and wages high," is no longer correct. It may do much, therefore, in the disappointment of hopes and expectations which every man has been encouraged, by high authority to form, to impair the ultimate

efficiency of the system. It mey, in fact, under the impression that they have been deceived or misled, destroy, in many instances, the good that long seclusion and a course of moral discipline have accomplished, and induce a fatal relapse into their former train of habit and of action. The statement is evidently founded on a former period in our brief annals, of high but onnatural prosperity, which has passed away, and has been succeeded, as is usually the case, by an almost uniwersal prostration of energy and unprecedented depreciation in the value of property. As a preessary result, the demand for labour is d'minished, and the rate of wages proportionably depressed. The operation of this inevitable consequence is still farther extended by the vast amount of labour constantly becoming available from our wn probation regulations, and which he colony, in its present position, is onable to absorb. The general effect of all this on the "Pentonville men," who were led, by authority that they never thought of questioning, to expect a very different state of things, cannot but be unfavourable in every point of vew. Instances have, in fact, already occurred where advantageous engagemen s have been lost from the exorbitant remuneration which this unfortunate statement has led them to demand; and this, be it remembered, is but one of the train of ev is that it manifestly involves. The Home Authorities, therefore, will doubtless see the desirableness, or rather the necessity, of correct ing an error so pregnant with disastrous influence on the system which they

baye, in other respects, so anxiously considered and so carefully matured; We shall continue our notice of the "report," with such observations as the subject may require.
