SPEED OF HORSES.

To the Editor of the Launceston Examiner. An opinion has been entertained the last two or three years, by many of our colonial sporting gentlemen and others connected with our northern turf, that the Tasmanian borses are but little slower than the English racers; and as your Saturday's print remarks that the last twenty years furnish but two or three instances of parrallel speed, allow me to place a few facts before you which will very materially alter this supposition.

Mr Editor, our horses in speed are far, very far behind the English nags, and many years must clapse, and more horses of tried speed and power must be landed as sires and placed in our studs, be'ore we can come up to the very extraordinary time the races are now run in

lightenment of those who think so highly of our colonial horses) the performances of our best, and their time ; and also a few transcriptions from English sporting works of the time and distances run in Englan; and you will from such comparison observe how very much we are behind their high mettled racers; and that it is not requisite to look back quite twenty years, as a few instances the last six years will be sufficient:-

RAETS RUN IN VAN DIEMEN'S LAND. 1842-Vanish, Town Plate at Launceston, 3 miles 240 yards, 4 years, weight 8st 9lbs, run in 6 min 15 sec. Ditto at Oatlands, 3 miles 6 min 2

Making thirty miles six hundred and ninety-nine yards, run in 53 minutes 52 seconds, or an average of one mile in 1 minute 46 seconds; and the average time of Inheritor, Captain Pops, and Semiserias three races, was one mile in I minute 32 seconds ! Average of Paganini's time for the Launceston Derby was one mile in 1 minute 541 seconds.

To give another splendid proof of the extraordinary speed of the English crack horses, that fine race-horse Lottery, in 1825, for the Fuzwilliam Stakes at Doncaster, in running against Figaro and Longwaist, went one and a halfmiles in two minutes fifteen seconds. Mr Gee's Egremont, last y minutes firy five secords.

You can observe that the average of the English horses given above is very much faster than any race ever yet run in this colony, and the speed of Inheritor, Captain Pops, and Semiseria, is almost unexempled in English racing.

I have had no occasion to look over the English racing annals for the last twenty years to find a parlatel to Paganini's time; I think it would be difficult to find a parallel to such slow running.

These facts are not placed before you to disparage our race horses, but to cause emulation, and with so small an amount of blood in our mares and so few tried stallion sires in the country, the running is very creditable; and when we get such fine horses in the colony from England as the Americans pur-chase, we may look to our rucers running near English time-but not till

A former letter of mine, some weeks gone, was replied to by by " Calcutta," wishing to know "where are those horse buyers to be found we have heard so much of: where are the ships to convey the horses; and where can the stock be insured? Your paper of the 4 h instant replies distinctly to "where are those horse buyers to be found? I hope we are not altogether destitute of British enterprise, and are to wait until the horses are purchased at our doors, -somewhat like the Waggones calling upon Jupiter to help him out o the mire-but we must put our own shoulders to the wheel. It is well known there are Indian officers in both colonies for the purpose of purchaing cavalry horses; and in answer to "Cal-cutta," and for the information of breeders, I insert a paragraph from a letter received a few days back per the Coringa Packet, an i dated Colcutta, Dece aber 12, 1814-" What you say about I will place before you, (for the en- export may have been true this last all the District Councils to surren-

The ship-ment of horses per Metcalf, which arrived in disgraceful condition, and at the dull season, averaged 750 rupees on sale; and that just arrived per Blundell, though mostly of a coarse breed are expected to average 800 rupees, which is far better than selling in the colony at £20 to £25, and never getting paid." So let "Calcutta," if his twelve colts are well bred, finish their education carefully, and he may depend upon finding the "ready market for them," if he looks for it.

ONE DISTRICT COUNCIL DEFUNCT. (From the Sydney Atlas.) When the charter for the district of Sydney was in course of preparation, it appeared, that, such was the anxiety of Sir George to sign, seal, and deliver it at the earliest possible moment-to delay not one instant longer than was absolutely necessary, the satisfaction which he anticipated from seeing his triumph over the wishes of the people complete-that it did not occur to him that the police district of Sydney included the city also. For the " police district of Sydney," the charter was, therefore, originally prepared and executed, and in due form delivered, with befitting grace and solemnity, to the new warden, Mr Barker. After it had been in Mr Barker's possession some time, and after several meetings had been held, in pursuance of its provisions, some member of the Council unexpectedly discovered, that, among other things, the police of the city of Sydney was placed by it under the management and control of the District Council. Doubts were entertained by some, whether the proper course would not be, for the warden and his councillors, to go at once in a body and take possession of the Town Hall, and without any ceremony, kick the Mayor and his civic brethren out of door. To settle the dispute, however, Mr Barker posted off to Government-house, with the Charter in his pocket, and, with a most deplorable countenance, as we are told, pointed out the difficulty in which the wording of that document had placed him. Sir George listened to his warden's story, and, smiling good humouredly at his anxiety, said " give me the Charter, and I'll soon set the matter to rights," and taking a pen, he inserted, as we are informed after the words "Police District of Sydney," the words except "the City of Sydney," carefully writing in the margin the well-known initials This is the history of this " G.G." curious transaction, as we have it from, what we believe to be undoubted authority, and assuming it to be true, we have no hesitation in saying that the District Council of Sydney is defunct. It was long ago decided " that when any deed is altered in a point material by the plaintiff himself, or by any stranger, without the privity of the obligee, be it by interlineation, addition, razing, or by drawing a pen through a line, or through the midst of any material word the deed thereby becomes void." -[Co. rep. XI. 27. a.] This is precisely the case in the present instance. By the Constitutional Act, the Governor was authorized by charter, to incorporate the inhabitants of such division of the colony as he should think fit, and by such charter to establish councils for such districts, but in no part of the Act is there any power given him to alter the charter once issued, or to issue a new one. The moment he executed the Sydney Charter, he was functus officii and to all intents and purposes a stranger. Nor can it be said that he did this act with the concurrence of the District Council, supposing that that concurrence would have been of any avail, which it would not; for the only corsenting party was Mr Thomas Barker-the Warden-and the consent of the body corporate could only be given by a document under its common seal. The materiality of this alteration is of course self-evident, and, under the circumstances, we are satisfied that any act now exercised by the body calling itself the Sydney District Council, will be illegal and void; that Council's rictly speaking being no longer in existence. > EXTENT OF RUNS. (From the Sydney Atlas.)

MR ATLAS .- In my last letter to you, I casually alluded to a charge against squatters respecting the monopoly of large tracts of land. I will now explain to any one requiring such information, the means by which such an evil, if general, would be removed, and by which its accidental occurrence is obviated. No such explanation can be required by those acquainted with the practical details of the present system; but it is the lot of the squatters to be denounced by those whose idea of woods is of mahogany or of an ebony ruler, and whose notions of pasture seem derived from glances at the green barley in the market-place, or a column of agricultural produce in a commercial dictionary.

If A claims a larger tract of land than he really occupies, the fact is palpable to his neighbours-B, probably A's neighbour, though possibly a searcher for new runs, seeing a part of the land claimed unoccupied, applies to the commissioner for leave to place stock there; representing that by so doing he trespassed upon no other person's run. If A is aggrieved, he complains to the commissioner, who is supposed to decide according to the merits of the case, and whose errors of partiality, if proved, are proofs of the impropriety of delegating arbitrary and irresponsible power to individuals, but are by no means the crimes of the submissive squatter, who gives way to the verdict, and "drags at each remove a lengthening chain."

It is apparent, therefore, that the wants of the landless stockholder check the desires of the recognised squatter, and effectually regulate what our opponents call " monopoly of land.

Actual occupation of land by means of stock is required to be shown to the commissioner. who is not, and could not be, guided be the mere verbal claim of one party.

If, in this manner, a squatter is guilty of monopoly, it is a monopoly of servility, for which his ancestors were never notorious, and which may not be averted from his posterity: against him are arrayed but a small body of scriveners and dignitaries; in his favour is the mass of the people here, which merely requires efficient organs in England to excite a sympathy there as universal as is the favourable feeling in the colony.

If the important question of fixity had never been mooted, the complaints of the squatters against arbitrary role or irresponsible misrule are such as may, it is to be hoped place their cause in a position which will show our friends in England the constitution of a country to which they flee whom taxes drive. The petition for fixity of tenure is not, however, the answer to the Regulations of April; though a sense of the precariousness of his position and an appreciation of the injustice in principle of these regulations no doubt led to a desire of amendment.

If a traveller (ignorant of the relation of New South Wales to England) were to come amongst us, and to see that so large a body of men as the squatters are unrepresented in the Councils of the state, though large sums of money are paid by them, his impression would be, probably, that the squatters are ill-used; -if he was then told that the Legislative Council wished to assist and govern them, but that another power denied this wish, he might be inclined to think that a hostile power too potent to be refused, was the demander of the large sums I have mentioned; if he was then told that a chief officer appointed by a gracious Queen to rule the colony at large, (colonists and squatters inclusively) in the manner most beneficial to the interests of all the inhabitants, is the demander of those funds, rejecting all intervention of any representatives of the people, he would, no members of that body, who think it doubt, think the graciousness of the on honor to be invested with the Queen checked by some sinister inpower of ruining their fellow citizens, fluence.
