The shipping interest suffer much from a very serious defect in the Law, respecting articled seaman, which was fully exchiplified on Friday last, in the case, of the barque Emerretta, the master of which vessel brought up two of his seaman for refusing to do their duty; they knocked off for two days and would do nothing but lounge about, eat, drink, and smoke, in consequence a warrant was issued for them. They had no defence to make, except, that they had been abused, which was denied.—The Bench sentenced them to forfeit four days pay each; being two days pay for each day they re-fused duty, and the costs of the proceedings. This is a very pretty punishment for seamen re-fusing duty, who by this law, if they think fit, may knock off duty at a most critical time, getmay knock oil duty at a most critical time, get-ting in cargo, preparing the ship for sca, &c. &c. when it may be utterly impossible to get other seamen to supply their places, upon forfeiting two day's pay.
