

since there was a flure up, in consequence of a man named William Kelly having imposed upon the Rev. Mr. Cartwright, one of the Surrogates for granting marriage licenses, through which he was enabled to marry a young girl named Mary Kellaher, his first wife it was alleged being Mary Kellaher, his arst when the was aneged being then alive in Ireland. He was committed to take his trial for bigamy, and convicted, but upon being brought up for judgment, the information was found to bear such a strong resemblance to a seive, that he walked through one of the loopholes and was discharged. While in gaol, his new made bride, not approving of being cut off from the joys of matrimony in such quick time, again took unto herself a husband being married by the Catholic Clergy. Kelly having obtained his liberation, intends to proceed in the course of a day or two at the Police Office, against his late wife for bigamy. There must have been gross negligence somewhere, or the second marriage of the girl would not so easily have been celebrated.

On Wednesday His Excellency the Governor, accompanied by Colonel Wilson, took a survey of Sydney upon horseback.

On Thursday a full Bench of Magistrates con sented to the business of the Bush Tavern, Par-ramatta Road, formerly kept by Robert Maddox, being carried on by John Lander, said Maddox having given his consent in writing to a transfer of the license next transfer day. This applica-tion was made by Mr. J. T. Hughes, as trustee for the estate of Maddox.

One of the "Randan" mob, as they have clasieally christened themselves, was brought be-fore the police on Thursday, charged with indecency in the streets the previous night, at half past eleven o'clock; but as the charley was un-supported, and the case perhaps not being altogether clear, he was lucky enough to escape. In the rear of the accused we observed a couple belonging to the same "moh," speculating upon the fate of their leader, for it was no less a personage who stood charged. We just wish these scamps to be informed, that if their nightly distorbance of the inhabitants is continued, we shall consider ourselves bound to give a list of the mob to the public, then many who think these kind of proceedings are being carried on sing and in security, will be somewhat asto-nished at their percadiloes meeting the gaze of the public. To such a height have their sauces been carried in Elizabeth street, that we feel convinced the constables wink at these pro-ceedings, instead of locking up the midnight Let them beware, a repetition of their proceedings may by them be severely felt.

The Police Office will soon become astounding in the article of warrants, which are apparently issued in the most reckless manner. It one man looks awry at another, he has only to state the case to the bench, and " issue a warrant," is the cry. A person supposes himself to have been robbed; he names the supposition, and the party he supposes, to the Bench, and " issue a warrant" again resounds through the Court. And so common has this become, that two out of every five warrants have been dis missed for want of a shadow of exidence against the barty charged. And all this ations for want of proper enquiry in the first instance.

MILITARY AND CIVILIANS.—That the military are a very necessary adjunct to this Colony is unquestionable, but the squabbles that continually arise between them and the townspeople is disreputable to both parties. If the Com mander in Chief, or Commanding Officer, were to take into consideration the necessity of an amicable understanding between the parties they would soon find a remedy for allaying the mutual ill feeling existing between the military and the lower orders. It would be no encroachment whatever upon the privileges of the mili-tary if the Barrack Gates were to be closed at sundown, and no egress allowed after that period, for it is under the shades of night that the evil passions of man's heart appear most fiercely to burn. This remedy would be effectual. The following case, a solitary instance out of scores that have occurred during the last six months will clucidate our meaning: - William M'Laugh lin, coachmaker of Pitt street, and Essey his wife, were brought up on warrant before the Police on Wednesday, charged with the follow-Police on Wednesday, charged with the following outrageous assault upon the person of Edward Johnstone, a private in Her Majesty's 50th Regiment, who stated that on Monday night he was standing near to M'Laughlin's premises, who came up to hun, struck him a blow upon the back of his head, and knocked him down. M'Laughlin drew his (the soldier's) bayonet, and made a thrust at him, and struck him repeatedly soveral times; the soldier soized the repeatedly several times; the soldier seized the bayonet by the middle, while M'Laughlin held it at both ends and called aloud for assistance. Mrs. M'Laughlin then came up, pulled off the soldier's cap, and scratched his face and repeat edly struck him. A constable, D No. 3, hearing the uprour, peeped out from his domicile, and after reconnotering the field of action for at least five minutes, during which one of the men might have met his death, and for which neglect he is to be discharged if justice is done him—seeing the coast clear went up to the parties, and obtaining possession of the bayonet he separated them. Several persons confirmed the statement of the soldier, as to the extent and unprovokedness of the assault. Two witnesses on behalf of M'Laughlin stated that when they came up M'Laughlin was on the ground, and the soldier with his foot upon him. The Bench gave no heed to their statement, op-

posed as it was to the overpowering testimony on the other side, and sentenced M'Laughlin and wife, to pay each a fine of £5 and costs." Walking in a devil may care kind of manner through the streets of Sydney, on Tuesday, our olfactories were tittilated with a most savory per fume; 'twas grateful to the nostrils; we thought at first the house we were passing, had given an invite to a numerous party, and that the curling steam from the kitchen was but the fore runner of the feast. The second, third, fourth, in fact the whole row we strided before sent forth similar exhalations; we had not heard of a general feast and became still more mystified. Rounding an angle, a couple of aged dames were at our elbow, bemoaning a sudden advance in eggs and milk; we pondered upon this, and thought of the mutability of all sublunary things; said eggs and milk having been as usual the day before. We still walked on, and were still greeted with that rich odour,

"Coming o're our nose like the sweet South Breathing on a dish of turtle, Levein's 500 pounder— Cooling - And giving odours."

We went home in despair, obliged to acknowledge that we for once were baffled; unable to discover the component parts of an essence, etherial, divine. Twas a libel upon our astuteness. We arrived at home in despair, at the acknowledgement we were obliged to make of our ignorance in this matter; flung ourself upon our sofa in a thoughtful delerium, and buried our face in the squab for fear of the annoyance we suffered, being too strongly marked in the lincaments of our countenance. Rat, tat tat, sounded at the door; "come in," in a very piano voice, was our reply, (enter landlady.) "The dinner is ready sir, and the pancakes done to a toss," "Pancakes!" we screetched leaping from our place of repose, and obtaining our perpendicular, a flash of irradiated intel-We flow to our Almanack, plucked it from its nook, and discovered to our awakening senses, that the day was described in red heiroglyphics denoting a holiday, and that day above all others, Shrove Tuesday. The bubble had burst, and we felt quite relieved at the weight taken from our mind, and consoled at remem bering that a far more ridiculous subject than a pancake had many a time, and oft called the in-

We must not, however, omit to mention Mrs. Clarke's songs, "The brook is purling on its way," and "My Father Land," which were warbled in very superior style and were duly appreciated by the audience. The little Sylph, Lazar, then executed the medley dance in that ariel style which is so attractive, and was encored. The Petite Comedy of "Catching an Heiress," was the afterpiece, and a most amusing affair it was. We are surprised that this piece is not oftner repeated, as it would never fail to fill the house at halfprice. Mr. Munyard was passable, and that's all, as Captain Poodle, a Cavalry officer. He was quite out of his line of business Mr Ca meron did not know one word, more to his shame, as Capt. Killingly. Mr. Gayton, by Mr. Stanton, was an extraordinary performance, he is introducing a new school of acting alto gether. Mr. Lazar doubled the characters of Tom Twigg and Baron Sowercroutzensansingen with much success, and kept the audience in a roar with "The Statty Fair," which was encored, and even then it appeared doubtful whether a repetition would not have been required. Mrs. Taylor was interesting and facetious as Caroline Gayton, and first rate in the character of Mr. Fip Gayton, an exquisite: her delinea tion of puppyism were complete, and caused the risible muscles of the audience to be kept in full play. Mrs. Downes was in her line as Fanny Giggle, and therefore was passable; her double of Jessamy was another affair, she's too short and thick for a tiger character. But the top boots, certainly, they added in some degree to the merriment; but in our opinion, people with knock knees should not wear top boot-we say nothing. We should recommend Mrs. D. be ore she again appears in that character, to pass a small bill through the House, compelling the tops to accept the Chiltern Hundreds. Per haps some Member of her establishment will put her in the way of carrying the affair through smartly. The evenings performance went off in a style the most satisfactory, and said not a lit tle for the good management of Mr. Lazar. We recommend him by all means to repeat the afterpiece as soon as possible.

DREADFUL MUTINY AT SEA .- A dreadful mutiny and massacre have taken place on board the British ship Fanny, Captain Mackay, master, formerly sailing from London.
