"The case assumes a peculiar importance from the circumstance that Mr. Southey, who gave the death wound, appears to have been subsequently twice commended in general orders, though not indeed with any express reference to his conduct in this office.

He is the son of the late Reverend Mr. Gipps, Rector of Ringwould, near Dover, and Nephew of Mr. Gipps, the Banker at Canterbury, who formerly represented that City in Parliament. Sir George Gipps was Private Secretary to Lord Aukland when First Lord of the Admiralty, afterwards Private Secretary to Lord Mulgrave when Lord Lieutenant of Ircland, the Admiralty, afterwards Private Secretary to Lord Mulgrave when Lord Lieutenant of Ireland, and lastly, one of His Majesty's Commissioners for enquiring into the grievances of Canada. Should Sir George Gipps not touch here, he will of course transmit to Sir John Franklin, from Sydney, the usual authenticated manuscript, of Her Majesty's commission, constituting him Governor in Chief and Captain General of New South Wales and Van Diemen's Land. We shall then know what changes (if any) have been made in the Executive and Legislative Councils of this Colony. We mention this, as it may not be known to some of our readers that the Government of this Colony is administered by authority not of any commission especially issured for rity not of any commission especially issured for Van Diemen's Land, but by that of the same commission under which the Government of the sister Colony is carried on, and it is by this commission that the powers vested in the Execu-tive Councils of the two Colonies are conveyed, and by it also are the individual Members of

AN OUT-AND-OUT SWINDLER .- Joseph Lawrence, aged 28, against whom there were a vast number of indictments, was charged, that he on the 4th of Nov. 1836, stole a harp of the value of £145, the property of Mr. Grosien. Mr. Joseph Grosien stated, that on the 4th of last Nov. the prisoner came to him and said he wanted to hire a harp for two months, and the terms were agreed upon-one of the stipulations was, that it was to be kept in thorough repair, and returned without damage. The prisoner gave his address-J. Lawrence, Esq. solicitor, New-square, Cambridge." He stated that Mr. Judkin. of Hatton-garden, was his agent, and gave reference there, and the account that person gave of the prisoner induced him to give up the harp, which was fetched by the prisoner on Guy Fawkes' day. Before the two months had expired the prisoner wished to enlarge the time of hiring, but witness having written to a friend at Cambridge, had learned enough to induce him to demand his harp. Having lost sight of the prisoner, he advertised him in the Hue and Cry, and offered a reward for his apprehension. Soon after this he saw his harp in Mr. Oxenden's auction-room, where it had been left for sale by a person of the name of Barnes. Witness' clerk soon after captured the prisoner in one of the promenades in the Regent's Park, and consigned him to a station-house. John Coombes, shopman to Mrs. Blackburn, a pawnbroker, in Myddleton-street, Clerkenwell, proved that the prisoner pledged the harp in question there on the 5th November

(the day of the alleged robbery). He gave the name of "John Long, 4, Winchesterstreet;" 10l. was the sum lent upon it, and about a month afterwards he brought Mr. Barnes to redeem it. George Barnes lives in the City-road; the prisoner called on him early in December last, and he went with him to Mrs. Blackburn's to look at a harp which he said was his own, and which be wished to dispose of. Witness paid 101. lent on it, and 3s. 8d. interest, and made it his own by giving the prisoner 191. He sent the Harp to Oxedon's to be sold, and when it was owned he gave it up to Mr. Grosien. Common Serjeant-Harps are

bad things to deal in, are they not?"-Witness-"It would seem so." Common Serjeant—" Have you ever been in any trouble respecting them ?" Witness - ' No. Common Serjeant—"Perhaps, you may if you get a 140 guinea harp for 301." Witness-"Everything's in a name, my Lord, the prosecutor's name is up-it's the case with respect to Broadwood's pianos I'll be bound that Mr. Grosien could make a double-actioned harp for 401." The prisoner, who was undefended, put several irrelevant questions to the witnesses. The Common Serjeant told the Jury the only question was, did the prisoner intend to commit a felony when he hired the harp. It was clear, that instead of its being sent to Cambridge, it found its way to the pawnbroker's on the day the prosecutor gave up possession. The Jury, without hesitation, found the prisoner Guilty. The prisoner was again indicted for stealing chaise and harness, value 231. The Jury again returned a verdict of Guilty. The Common Serjeant said there were three other charges against the prisoner, but if the parties would give up the property, he would not try them, as the ends of justice would be answered by two convictions; there appearing some disinclination, the next case was called :—The prisoner was again indicted for stealing a chaise, value 201. As in the other cases, the prisoner obtained the article by false pretexts, and parted with it the same day. Verdict-Guilty. The Common Serjeant told the prisoner that the Court would not try him on the other charges: he was by far too clever to live in this country, for no tradesman would be safe if such practices were to be slightly passed over. The sentence of the Court was, for the first offence, seven years transportation, and, at the expiration
