

We the undersigned Members of Council Civil Officers, Magistrates, Clergy, Landholders Merchants and other Colonists of New South Wales, beg to approach your Excellency upon your arrival with your family, at the seat of Government, with the renewed assurance of our devoted loyalty to our Most Gracious Socongratulations upon your Excellency's appointment to be Governor of this Colony. As he first representative appointed over us by Her Majesty, entering also upon the high and responsible duties, thus delegated to you, at the commencement of the second half century from the foundation of the Colony, your Excellency's accession to the Government, cannot but form

a memorable epoch in its history.

We trust that this epoch will be in every way auspicious, and become yet more memorable by the continued and progressive improvement in the whole system of our Government by the general amelioration of the society, the development of increasing resources, moral as well as physical, the maintenance of our true interests and the secure establishment in this remote portion of the Empire, of those sound princi ples of religion, morality, and rational liberty which are the national attributes and the glory of Britain.

About a month since, Mr. Vickery, boot and shoemaker of George-street, delivered to a man named Alexander Hunt, who worked for him out of doors, a pair of ladies' shoes, to do to them some slight repairs, and leather to make up. Time passed on, but neither the man nor Mr Vickery's property made their appearance. On Wednesday he was met by Mr. Vickery's foreman, who would not part with him until he gave up the property; they went in company to the house of a woman named Mackay, when Hunt demanded the shoes; they were delivered up but had been worn out. The woman said that she had bought them of Hunt. Mr. Vickery said he was determined to prosecute the case, as not only himself but others of the same trade in Sydney had been continually robbed in a similar manner. The man Hunt for an offence of a like nature, some time since, served twelve months in irons, which appears however to have had but little effect upon him. Many trades-men in Sydney have been robbed to a consider able amount by workmen taking home materials with them to make up and then absconding.

On Sunday afternoon, John Boucher, a ser vant in the employ of Mr. Mackaness, observed a man named Murray in company with another man, coming out of what is called the Sheriff's Garden: they had a handkerchief and a paper full of grapes; he seized upon Murray, when his companion, who was a stranger to Boucher, suggested that they should adjourn and wash down the transaction with a hulf pint of rum to this he refused to consent, and still kept hi hold of Murray, upon which the stranger absconded, and Murray was locked up.

The Quarter Sessions for the district of Muitland commenced on Tuesday last. There were only five cases set down for trial, which speaks loudly for the well government and subordina-tion of that portion of the country; notwithstanding the outery which has been made by certain parties who have a distaste for every thing like order and regularity, the manner in which Mr. Grant, the Maitland Police Magistrate, performs his duties gives general satisfac-tion to the inhabitants of that portion of th community. #### Supreme Court.

TUESDAY .- Before the Chief Justice and a 'ommon Jury.

RENNET D. CAPE.

This was an action to recover compensation or the 22nd December, Mr. Cape hired a horse from plaintiff for two hours; he did not return for five or six, when the knees of the animal were found to be broken. The defence to the action was, that after Mr. Cape started with the horse it came on to rain heavily causing the horse; it came on to rain heavily, causing the delay beyond the time agreed upon; and that, as he was returning home, owing to the slipperiness of the road, the horse stumbled and fell, thereby breaking its knees.

Mr. Jacques, father in law to defendant, was called to speak as to the rain, and the consequent detention of Mr. Cape, but he remembered nothing of the matter, Mr. C. being in the constant habit of calling at his house.

His Honor ruled, that it was an implied contract when a person borrowed a horse, that it should be a good horse, and that the hirer should use due diligence and care towards it; he was not answerable for unavoidable or inevitable accidents, and it was for the lender to show it was not inevitable. In this case, defendant having exceeded his contract, the onus rested him, to show that the accident was unavoidable.

The Jury returned a verdict for plaintiff, damages £23 7s 6d; the odd shillings and pence being for half a day's hire of the horse.
