

FEMALE ORPHAN SCHOOL.—This institution is invaluable in any country, more especially so in a rapidly rising and peculiarly constituted Colony like New South Wales. But if abused, it is attended with a curse, rather than a benefit to those for whose protection and support it was peculiarly instituted. We are led to these reflections, by having within these few days witnessed some specimens of the working of this system, which we do not consider creditable to those who manage the institution. One, is the case of a girl named Ann Gutch or Gudge, who had been apprenticed to a Mrs. Maddox, of Pitt-street. The infant, for she was nothing else, of the tender age of nine years, complained of ill-treatment from the motherin-law of her mistress, and the Bench said they would enquire into it. This is not the subject we intend canvassing at present.— Our notice was particularly directed to the tender age of the child, and the service for to nurse children, when she was totally incompetent to take care of herself. A second, was a young girl apparently not much older, apprenticed to Mr. Soole, of George-street who complained of her being incorrigible and had lately absconded for a fortnight. living, as she stated, with a fruit woman, in Prince-street; and as a third instance, a child under similar circumstances, named Janet Watt, has been advertised as having absconded for the third time. In the first instance, the child, in our opinion, from her size and years, was totally incapable of the duty required of her, and ought not under any circumstances to have been apprenticed until she was at least four years more advanced in life. The two latter cases also show the impropriety of sending out into the world children of such tender years, who for the want of anything like fixed principles, are easily seduced from the paths of rectitude and good conduct. But we can tell the recreants that do fly, that the lash shall follow them as they run, and that we shall be neither delicate nor gentle in its application; and, further, that they have not the slightest occasion to lay the flattering unction to their souls, that they will grind any sum of money from the widow as a premium for their own villainy of conduct, but that they will be called upon to pay, to the uttermost farthing, the for-feit of their bond. Now, we would ask these people upon what ground, or what shadow of pretext they have for descriing before the close of the season? Tis a question that is unan-swerable. The Benefits, which appear gall and wormwood to the very "judicious critic" of the Gazette, are shortly to commence: they are so, and very properly too. MERCHANT SEAMEN AGAIN .- Captain Orlando Bull, of the barque Spartan, brought before the Police on Saturday two of his seamen, named William Kenny and William Griffith, who had signed articles in London to proceed to New South Wales, and return to her port of dis-charge, touching at any immediate ports. They had each absconded for the 29 days last past. Kenny he had found on board the Elizabeth schooner, and the master of that vessel de murred when called upon to deliver him up, bu upon the production of a warrant he allowed him to be taken away. The man Griffith, dur-ing the time of his desertion, had been employed on board the *Tanar*, steam boat, earning wages.

The Bench wished to know if Captain Bull treated the absence of the men as a desertion. Captain B. replied, "Yes, a total desertion when they signed articles it was fully explained to them that forty-eight hours absence would be considered total desertion." The Bench, upon looking at the information, discovered that they were charged with absconding. not desertion, and therefore they could not punish them for the latter offence. [Oh! this law, this law!] Captain Bull replied, that when he made his affidavit upon which the warrant was issued, forty eight hours had elapsed, but he was not permitted to have the nood "DESERTION" inserted in his affidavit. The Bench were troubled with a con venient deafness at this remark, which is some times the case, and only replied, they could not not punish them for desertion, but absconding. The men were then each sentenced to forfeit lifty eight days pay to the owners, being two days pay for each day they had been absent, and also pay the costs.—This is a mere farce and mockery of justice; if the information was faulty through the ignorance of the Clerk who drew it surely it might have been amended—Peel's Act permitting such amendments in the higher Courts, of a grave and important nature. Now, will any man who lays claim to a portion o common sense, attempt to argue, that these men were adequately punished; we say No, fearless of contradiction. Had these men been what is technically called n this country "Free hired Servants," and they had absented themselves, or deserted—for we hold it to be one and the same offence—for half an hour, without leave first had and obtained of their employer, they would in all probability have been sent to the Tread-mill for three months. Merchant seamen, and free hired servants, by analogy, are upon the same footing; they are both servants under specific agreements, yet, comparing the two Acts of Co-lonial legislation under which these two bodies are amenable, it would appear as though the Legislators had a horror of their dinners being spoiled or delayed, or, that their own personal comfort should be in any way intruded on; while the masters of "the bulwarks of old England" are left to shift for themselves, so far as efficient punishment is concerned. A hired servant was the other day sent to the Tread-mill for a month for bringing fish to his master's ta-ble with the scales on. The next day, seamen ab-scond from their vessel, leaving the captain to get his cargo on board, which he is doing with all expedition to save a heavy demurrage, as he best may, and for such absconding they are simply mulcted two days pay for every one they have been absent. We protest against such an inequality in our Colonial enactments, and call upon our Legislators to expunge such anomalies from our Statute Book. We shall not sit caluly by and witness the loss and annoyance sustained by the shipping interest of this port, upon which the prosperity of the Colony mainly depends, without again and again calling for an amended

A HIRED SERVANT.—On Wednesday, Mr. Johnson, of the Bridge End Factory, Botany Road, brought before the Bench his hired ser vant, William Longsong. Mr. J. stated that the prisoner was hired to him as a spinner; he was a good workman, and could carn for him a habit of absenting himself, going to public houses, and boasting that his master did not dare send him to juil, or he would very soon have to follow himself. He had forgiven him this offence fifteen times, and could no longer put up with such treatment; he was determined he should be punished. He had engaged another man to fill his place, but certainly not so expert a workman. Prisoner had nothing to say. The Bench; after commenting upon the kindness of his master in so repeatedly forgiving him, sentenced him to the tread-mill for a month, with this remark, that, when he came out, if he again neglected his duty, and was brought before them, he would receive the full penalty of his offence viz. six months imprisonment. The man, Longsong, appeared to think that he should be able to escape the agreement he had entered into with Mr. Johnson. He is, however, egregiously mistaken. The agreement ceases not until he shall have served the full time for which he shall have bound himself, including, also, every day that he is undergoing punishment for his own misconduct. That is not included in his time of agreement. The same rule applies also to apprentices.
