



Murder of the Captain of the "Sir David Ogilby."

The following particulars relative to the mur unfortunate individual, have been forwarded for publication by Captain

> Brig Mermaid, Peru Harbour May 13, 1838.

Stn,-I am sorry that I have to inform you of the sad disaster that happened to the Davis Ogilly, shortly after her arrival at these Islands she arrived here on the 28th April, having (as Captain Hutchins informed me) experience much bad weather on her passage from Sydney Capt. H. informed me of the route he had though of taking to obtain shell; but being disappointed in his plans, in consequence of my having obtained all that was worth spending time for he determined to spend one or two months in fishing before proceeding to Manilla. For this purpose, he purchased of me three kettles for 2lb shell each; he also shipped five men, two from me and three from the shore, and sailed for Beratta on the 30th same month. For your satisfaction I will state the amount of trade expended at this place as given to me by Captain H. One whole's touch to me by H. One whale's tooth to each of the principal chiefs, say four; four teeth for shell turtle; six gallons liquor; one keg powder and one musket for five head shell and several hogs; this shell belonged to a white man who was forbid putting his foot on board my vessel; I believe this account to be correct; Captain II. anchored at Beratta the following day. The particulars from that time till her arrival at this place, you will get from the certificates, signed by those who m board of her at the time of the disaster and by the Lobooker people who assisted in bringing her to this place; she arrived off this barbour, on the morning of the 5th instant, with colours half must, fired a gun, and shortened sail; a boat was despatched from my vessel with Mr. Linden (the present master) and four hands to render any necessary assistance; I was ashore at the time, but returning, at noon, I tooka small canoe and boarded her in the passage; I heard that Captain II. was dead—killed at Be-ratta and buried in Lobooker; one hand also killed; I found the mate (Mr. White) lying below in a dying condition, with five severe cuts on the head, his neck and shoulders much bruised, apparently with clubs. All (with one exception) who were on board at the time, were more or less wounded. Samuel Hicks (who called hun-self mate) was severely wounded in the head, cut, but doing duty when I went on board; Ed ward Stevens bruised in the thigh with a spear; Thomas M'Cullen wounded in the head and shoulder by a club; John Hunter on the head John Jones, a severe cut on the foot. I brought the vessel to anchor and sent those whose wounds needed dressing abourd my vessel to have them dressed. Mr. White's wounds were dressed as well as circumstances would admit, it being impossible to move him, his head and neck were greatly swollen, he was completely disfigured. I found the vessel in great disorder; there were chests in the cabin, unlocked, and no keys to be found; trade lying about in all directions, and a cask of liquor on board to which every one had access; there were clothes stained with blood, and patches of blood in various places about the cabin; one musket ball hole through the Captain's state room door, and one in the larboard berth, both apparently fired down the skylight; on deck there were many traces of blood, on the larboard quarter and on the running rigging, and about the quar-deck. I found her hold in great disorder. The fish, some of it in bad order and all much exposed; before leaving the vessel, I sent for my first officer to come on board and remain during the night to see that nothing should be taken from her. The next morning (Sunday), I sent

I noticed some of the hands a little the worse for liquor, and before I left the vessel I informed Hicks (who had charge of it) that if a better use was not made of it, I should start i all over-board, let the consequences be what the would. The next morning (Monday) Mr. Cross came again and went on board the Ogilby A. this time, I took final charge of the vessel, secing no one on board whom I thought capable of the duty. I overhauled and found the ship's papers instant, with considerable damage done to her and found by the articles that no officer rem oard, although Hicks maintained that Cap tain II. had made him such; his promotion however, I could not find in the log-book, and ac cordingly I took charge of the vessel in you name; I took an inventory of Captain IP's property and of the trade &c., I found on board. Finding that they still continued to use the liquor freely, I ordered the cask to be got on deck, and in the presence of all hands had it stove and started overboard; it was not quite half full, but in destroying it, I believe, I acted for the welfare of all concerned. Hicks being unwell, I put Mr. Linden on board with orders to have the hold cleared up; the fish covered from the wea-ther, and her rigging put in condition for sea. I hired canoes to fill up her water, they watering with my casks and paid them from the trade of the vessel. I have accounted for, and in every resrest I have acted with her as my own property: I found no invoice of the property on board, but am induced to believe (from Cupi. II. informing me on his first arrival) he had a number of doubloons on board (his own property) ask-ing me at the same time their value in Manilla; hese I have not been able to find, but think that (if he had such in his possession) they are together with a watch secreted somewhere on board the vessel; I expect to get her ready for sea to morrow, and shall put Mr. Linden in charge of her. This man has been in my employ up wards of 4 years, and (leaving liquor on one side) I cannot speak of him in too high terms; as he intends to return to these Islands to reside, and put up a small vessel. I would recommend him as a first rate pilot for these Islands, either for a nan of war or merchant man I sincerely hope that this disaster of the

Ogilby, will be noticed by your government, and that shortly an armed vessel will be here to take satisfaction. It is time something was done, otherwise traders here will not be safe. It may e said that the whites are the aggressors; but i treasonable to suppose that a master looking for his voyage will voluntarily affront the natives? Whoever may have been the aggressors in similar instances at other islands, you may believe me, that the whites have not, in instances of this that the whites have not, in instances of this kind here. The only blame that can be attached to masters of vessels visiting here is, in not keeping a sufficient look out; but if Capt II. of the Ogilby, was to blame in this respect, he expiated his fault with his life. The natives about Beratta and all along that part of the coast, deserve to be punished. Threats and promises are of no avail; they place so little value on human life and so many whites have been numan life, and so many whites have bee killed whose deaths remain unrevenged, that rather emboldens than deters the natives. Th English armed vessel that visited these island had Mr. Linden on board for a pilot. The commander of her did all he could, or as much perhaps, as he felt authorised to do, concerning the French brig that was taken by the Bever people in 1834. But I have since heard these same natives ridicule that vessel, and speak of her commander as a coward. It is not long since there was an English whale ship of Cantab. The first officer was ashore trading and the natives detained him ashore and kep him till ransomed by the Captain. They ar eager to possess the trade we bring among them and until an example has been set them of th power of armed vessels, they will never cens their treacherous attempts upon vessels wheneve they have an opportunity. The French should they have an opportunity. The French should not forget they owe them a small debt; the sooner it were paid the better. The Americans should owe them several more; and considering the trade we have held here the last eleven years the heads of our government are much to blame for not noticing the depredations of (what are termed at home) these unoffending natives. The trade is certainly but small, but worth protect tion; and if not furnished, will be carried o with great risk and the loss of many lives. The navigation here is very bad, but notwithstand ing, I believe there are many officers in our na vies, who would run any risk to avenge these unprovoked treacheries.

With respect to Mr. Linden, I have agreed with him, that for his services he is to receiv £100 on his arrival in Sydney, which amount, think, is not out of the way

The failure of this part of the voyage cannobut be attended with considerable expense or your part; but, perhaps, not so much as if the vessel had been taken, or the accident had happened subsequent to my departure, and no other vessel here. At all events, Sir, those who were on board of her at the time of the affray are deserving of credit, and entitled to you generous consideration for retaking and bring ing her here. To morrow was the day I had intended to sail, but the arrival of the Ogilby un der such circumstances will detain me four o five days longer; but the detention of my vesse

RENEWAL OF NEW SOUTH WALES ACT,

9 Geo. IV. Cap. 83, passed 25 July, 1828.

Despatch from the Right Honorable Lord Glenely, Secretary of State for the Colonies, to His Excellency Sir Richard Bourke, K. C. B., Se. Sc. Sc.

> Downing-street. 25th August, 1837.

I have the honour to transmit to you a copy of an Act which has been passed, to continue until the 31st December, 1838, and from thence to the end of the then next ensuing Session of Parliament, an Act of the Ninth year of His Majesty King George the Fourth, for the Administration of Justice in New South Wales

and Van Dieman's Land. You are aware that it was the intention of You are aware that it was no measured a fler Majesty's Government to propose to Pur-liament, during the present year, a new Bill for this purpose, and with this view they had bestowed much attention on the subject.

The highly important Enquiries which engaged the Select Committee of the House of mmons, during the last Session, with reference to the moral effect of the System of Transports tion, as well on the criminal himself, as on the Colonial Society into which he is thrown, seemed to render it desirable that the adoption of any new Act of Legislation for the Australian Co. lonies, should not be pressed on the considera tion of Parliament sooner than was indispensa bly necessary, pending those enquiries; and the Session being suddenly terminated by the de-mise of the Crown, the only course remaining for Her Majesty's Government was, to propose the continuance of the existing Act, which has accordingly been carried into effect.

No member to receive profit in any way from funds of club, under penalty of expulsion, nor any money nor gratuity to be given to the servants of the club on any plea whatever. No member to take away from club any newspaper, books, pam phlets, &c. on any pretence. No provisions cooked in the Club-house, or wines or liquors to be sent out for the use of any member. None but members to take refreshments in the Club house. All members to pay their bills of exouse steward to open

CHARGE OF MUTINY ON BOARD THE " GUI-ANA."—On Wednesday last eighteen seamen of the whaler Guiana, Captain Dolling, were brought by him before the Police charged with mutiny. It appeared from his statement that the vessel had been cruising eight or nine been cruising eight or nine months and had not taken a single fish; he put into Amboyna, and applied to the authorities to take the first and second officers out of the shir and control the men; the following morning Mr. Berner, the Harbour Master, and Mr. Ball, J. P, came on board and argued with the men but they refused to obey orders; he wished the ship's berth moved, but theyrefused to weigh anchor. They also refused to spread the awning over a studding-sail boom on which the cook was sitting armed with a knife. To these charges the doctor of the vessel and the chief officer proved that dissatisfaction existed among the men in consequence of the frequent intoxi cation of the captain, his refusal to lower boats when whales were in sight, and his beating a when whates were in sight, and his heating a man named Cantle with a heavy wooden sword used in the making of mats. The case which had not a leg to stand on-appeared to us a complete farce, and one of that kind which masters of vessels but too often take advantage of te hide their own inability and misconduct, wast ing the public time, and making a mockery o justice. The Bench appear to have a penchant for such cases, thinking probably that they can show their legal acumen and astateness in ex amining the witnesses, but we think very differently. The case redounds but anything to men were dismissed; and whoever issued the warrant for their apprehension should have required more than one allidavit before so many nen wore taken into custody.
