gaol. They were taken by Captain Mackenzie, of the 21st R. S. F., the Police Magistrate at the Green Ponds. We are indebted to a contemporary for the following interesting account of capture:-

On Monday last, information was received of the runaways having been at Jerusalem, and that they had been at the Eastern Marshes. Captain Mackenzie determined upon proceeding himself in search of them; he took with him four soldiers, two constables, and two prisoners, all volunteers, he himself heading them on foot. From information which had reached him, he proceeded first to Reis's, near the Brown Mounproceeded first to iters's, near the Brown Mountain, where he got upon the track of the runaways, having ascertained they had taken a horse to carry Banks, a free youth, of about 20, who had joined them, but who had been wounded in the leg in some rencontre. Captain Mackenzie, after traversing with great difficulty, a ragged brushy ravine, arrived at sunset at the top of the Brown Manufain from whome he top of the Brown Mountain, from whence he could overlook the surrounding country, but seeing no fires in any direction, he turned back to Reis's, and from thence towards the Eastern Marshes. After a long march, on Friday, he arrived at Stokell's about sunset, where he remained until the moon rose, about one o'clock on the morning of Saturday, when judging from all circumstances that the runaways could not be far in advance of him, he proceeded in the direction of Runney's stock hut; upon his ar-rival there, three o'clock, he saw, to his satisfaction, that there was a light, an I was convinced that the men were within: halting his party at that the men were within: natting his party at a distance of about 300 yards from the hut, he asked which of them would volunteer to proceed with him to enter it, purporting to divide his men into two parties, the one to cover the advance of the other, supposing the runaways would rush out and attempt to escape. They all professed their anxiety to lead, but he sean professed their anxiety to feat, but he selected Cockburn, a soldier of the 21st, Peacock and Buckley, two prisoners, the latter being the man who shot! Jenkins, the celebrated bushranger; the hut was situated in an inclosure, the gate of which was at about 100 yards discussed from it the faces pressing close to it the sance from it, the fence passing close to it, the windows looking towards the gate; the two parties advanced to the hut, in different direcparties advanced to the hut, in different directions, the one entering by the gate proceeded to the door, the other up the fence, but reaching it nearly at the same time with Captain Mac kenzie. The men he sought were there, Regan who headed them, Banks the youth above mentioned, Davis and Hatrell, with seven pressed men brought with them for the purpose of carry. men brought with them for the purpose of carrying their baggage; these seven men were all ticd, as was Tucker, the resident in the hut, a ticket of leave man. Regan, Davis, and Banks had laid down to repose, posting Hatrell as a sentry at the open door, equally over those within, as to reconsitre without.

Capt. Mackenzie with his party of three admired a said the most of the sentre with the door, when the

vanced rapidly towards the door, when the alarm was loudly given by Hatrell, who called to his companions to stand at their arms, the door was closed, the light extinguished, and all was silent. Capt. Mackenzie knocked at the door and demanded admittance, calling out who he was, but no answer was given; he then caused the men to break in the windows, but still all being silent, incautiously he looked into the window he had thus broken open, and saw the muzzle of a gun levelled at him at a short distance. Peacock, one of the prisoners, was at the other window, and the men ready to fire when ordered; Capt. Mackenzie then called aloud, "pressed men lay down, for unless the others surrender I'll fire upon them." The windows were so small that Regan and the three others were enabled to get out of the range of fire, but yet to cover the entrances either by the two windows or doors. At this moment Tucker who was tied to the 'able on the ground, contriving to loosen himself, and covering himcontriving to loosen misself, and covering mar-self with a bag of wool which was near him, he crept to the door, unbolted it and got out. The door opened inwards upon the pressed men, but opposite to the runaways, who were thus mable to attempt to shut it, which would have brought them within the range of fire. Captain Mackenzie then called upon them to surrender or he would fire into the place, although he was very anxious to avoid taking life; no answer being given, he caused a few shots to be fired into the hut, which not being returned, Captain Mackenzie again called to Regan, but still not a word was spoken within; the firing again com menced, when Regan called out "Capt. Makenzie will you treat us well if we surrender?" Capt-Mackenzie promised to do so, but still apprehending they would rush out, he told them that they must come out upon their hands and knees one by one; Hatwell came out first as ordered, and then came Banks and Davis, but Regan ad vanced to the door erect, but holding up his hands to show that he was marmed, called to Capt. Mackenzic to shoot him if he pleased, for he would rather die like a man than crawl out like a dog. Capt. Mackenzie having secured him, caused them all to be stript, and covering them with blankets put them into a cart which, we omitted to state, he had brought with him from Stokell's. The pressed men were then re leased; by this time it was nearly daylight. The arms found in the hut were three double barrelled guns, a blunderbuss, a large gun cut down, and six pistols, all heavily loaded and cocked, also plenty of powder and ball. Regan and the three others were extremely indignant at being placed stript in the eart. Captain Mackenzie proceeded without delay to Jerusa-lem, where he provided his captives with cloth-ing, and had the wounded man attended to, having given the whole the necessary refresh-ment, reached Richmond at sunset, he lodged his captives in the gaol, and on the following morning (Sunday) proceeded to town by Kangaroo Point. When entering the steam-boat, having cause to suspect Regan of an intention to jump overboard, had him tied to a ring-bolt on the deck; during the passage he contrived to get loose, and turning to Capt. Mackenzie, he said "you see I could do it if I liked." Capt. Mackenzie did not cause him to be tied again.

The greatest praise is due to Capt, Mackenzie The greatest praise is due to Capt. Mackenzie for his conduct in this important affair. It required equal firmness and discretion, and perseverance, to effect the desired purpose; expeditiously as it was done, and without the loss of life on either side; Capt. Mackenzie's conduct at the hut evinced equal coolness and deter-mination; the slightest want of either would obviously have been attended with serious loss of life-most probably of his own, and of some, if not the whole of his party. The prisoners who were with him, will no doubt be rewarded as they so well deserve; and Tucker, the ticketof levve man at the hut, will of course be in cluded in the Government consideration. This is the officer whose sword (we mentioned the occurrence in our number of 19th of December) King George the IVth borrowed at Windsor Castic, with which to confer upon the Duchess of Kent's Chamberlain, Sir John Convoy, the honor of knighthood. - Bent's News.

CAPTAIN GOODWIN .- All our readers will be happy to hear, that on Tuesday last the Court, according to our anticipation, confirmed the ar rest of judgement in the improper conviction of Captain Goodwin for libel, and discharged that gentleman from his bail. We cannot but observe that a great hardship and serious expense was unnecessarily imposed on Captain Goodwin, by his detention in town, which was of itself a punishment, although the judges decided, that although convicted, he was legally, and in fact,

charged with no offence.
Captain Goodwin still remains in town, weite return of the Launceston coach. Private letters from Launceston state, that there was a general rejoicing there, when tidings arrived of his discharge, and that on his return, he is to be entertained at a public dinner, by a numerous body of the most respectable inhabitants. - True Colonist.
