Money Market, March 24 .- Within the and two or three days money has become more easier in the City, and the apprehensions entertained at the end of last week, that it would continue in demand on an increasing rate until the payment of the quarterly devidends had ceased to operate. The reason assigned for this change, arises out of the circumstance to which we adverted to in our last, namely, that the importation of goods for the distant markets has reduced the demand for nearly all the staple ar ticles to the current consumption. This state of matters makes good our supposition, that the efforts made by the previous holders of stocks to prevent a partial decline, would prove ineffectual, in consequence of the magnitude of the aggregate value of the new importations, and ber of rival interests which require to be combined to effect such an object. There has yet been no very marked decline in the price of any important commodity, but in every instance where attempts have been made to force sales beyond the actual demand for consumption it has immediately produced lower quotations than the previous sales. The feeling therefore, is, to avoid buying in anticipation until price are presumed to have reached the lowest noint of depression, and it is easy to perceive that such a state of things, must for a time, render money more abundant. There is no likelihood however, of the depression of prices reaching the point it did last year; as confidence is in a considerable degree re-established, and advances can therefore be much more readily obtained when required upon goods held by the mer-chants, guarded of course by secure limits. The change is perceptable upon public securities which have again exhibited a tendency to ad-vance, without the assistance of speculative operations of such magnitude as would affect prices. The Bill Brokers are giving about 3 per Cent. for money, and discounts are varying from 31 to 4 per Cent., according to the character of the paper and the length of time it

Home Trape .- We have fewer complaints from the manufacturing districts than might be expected under circumstances. Wages and profits are no doubt low, but few persons are out of employment. The demand for the home warket is steady for the principal productions of the loom, and the iron trade, for obvious reasons, is in a state of full activity at remunerating prices.

The demand for many of the Colonies is regular and good. The money expended by the Railway Company is sensibly felt throughout the country. The principal drawback is the re-latively high prices of subsistence, contrasted with the rate of wages. The capabilities and energies of the country have however, upon the whole, been matter of perfect astonishment to our American brethren, who had been in the habit for some years past of assuming that a cessation of their demands for our manufactures to the extent which has occurred for eighteen months would involve us in absolute and irretrievable ruin. The inadequate conception which the most enlighted persons amongst them formed of the resources of the country, and the universality of the impression is obvious from the fact, that when the commercial crush occurred in New York, in the beginning of last year, the President exclaimed bankrupt all England. He must now be unde. ceived as to the relative power of the two countries.

EXTENSIVE JEWEL ROBBERY.—At Lord Chalemont's, another of those singular robberies termed among the police "put up," that is a robbery deliberately planned and carried into execution at a favorable moment, took place on Saturday night last, at the residence of Lord Charlemont, No. 19, Lower Grosvenor-street. Lady Charlemont was in attendance on her Majesty on Saturday, and did not reach her re-sidence until about 12 o'clock at night. The first suspicion was created on the disco cry being made that a gold watch which usually stood in the dressing room of Lady Elizabeth Claremont was gone. The servants were questioned, and one of them declared that at a quarter past seven the Supreme Court, to recover a compensation o'clock that evening the watch was in its usual place. Lady Charemont on proceeding to her dressing-room found the drawers in it open and lished in that paper of the 7th, 12th, and 14th ransacked. It was soon ascertained that property, consisting principally of jewellery, upwards of £2000 in value was taken away. Information was instantly conveyed to the Station House, and Inspector Haining, a very experienced constable, proceeded to her Ladyship's re sidence Haihing, after making an inspection of the place, became satisfied that the thief was ap parently well acquainted with the premises and where the valuable property was kept, and also that access to the house had been effected through the lettice rooms. It being too dark to pursue the investigation at that hour. The nspector went away, but returned at day light; notwithstanding a shower of rain had fallen during the night, which had partially obliterated the footstops, sufficient traces were left to place beyond doubt the fact of the thief having entered the house from the top. The inspector succeeded in tracing the foot marks to an empty house at the corner of Davies-street, five doors from Lord Charlemont's residence. A description of the missing property was forwarded to the police. It consisted of a diamond necklace, valued at 1000 guineas; four gold snuff boxes, two containing the freedom of Irish cities, presented to Lord Charlemont; gold watches, diamond rings, gold chains, and a quatity of Irish diamonds. Lord Charlemont was in Dublin at the time of the robbery, as also I ady Clement. Information of the robbery was forwarded to both, as it is feared that the loss is not entirely confined to Lord Charlemont's property; in Lady Clement's dressing room the drawers had

There are many cases of men whose characters would stand the test of any enquiry, and who were refused licenses merely because some of them were bachelors Others whose premises were not considered sufficiently commodious, and others who in tended to open new houses, could not obtain licenses because the number of public houses were to be diminished. These cases were better to have been cited than many others. While we agree with our Contempory as to the hardship endured by respectable persons, we are willing to admit, that there are many of the rejected who do not deserve licenses, and such as a re view of their cases, would gain little or nothing by being allowed a re-hearing. We think, how ever, that much waste of money might have been saved by many of the rejected, if the Bench had intimated to them, that objections would be taken which would deprive them of their licenses, and surely there was sufficient time between the 5th of June, the last day of receiving applications, and the 26th, the last day of entertaining such applications.

The circumstances are as follow :- Plaintiff was employed by one Ford in an action against Place and Tallenton, for a breach of contract, tried during the last Term—a few days previous to the publication of the first libel—which was headed "Jobhery in the Supreme Court," which purported to be a report of the trial, and con-tained remarks alleged to have been made by the Judge on the conduct of the attorney who brought the action, together with comments by the Editor. From the statement made by plaintiff's counsel and the evidence adduced, it appeared that the Judge who presided on the trial of the case "Ford v. Pace," made no such remarks as those imputed to him in the first publication, that he had endeavoured to dissuade Ford from bringing the action, that plaintiff was suspended for taking an assignment from one Baldwin, who was acquitted of the charge preferred against him, that the Judge in suspending plaintiff acquitted him of dishonorable motives, that Godfrey was convicted of sheep stealing, and that plaintiff had nothing whatever to do

with his defence. On the part of the defendant it was contended that the articles were intended as comments on the division of the bor, and not an attack on the character of plaintiff, who would have acted wisely if he had taken no notice of the paragraphs, and that defendant had not been before

the Court for libel for several years. His Honor in summing up, left it to the Jury to say whether the articles were libellous, and so to what damages was the plaintiff entitled.

#### Hobart Town Extracts.

THE BUSHRANGERS .-- No fresh intelligence respecting the movements of the second gang of bushrangers had reached our office when we went to press, but the following extract of a letter gives some interesting particulars con-nected with the robbery and murder lately committed near Ben Lomond.

" I was alarmed by one of my men running

down from the upper run, a distance of three miles, to inform me the hut-keeper, Samuel Day, a tailor, had been murdered in a most brutal manner. I immediately dispatched three men with arms, to search the body if any life was eft, also a man on horseback to return with the particulars. He was quite cold and stiff. They found the ball had entered about the third rib on the right side, and came out at the left houlder. I immediately dispatched the man on another horse with the information to the Police Magistrate, R. Wales, Esq., Morred, during which time I armed 18 men with muskets and fowling pieces, determined to find the murderer, if possible. The three men which I sent up, and the shepherd, who remained from the time he found the body, heard a person on horseback at full gallop—this was Mr. Henry Pyke, who informed them he had been detained nearly four hours in the hut by the bushrangers, all armed with double-barralled guns and pistols, each man capable of firing six times without loading, and advised them not to encounter with their muskets. Immediately after Mr. Pyke left them they were alarmed by the dogs, and observed three men coming towards the hut with their pieces in their hands. One man remained a short distance off for some minutes, and saw the first bushranger knock at the door, and say halloo my lads are you all asleep, and then enter the hut. They all four ran down imthen enter the hut. They all four ran down immediately to inform me they were in the hut, and what they had heard them say. I immediately dispatched a party of six men well armed, for the spot. On their way they heard a man in the scrub, and ordered him to stand; they brought him out, and found, from the smell of port wine which they had been drinking in the hut during Mr. Pyke's stay, that he was one of the party. They immediately brought him home, and I searched him thyself. I found in his pocket 10 hall cartridge. 30 hulls, a flask of pocket 10 ball cartridge, 30 balls, a flask of powder, &c., and two razors, which he had taken rom the hut, belonging to the shepherd, John Greenhalgh, also a paper containing silk and needles, which he could also swear to. He then told me his name was James Ely, who had been told me his name was James Ely, who had been out so long, and said at the place the men found him they would find his double-barrelled gun, which he had taken from one of Mr. David Gibson's shepherds; they immediately set off in search and found it, during which time I had him secured in the stone house with a strong guard. They then went in search of the other three, which he said he had lost in consequence of baying dyank too much of the not wire and of having drank too much of the port wine and brandy which they had taken from Mr. Edmund Bryant's the night before. He would not con-fess anything about the murder, but said he had been drinking at the hut nearly all day, and they had killed a sucking pig and dressed it, which was very good. The two shepherds who found the body were at my house the whole day dress. ing sheep, which was the cause of their not being disturbed. The party returned about two o'clock, but without more success. At this time a party of constables arrived, which I sent off with six of my men who had been on guard at the house, and put the others on guard for the night, ac-companied by my father and brother John. The other party returned without success. During this night they robbed Mr. Corbett's, and Mr. Samuel Bryan's huts, which accounted for their not being found. This morning I sent Ely to the prison at Morven, in charge of the six men who took him. Mr. Wales and Mr. Murray came this morning to examine the body, and appointed Monday at 12 o'clock for the jury to sit on the inquest. Mr. Pyke informs me he rode to the door for the purpose of informing my shepherds one of his men had taken the bush with a party of bushrangers, and had been to Mr. Bryant's and robbed his house, and stuck up 19 men and tied their hands. When he got to the door two men came out with double-barrelled pieces, and told him to alight, which he refused; but was at last compelled. They then told the deceased to take Mr. Pyke's horse, put him in, and give him a feed of corn. They then offered Mr. Pyke some wine, which he refused, but they obliged him to drink, by pouring it into his mouth until he was nearly tipsy. During this time they killed a pig and dressed it. They ordered the deceased to go up stairs and fetch some onions; he went up stairs, but they thought him long in returning, when one of them called out for him to come down, but receiving no answer they fired two balls at the ceiling. Not receiving any answer again, they looked out of the door and saw him running across the paddock, some distance from the house. They pursued and brought him back, when they tied his hands behind him and threatened him. They then told Mr. Pyke they intended to march him to our house, but he begged of them not. One man then went for his horse, and told him to mount and ride off home, and not stir out till sunset. He set off at full gallop, when they fired after him twice but missed him; this was the last he saw of the de-ceased; he was then alive. The whole of the men on the farm deserve great praise for their exertion and attention." The statement in the above letter is confirmed n almost every particular, by the evidence ad-

duced upon the inquest, which was held at the Morven Police Office on the 12th instant. Ely, in making his statement, acknowledged that he was at Mr. Glover's hut on the Saturday morn. ing the 9th of June; that he saw Samuel Day. the deceased, at the hut the same day, and that he remembers seeing Mr. Henry Pyke talking to two of his comrades, whose names however he would not mention. Benjamin Ball, he says, joined them on Friday night, and that he did so voluntarily. Ely and his companions wished Ball to go back, but he persisted in keeping with them. He acknowledged having obtained two razors which had been found upon him from Mr Glover's hut, and also recognised the dduble har relled gun which was produced as the one which he had with him when taken by Mr. Glover's men, and which healso had when at the shepherd's hut. James Elv has been distinctly identified and sworn to as one of the men who robbed Mr. J. Solomon's stores at Evandale, on or about the 21st day of September last. According to Ely's statement, he has been about two and twenty months in the bush.—Hobart Town Courier. June 22.

Law.—(From a Correspodent.)—Extraordinary Case.—The following case although not recorded in any of the books, is nevertheless true and rather amusing. The detention of a corpse under a writ for debt is a circumstance rare indeed in England, but unknown in any other part of Europo, occurred at Camberwell, during the sittings of the Courts in the winter of the year 1828.
