Supreme Court-Civil Side. IN BANCO.

THE QUEEN AGAINST MR. ROWE. In this case a rule Nisi was granted calling on Mr. Thomas Deane Rowe to answer certain affidavits of the Crown Solicitor and others, on which was grounded an application for at-

Mr. Windeyer rose to shew cause and stated preliminarily that Mr. Rowe wished to have the matter fully brought before the Court. The question which Mr. Rowe was anxious to have decided was, whether he was bound to account to the Crown officers for all his transactions with his clients. He (Mr. W.) admitted that the Crown officers were necessarily armed with vast powers, but the question was, was Mr. Rowe ound to answer the personal application of the Crown Solicitor to account for professionally from a client. He (Mr. W.) thought not. The ground of the present pro ceeding appeared to have been a charge against Mr. Rowe for taking money and making away with it, the property of the Crown. Now the circumstances of the case were these, Mr. Rowe was applied to to defend a man named M'Keon who was committed to take his trial at the Quarter Sessions for stealing £50 from a man who was tried in the Supreme Court and was convicted of horse stealing. M'Keon gave Mr Rowe an order on Mr. Francis Mitchell, merchant, for £32, which was paid to Mr. Rowe, he not knowing how the money was come by, and the terms of that payment were these; Mr. Rowe was to retain the sum of ten guineas for his pro fessional services, and to pay over the residue to the prisoner, or any person on his account. Mr Rowe accordingly paid over first £13 to the pri soner, and afterwards various small sums to his orders, leaving only a balance of £2 5s. which Mr. Rowe still retained in his possession. But Mr. Rowe had paid these various sums previous o the prisoners' trial, had not paid any monies after his conviction, and was now ready to dis-pose of the balance as the Court ordered. It appeared that the Crown had claimed the effects of the man convicted of horse stealing, and as the Crown officers had reason to believe that the money Mr. Rowe received from Mr. Francis Mitchell was a part of the £50 stolen by M'Kcon; the Crown Solicitor personally asked Mr. Rowe to give an account of the £32 so received, which Mr. Rowe doubting the authority of the Crown Solicitor to do so, had certainly declined doing, not but that he was able to ren der a most satisfactory account of it, but because it would involve a question of much importance to the profession generally. It might be a ques-tion how far an attorney ought to step out of his character as an attorney and become the banker of any individual in such circumstances, but the Court would observe that Mr. Rowe had consented to do so as an act of kindness to the prisoner who had urged Mr. Rowe to do so by stating that his money would not be safe with him in gaol. Mr. Rowe was now ready to give a full account of the sum received from M'Keon, and he had receipts for the several sums paid, which the Court could see if required.

Rowe to these facts.

The Attorney-General went through the affi davits filed in the case, and said that the ques-tion was whether Mr. Rowe as an officer of that Court was warranted in retaining the money knowing as he must have done by the deposi tions taken at the Police Office, and as counsel for the prisoner that it was dishonestly come by

Windeyer then put in an affidavit sworn by Mr

being in fact a part of the money, for the steal-ing of which M'Keon had been tried.

The Chief Justice in delivering the decision of the Court said, that he did not think Mr. Rowe had satisfactorily answered the matter of the Crown Solicitor's affidavit. As regarded the power of the Crown officers to call parties to account, there could be no doubt but that Mr Fisher in this case had not only exercised sound discretion, but that he had behaved with sound discretion, but that he had behaved with much courtesy to Mr. Rowe in personally requiring an explanation, instead of at once applying to the Court. Doubless it was his duty to look after the money of the Crown, and he would not have done his duty, if he had not done to The Rule would he extended to size Mr. so. The Rule would be extended to give Mr. Rowe an opportunity of answering more fully to Mr. Fisher's affidavit.

Mr. Windever said that Mr. Rowe would much rather that the Rule should be at onec

made absolute, as he was ready to answer any interrogatory that might be put to him.

The Chief Justice. Let the rule be made ab. solute, and let Mr. Rowe enter into his personal

recognizance for £100, to answer any interrogatories that may be put by the Court.

Exparte R. Windeyer. This was a rule calling on Mr. D. Chambers to shew cause why a criminal information should not be filed against him, for a libel of and concerning Mr. R. Windeyer, published in a placard posted in various parts

of the town by Mr. Chumbers.

Mr. Foster rose to oppose the rule, and went very lengthily into the subject of the affidavits filed on either side which set forth the circum. stances, which have already appeared at length in the newspapers, and which are simply these: On a trial before the Supreme Court, Greece v. Bullivant, in which Mr. Windeyer was Counsel, Mr. D. Chambers was a witness; and, in the course of his cross-examination, stated circumstances that not being fully explained at the time, occasioned the presiding Judge to pass some severe comments on Mr. Chamber's professional conduct, which was followed up by some severe remarks by Mr. Windeyer, Mr. Chambers after wards went into an explanation, which removed the unfavourable impression formed by the Court, and the learned Judge expressed his regret that he had, under an unexplained misapprehension, censured Mr. Chambers; when Mr. Windeyer also said that he had laboured under misapprehension, but did not express any regret for his remarks. It afterwards came to Mr. Chambers' knowledge through a third party, that Mr. Windeyer had said, in an observation to the Court that "if he had been placed in Mr. Chambers' situation, he would have chucked himself into the cove;" upon which Mr. Chambers, who had suffered greatly by the promulgation of the Judge's and Mr. Windeyer's remarks, sent, through Mr. Brown, merchant, of George-street, for an explanation from Mr. Windeyer, and a re-traction of the offensive expression; which that gentleman, through his friend, Mr. Broadhurst, refused to give-on the ground that, whatever were the precise terms he had used, and which he could not remember, he had used them in his professional privilege, and that he did not con-ceive himself bound to answer for them. Mr. Broadhurst having declined a personal meeting for his friend Mr. Windeyer, Mr. Chambers caused the alleged libel to be printed and stuck

through the town.

Their Honors the Judges again recommended that some mutual friend should interpose to effect an arrangement out of Court, stating that both parties were greatly to blame -Mr. Windeyer for exceeding the bounds of professional privilege in the expression he had used to Mr. Chambers; and Mr. C. in having published the placard, which tended to a breach of the peace.

Mr. Chambers stated he was then ready to make mutual concession, but he could not permit himself to be the sole mover in the matter. It appeared that the other side was unwilling

come to any terms. The Chief Justice said the Court was bound to protect the peace, and the rule must be made absolute, as no sufficient cause had been shewn against it. The Court forbore to make any remarks upon the case, which would go be ore another tribunal.

Ex-parte S. E. Levy.—In this case a rule Nish had been granted, calling upon George Sippe to shew cause why a rule for prohibition directed to the Commissioner of the Court of Requests, restraining him in further proceedings in his Court, in the case Sippe v. Levy, should not be made absolute.

The circumstances of this case were as follows: Mrs Sarah Levy, the proprietress of the Theatre, entered into an agreement, in September last. with George Sippe, by which Mr. S. was bound to play in the orchestra of the l'heatre four times aweek, for the space of six months in consideration of which Mrs. Levy agreed to pay him the weekly sum of £3. In the month of March following, Mrs. Levy let her Theatre, and discharged her company, but refused to pay those who were under engagement to her; and Mr. Sippe, who could not get so good an agreement at the new Theatre, sued Mrs. Levy in the Court of Requests, in April, for £9, the amount of three weeks salary, and recovered a verdict. In May following, he again sued Mrs. Levy for £9, being for three weeks salary, and again got a verdict; the Commissioner deciding, that as Mr. Sippe had tendered his services regularly to perform his part of the coutract, Mrs Levy was bound to pay him of the contract, Mrs Levy was bound to pay him his salary, which, by the terms of the agreement, was to be paid weekly. It was upon this second verdict that a prohibition was prayed for. Mr. Windeyer, for Mr. Sippe, contended, that the agreement being for work and labour done, for which the payment was to be weekly, it came within the Court of Requests Act, and that Mr. Sippe had his remedy, if he so chose, at the termination of each period of anyment, being successive debts of each period of payment, being successive debts incurred for specific terms of labor, and not a continuous debt, which would place it out of the jurisdiction of the Court The objection to the urisdiction of the Commissioner ought to have

been taken at the time.

Mr. A'decket, on the part of Mrs. Levy, contended that it was a contract for a full term, was in no way affected by the payments being made by instalments, and that Mr. Sippe could not claim on it until the full end and term of his contract. The payment by instalments were made for the convenience of Sippe; but the actual terms of the contract were for a certain sum for an express term, and for an expressed, consideration, and would not be due until that consideration had been fully satisfied. The Court was of opinion that the rule ought

not to be made absolute. The court considered

that the ground taken by Mr. Windeyer, that no objection had been made at the time to the jurisdiction of the commissioner of the Court of requests was conclusive. It did not appear that this objection had ever been brought under the commissioner's notice-it appeared that the commissioner had decided with judgment; his court was one of conscience, equity, and law, and it was only on very particular occasions that his judgments should be brought before another tribunal. If suitors objected to his judgments to be the state of the risdiction, it was incumbent on them to state their objections at the time, and if it appeared that there was no jurisdiction in that court, the suitor would have the benefit of it. It appeared that the second action had evidently been brought forwork and labour done, and it appeared that Sippe had attended, performed his work as far as he could, and tendered his services regularly as by his agreement he was bound to do. came the question, was it a special contract or & came the question, was it a special contract of a mutual agreement? Mrs. Levy had agreed to pay Sippe £3 week per week, and it appeared to the court Sippe had cause of action at the termination of every week. This case was on the same principle as the judgment in the Patriotic Association action, in which it had been held, that the beauty of the property of the pr that although parties had agreed to pay a cer-tain sum for three years, nevertheless, by the terms of the agreement whenever an instalment £5 fell due, the parties were bound to pay it, and could be sued for each instalment as it became due. It was a mutual contract in which one party had agreed to pay £3 weekly, and the other to perform certain work for that consideration. Rule Refused,-Monitor.
