WINDSOR POLICE.

TTESDAY, 11TH SEPTEMBER,-Before Samuel North, Esq., J. P., and William Cox, Esq.,

Anne Riley, appeared upon summons to answer the complaint of John Turnbull, for assulting his wife; the parties in this case are near Elizabeth Turnbull upon being placed in the witness box, stated, that the d fendant, (Ann Riley,) who from appearance and manner of conducting herself before the Bench, is an amazon of the first water, stated, that the said defendant on a certain day assaulted her, by striking her with her fists and knocking her down, biting her eye-lids, and otherwise maltreating her; the case being clealy proved the defendant was found guilty and sentenced to pay a sum of £5 to the poor, including costs and in default of payment, to be imprisoned

John Earl, a licensed publican, residing in Fitzgerald street, Windsor, was duly summoned to answer to an information preferred against him by Mr. Jilks, the Chief Constable, for refusing to admit a constable into a certain part of his house, to wit, a room up stairs, where it was strongly suspected the practice of gambling was being carried on to a disgraceful extent The defendant having been called three times and not answering, the case was gone through by calling the witnesses and examining them severally; he was convicted in the sum of £10 and 3s 6d costs. Cape of Good Hope.

The news from this Colony per Clyde is still of a discouraging nature, the emigrant farmers still being annoyed by the blacks, and compelled to wander far from their original habitations, into the dreary and distant wilds. In consequence, their numbers are rapidly diminishing, in fact some families have been entirely lost sight of, and are in all probability annihilated. It is a great pity a few of the canting, and hypocritical set in the Mother County, who seem to have more pity towards these wild, uncivilized, and murderous blacks, than to their own white and civilized countrymen, do not go and live in the midst of these Caffers, their tone would then soon be changed. The sytem of treacherous plunder is still carried on by these bands of irreconcila-ble Cassers on the frontiers, with not the shadow of a hope that they can be brought to a feeling of true and unchangable unity. Only a short time since an Englisman, while, apparently in the act of retiring to rest, was assassinated by one of these cold blooded murderers, on the frontier, being in charge of a trading station; almost every thing that was portable was taken away by himself and companions, amounting to something considerable.

The inhabitants of Cape Town, anticipating the expiration of slave apprenticeship in December next, are devising plans for supplying themselves with labor from India.

"The Cape of Good Hove Price Current," a new Journal, was to be published at Cape Town shortly; -it is not stated if the proprietors intend to make it in part a political Journal, or to devote its column: exclusively to advertising and markets.

SINGAPORE.

(Concluded from our last.)

On the 14th of June, a public dinner was given at Singapore, by the mercantile gentle. men, to Captain Stanley and the Officers of her H. M. S. Wolfe, as a public approbation of the services rendered them as a body, in the suppression of piracy, by these gentlemen. Captain Warren, of the Hyacinth, and his Officers, were also invited and attended, together with Colonel Cooke, and the Officers of the 8th Rgt M. N. I. stationed there. On the 18th June a sword, value One Hundred Guineas, was presented to Captain Stanley, with the following inscription:— Presented to Captain Edward Stanley, by the European and Chinese mer-cantile Community of Singapore, in testimony, of the grateful sense entertained by them of his unwearied and successful exertions for the suppression of Piracy in the Straits of Malacca, and adjacent seas, during the years 1836, 1837, and 1838, while commanding H. M. S. Wolf."

The following is from the Bombay Gazette, May 21, relating to the intended Persian war.

We are sorry to say that the course of events in Persia has called for an armed interference on the part of the Government of this presidency. It is not known precisely, as secreey is the order of the day, what particular cause there is for the extraordinary preparations that are now in progress in the Indian Navy. Something serious it must have been, otherwise so many vessels would not have been ordered to proceed in the direc-tion of the Gulph. Some say that Mr. McNeil has been ordered to quit the Persian Court, or has quitted it on his own accord in consequence of certain proceedings derogatory to British in-terests and inconsistent with a due regard to British honor. It is reported that order has been received at Bushire by Captain Hennel from Mr. McNeil for the former to leave that place, and put himself under the protection of the British flag in the Persian Gulph at its head quarters Bassadore. From this it would appear that our relations with Persia which have long worn a threatening aspect have at length reached a crisis, and that it has become neces sary for us to maintain, by the presence of an armed force, the respect which is due to us under the faith of treaties, and to prevent the dismem berment of Persia, which seems to be threaten ed by Russian intrigue. We know not what credence is to be given to the report that a body of Russians had entered the Persian service, for the purpose of maintaining the influence of the Czar in the Counsels of the Shah, but if this ac tually be the case, it is time that we bethink ourselves of the true position of our affairs in that country, and assert our title to that respect which is due to one of the oldest and most faithful allies of the Persian monarchy. The arms of the Russians are, it is well known, bent under the specious pretence of friendship upon the annexation of Persia to Russian empire, while those of Britain have for their only object the preservation of tranquility, and the uphold-

ing of legitimate authority.

The news whatever they are, arrived a few days ago by a Buggalow from the Persian Gulph. They must have been considered of the highes importance, as a meeting of Council was held late on Saturday afternoon for the purpose of deciding what measures ought to be taken, under such an emergency. We cannot help notic ing in terms of strong reprehension the conduct of our Commander in Chief, whose presence was imperatively required in such a juncture, in ab senting himself from the presidency without leaving behind him any account of his move. ments. He has gone to sea, and now, in a pe culiarly military crisis, no one knows where to send for him, at a time when his advice might be of the most consequence. The following vessels proceed with as little de-

lay as possible to the scene of action, and we think the armament cannot fail of striking a salutary terror, inasmuch as the formidable Hastings is one of the number, and must inspire a wholsome fear wherever her porentous and unsceming bulk makes its appearance. The vessels are, the Semiramis, Hugh Lindsay, Has. tings, Coole, Tigris, Mahe and the Grant, can be got ready. There was a report that the Berenice would also be sent on the excession, but this appears to be without foundation. If however she would go, the Mahe will be sent on with her despatches.

We have to regret for the sake of the public, that these matters are kept so very secret, as until the truth is known, surmises will be abroad making things a thousand times worse than they actually are. We therefore think the Govern-ment cannot do better than make known the real cause of the present preparations.

VARIETIES.

Rationale of Advertising .. - Advertising is an expedient for obtaining business by no means generally practised. Many tradesmen are deterred by the expense; some

and therefore more apt to be injurious than otherwise. On the other hand some tradesmen make a system of advertising, planting every kind of periodical, from the daily newspaper to the quarterly review, with specifications of their anxiety to serve the public, and of the merits of the articles in which they deal, and evidently spending a considerable sum of money yearly in this way. The unconcerned reader and the less acute tradesman, struck by the frequency of these appeals for business, are apt to suppose that he who makes them must be less under the influence of wisdom than of folly, and a good deal of a pretender or a quack into the bargain. There may even ne a class who make a principle of disbelieving and disregarding all such appeals, and, like the Irishmen, when much enreated to come, the more they won't come. Yet the regular discharge of advertisenents keeps up nevertheless, and the trader nust evidently find it servicable upon the whole. It may be worth while to communicate to young tradesmen the ideas of an old one on this subject—they are simply and briefly as follows :- The first utility of frequent and regular advertising consists in this: there is at all times a large class of persons, both in country and town, who have no fixed places for the purchase of certain necessary articles, and are ready to be swayed and drawn towards any particular place which is earnestly brought under their notice. Indifferent to all, they vield without hesitation to the first who asks. Then, in the country, a considerable number of persons, who wish a supply of the article advertised, and do not know of any particular place where it is to be got, being thus furnished with the address of a person who can supply them, naturally open a communication with that address, which perhaps leads to much ulterior business. People in the country are also liable to be favorably impressed by the frequent sight of a name in the newspaper. The advertising party requires distinction in their eyes, and thus they are led, in making a choice, to prefer him. But by far the most important effect of advertising is one of an indirect nature. It conveys the impression that the party-pretending or not pretending, quackish or not quackish-is anxious for business. One who is anxious for business is unavoidably supposed to be an industrious, attentive, civil person, who keeps the best of articles, at the cheapest rate, does every thing in the neatest and most tradesman-like manner, and in general uses every expedient to gratify and attach customers. People of course like to purchase under those circumstances, and the system of advertising assuring them that such circumstances exist at this particular shop, they select it accordingly. Such are the opinions of the old tradesman alluded o, and they are certainly supported by facts -for wherever an extensive and regular system of advertising is practised, and no back-drawing or unconquerable circumstances exist, it is usually seen to be attended with a considerable share of success. One feature in the philosophy of the subject must be carefully attended to. A faint and infrequent system of advertising does not succeed, not even in proportion. "Drink deep or taste not the Peirian spring."-Chambers' Journal. Narrow escape from a Tiger.—At a re-

cent shooting excursion at Jellasore, in Bengal, Mr. T. Campbell, indigo planter, of that station, was very nearly carried off by a tiger. It happened that whilst pursuing his sport, he wandered away from his companions. It was early in the morning, in the mouth of September. The country consisted of wide plains, occasionally interrupted by heavy clusters of bamboo trees and other timber. Not the slightest suspicion rested with any of the party that a tiger was within miles of the neighbourhood. No rumours had been started by the native "ryotts" (farmers) that ananimal of the kind had been seen. However, it so occurred that Mr. C., who was accompanied by his groom, leading his horse, passed into a small paddy-field, which on one side was bounded by a narrow strip of jungle, and having alarmed a peafowl, discharged the contents of his gun at it, when suddenly something heavily rushed by him in the jungle. At first Mr. C. suspected it to be a hog or a deer, but on penetrating within, he perceived an extensive lair, arched above with thick intervolutions of the Mysore thorn, and a monkey's skull and other bones lying on the verge of it. There were also two outlets from fhe lair, both of which led to a green slip, where cattle and deer were likely to pass, but where Mr. C. entered there was no regular track. Not being supplied with ball, he retreated from this dangerous posi. tion, and in passing over a wicket to reach another paddy-field, on his way home, he discovered a dead bullock at the extreme end of the further outlet, nearly devoured. On inquiry it appeared that the tiger was for the first time, seen on the night previous carrying away a bullock from the little village of Bustom, The animal harboured in the neighbourhood for some weeks, and during the night ventured into the town of Jellasore, and carried off several men and women, cows, and horses. So alarming became his depredations, that eventually application was made to John Inglis Harvey, Esq., the magistrate of Midnapore, in the matter, who despatched two chekaries (native sportsmen) to destroy the marauder. Some days elapsed before they could succeed in discovering his retreat, which they eventually did by means of watching the flight of the vultures into the neighbourhood of the charnel-house. They shot him by moonlight, as he was commencing his nocturnal prowls, by the side of a nullah, in which he was slacking his thirst.
