by a bold exercise of the spiritual sword, and this seems to have struck Lord Palmerston's fancy, while his forcible transportation of two rival French missionaries to the Gambier Islands commended this head of the English missionary establishment as an active spirit and an able man to the then Foreign Office. This activity, it seems, has continued, and has contributed to bring on these disturbances.

"The fact is, neither country has been properly or suitably represented by its officers at Tahiti. Mr. Pritchard was a busybody and a disturber, and M. D'Aubigny peppery and unscrupulous. It would have been ridiculous for the two governments to have fallen out, because these two warm-headed men happened to have come into collision, with the insignia of office upon them. We are ready, for our part, to throw them both overboard, and clear both countries of any connexion with them. In this state of the question it is of comparatively little consequence which of the combatants struck the outward blow, and did the overt act. Both were to blame; and, though the overt act is the one to be taken cognizance of, because it is an overt one, and therefore must be seen, and an apology must be made for it; still, both countries are clear, and both retain their character, because neither has strictly had anything to do with the act, or the provocatives to it.'

This reasonable view of the question is, however, far from being acquiesced in, either by the war party in France, or by the missionary party in England, neither of whom, it appears, would regret giving a new importance to the quarrel by shedding the blood of their countrymen on its account.

THE TENTH REPORT OF THE COMMISSIONERS OF NATIONAL EDUCATION IN IRELAND.

I. We stated in our last Report, that unless the annual grant were raised we could not undertake to contribute to the building or even the support of additional schools, although many were wanted and applied for; nor could we take those steps which we deemed essential for giving due efficacy to our system of local superintendence. We added, that the number of schools under us had about doubled since the present number of local superintendents was fixed; that unless it were augmented, the duty of inspection could not be adequately performed, and that we must consider this a very serious evil.

As the grant has not since been augmented, we have been unable to meet the unceasing desire of the public to establish schools in connexion with us; and many applications which have been made to us for aid now stand over.

We have reason to believe that the number of applications made to us falls far short of what it would have been, had not the country been aware of the exhausted state of the funds; that many who have schools conducted upon principles different from those of the national system would prefer it, if they did not fear that by doing so they might lose some of the contributions which they now receive from individuals, without being ompensated by assistance from us; and that the people of those districts from which aid is withheld feel deeply aggrieved at finding

boon which is professedly intended for the whole of Ireland, but from the advantages of which they are practically excluded.

It has also been matter of regret and disappointment to us, that we have not had it in our power to provide for that strict and frequent inspection of the schools which we have already adverted to as so essential to their efficiency.

We have, therefore, learned with the greatest satisfaction that her Majesty's ministers intend proposing such an addition to the funds confided to us as may enable us to increase the number of our schools, and of our superintendents.

To leave the grant unaugmented would in effect be, not to leave matters go on as heretofore, but suddenly to stop the spread of a great good at a certain point, and thus to make it the means of producing discontent instead of satisfaction through the nation.

We say a great good, because the tendency of the system is to produce peace, and that knowledge of men's true interests, the want of which is so likely to lead to disaffection

We have shown this in former reports, particularly in our last; and we have the gratification of observing, that those unfounded impressions upon the subject, which we have on former occasions had to notice, are at length rapidly dying away.

II. We have now to state our progress

during the last year.

At the close of the year 1842 we had 2727 schools in operation, which were attended by 319,792 children. At the close of 1843, we had 2912 schools, which were attended by 355,323 children. The increase in the number of schools in operation, therefore, amounted within the year to 191; and the increase in the attendance of children, to 35,528.

Your Excellency will thus perceive, by comparison of the foregoing numbers, that the increase in the number of children educated is more than proportionate to the increase in the number of schools by above 13,000.

To most of the new schools we have been able to afford aid only by grants of books; but we have undertaken to give them further assistance, should we be enabled by an augmentation of our funds to do so.

III. We trained during the last year 195 teachers, of whom 134 were males, and 61 were females. Although we give a training of about twenty weeks only to the teachers we bring up from the country (to which time we limit it, that we may the more rapidly extend its advantages to the whole,) yet we find, short as it is, that it effects a very great improvement in those who receive it; and the reports subsequently received of them are, in general, highly satisfactory. propose, should our means be adequate to the purpose, to have in future a certain number of paid monitors in some of our best schools, and that they should be educated for the office of teaching. We intend that they should be selected by the local superintendent, and when of a suitable age, that they should be received at our training establishment, from which they may be set to undertaken schools as opportunities offer. We hope, in this way, without any considerable increase of expense, to provide gradually a supply of that they are excluded from the benefits of a teachers of a superior description, and thus him, and hope he will vacate his seat.

to add most materially to the benefits which the national schools are already conferring upon the country.

IV. The receipts from the sale of our school books continue to increase, although we have been enabled, by a reduction in the cost of printing and binding, to make a large

corresponding reduction in their price.
It appears, by returns had from the patrons of the national schools, pursuant to an order made by the House of Commons the last session, that the Scriptures were read in 944 of the national schools, and that the Scripture extracts which we have published were read in 1,037. We have to add that the school books which we have published were read in all, and of these we beg leave to repeat what we said in our last Report:—"The books we have published for the use of the national schools, and which, though not forced, are adopted universally in them, contain several lessons upon the subject of religion. They give an epitome of Sacred History; they dwell on the original sin of our first parents, and on the promise then made that in time one would come by whom sin should be overcome; they show how that promise was renewed, particularly in the covenant with Abraham; and they point out the fulfilment of it in the coming and suffering of our Lord: they dwell also on the giving of the law to Moses; they state that it is commonly divided into three parts, the moral, the civil, and the ceremonial, and that the moral is of perpetual obligation, 'because the duties which the creatures of God owe to him and to one another can never have an end.' The duty of Christian charity is set forth as enjoined by the precepts and example of our Lord himself; and a lesson by which it is thus inculcated is hung up in every national school."

ATTEMPT AT MURDER.—About one o'clock on the morning of Dec. 27, a most atrocious attempt was made on the life of the Rev. M. O'Reilly of Bathurst by shooting through a glazed door of his sleeping apartment. About the hour named Mr. O'Reilly was awoke by the report of a piece almost close to his head; he had scarcely time to arouse himself before another and a third report took place, supposed from a double-barrel piece; he immediately arose, and having secured a fowling-piece; which was in an adjoining room, he sallied out and searched round the premises, but could discover no one. The matter was investigated privately at the police office on the following day, and suspicions are said to be entertained against several parties, whose names however, are not yet mentioned.

INQUESTS .- On Saturday afternoon, the adjourned inquest on the body of William Henry Russell, who had died on the 24th instant, was resumed, in the "Sir Walter Scott" public house, corner of Bathurst and Sussex-streets. Dr. M'Phee being present to hear the statement of his having opened the body contrary to law, Dr. Silver proved that he saw the body of the deceased on Christmas Day, which had been opened. On the day of the inquest he had made a post mortem examination of the body, which was then in a rapid state of decomposition; but from the heart being twice the natural size, he had no doubt but that death had been caused by disease of the heart. The Coroner stated that it was not his intention to proceed at present any further in the case as it affected Dr. M'Phee. The evidence taken would be forwarded to the Attorney-General, and he (Mr. Brenan) would act in the matter as the Law Officers of the Crown might direct; and if ulterior proceedings were ordered, Dr. M'Phee would receive due notice of the same, which would afford him an opportunity of explaining his conduct. The Jury returned a verdict of died by the visitation of God from disease of the heart.

VOYAGES OF THE "BEAGLE." - Captain Stokes is about to publish, by permission of the Lords of the Admiralty, an account of the voyages and discoveries of H. M. S. Beagle. The following extract from the prospectus will shew the nature of the work: _" New Lands in Australia; discoveries of the Victoria, Adelaide, Albert, and Fitzroy Rivers, and expeditions into the interior described; with an account of the hitherto unknown coasts, surveyed during the voyage of H. M. S. Beagle, between the years 1837 and 1843; also a narrative of the visits of H. M. S. Britomart, Commander Owen Stanley, to the islands in the Arafura Sea. By J. Lort Stokes, Commander, R. N. With maps, charts, and numerous illustrations, 2 vols. 8 vo. The Beagle sailed from England early in the year 1837, and returned towards the close of 1843. During that period, besides the ordinary incidents of naval adventure, many circumstances of the highest interest marked the progress of her voyage. Unknown shores and untraversed plains upon the north and north-west coasts of Australia have been added to our geographical knowledge. An inroad into the interior, reaching within 500 miles of the very centre of the great Australian continent, has been accomplished. The rivers Victoria, Adelaide, Albert, and Fitzroy, all discovered by the expedition to which this narrative relates, attest its triumph in an object of primary importance. Great additions have been made to the several departments of Natural History, the various specimens having been classified and described by some of the most eminent Naturalists. The north-west coast of Australia has been carefully surveyed; and Bass's Straits, heretofore so justly dreaded by the masters of ships, may now be navigated with the safety that ought to distinguish the high road between England and Sydney. The charts of the passage through Torres Strait, by the inner route, have been improved, and a safe channel discovered through Endeavour Strait: while anchorages, especially at Western and Southern Australia, now correctly laid down, and doubtful positions finally assigned, prove that in the unpretending though important duties of surveying, the officers of the expedition failed not to do justice to the cause wherein they were engaged. Notices of Teneriffe, San Salvador, the Brazils, the Cape of Good Hope, the Mauritius, its hurricanes, and the numerous Islands, Waters, and Lands of Australia, now first discovered and described, will be found in the earlier portions of the work, and an account of the interesting visits of H.M.S. Britomart, to the islands in the Arafura Sea, prepared by Capt. Stanley, enriches the latter."

ADJOURND INQUEST .- On Tuesday morning the jury, who had been sworn to make inquisition, concerning the death of Dr. Joseph Meyrick, re-assembled at the Albion Inn, George-street, and the prisoner, Lucius O'Brien, having been brought from the Gaol, at Wooloomooloo, the Coroner proceeded to examine several witnesses, who deposed to the fact of the prisoner having fired two pistols at deceased. After a patient investigation, which lasted nearly nine hours, the jury returned a verdict of wilful murder against the prisoner, Lucius O'Brien, who was accordingly committed, by the Coroner, to take his trial at the ensuing Criminal Session. | against the rates.

Anonymous Letters .- A number of indelicate letters have lately been forwarded to. several respectable females in Sydney. About half-past nine o'clock on Monday evening a man named James M'Mahon took one of them to a highly respectable house, where several of them had been previously sent; he was immediately seized by the servant girl, and held fast until he was given into the charge of the police. In defence, when brought up on Tuesday before Alderman Macdermott and Mr. Miles, the prisoner stated that a man, unknown to him, had employed him to carry the letter to its address for hire. As there was no evidence to rebut his statement, the Alderman, previous to dis-charging him, admonished him as to his future conduct, and expressed his determination to punish with the utmost severity every one convicted before him of insulting respectable people by sending such letters. Mr. Miles also expressed his determination to put forth all the energies of the police in unmasking such miscreants.

NEW POST OFFICES .- His Excellency the Governor having been pleased to approve of the establishment of Post Offices, at Merriwa, situaten between Merton and Cassilis, and Molong, between Bathurst and Wellington, parties wishing to receive their communications through those Post Offices, are advised to caution their correspondents to address their letters and newspapers to those places distinctly by their names, and to secure their being duly forwarded to those Post Offices.

GRAIN .- Statement of the various descriptions of grain held by government on the 1st January, 1845:—Wheat, 39,013 hushels; maize, 6,640 bushels. PORT PHILLIP.—Two meetings have been

held at Melbourne-the first of settlers, at which it was resolved to adopt measures for obtaining a supply of "exiles" from the Pentonville Penitentiary as shepherds and labourers; the second a meeting of citizens, at which the Mayor presided, and at which resolutions were passed strongly protesting against the introduction of those exiles. A curious motive is urged by the advocates for this kind of immigration, namely, "to check the introduction of expiree convicts from Van Diemen's Land!" A choice of evils certainly; but why not rather agitate for the removal of both?

City Council.

MONDAY.

Alderman Broughton brought up a report from the Finance Committee on the fiscal affairs of the Corporation, and the probable expenditure of the year 1845, which was read and received.

Mr. Holden presented a report of the Special Committee appointed to consider the petition of Mr. C. H. Gray, against the rates imposed upon him; stating that the petitioner had himself waved his objections The report was read and received.

The Town Clerk laid upon the table the statistical information required by Mr. Thurlow's resolutions passed on the 4th of December last.

The sum of £215 12s. 10d., being the amount of salaries due to the officers and servants of the Corporation for the month of December, was ordered, upon the motion of Alderman Broughton, to be paid.

The sum of £21 15s. 9d., being the amount of commission due to the rate collectors, was ordered to be paid, upon the motion of Mr. Little.

Distress warrants were ordered, upon the motion of Mr. Holden, to issue against three parties resident in Brisbane Ward, who had made default in the payment of their

The letter of Mr. N. James, recommending certain alterations in the system of keeping the city accounts, was ordered, upon the motion of Alderman Wilshire, to lie on the table.

The report of the Special Committee appointed to enquire into the duties of the City and District Surveyors, recommending that no change should be made in the above offices as at present existing, was taken into consideration, and Mr. Ryan moved that it be adopted.

Alderman Flood opposed the adoption of the report, contending at some length that the City Surveyor had altogether failed to carry out the resolutions of the Council as to the alignment of the streets, &c., and arguing for the necessity of some reformation in this department, as well with the view of rendering it more efficient as of saving some portion of the present expense. He concluded by moving a resolution expressive of the Council's opinion to the above effect.

Alderman Macdermott seconded the amendment, contending that the documents and evidence before the Council fully justified the passing of such a resolution as this. Both offices might be combined at a saving to the city of about £100 a year, without injury to the public service.

Alderman Wilshire moved a further amendment, that the report should be sent back to the committee as incomplete, in order that sufficient information might be laid before the Council to make the new members understand the subject. He proposed also to add Alderman Flood and Mr. Cowlishaw to the committee

Both amendments were ultimately lost, and the original motion (for the adoption of the report) was put and carried, the votes being twelve for and ten against it.

Certain accounts, amounting in the aggregate to £50 11s., were ordered, on the motion of Alderman Broughton, to be paid.

The present collectors of city rates were re-appointed to their situations for the ensuing year, at the present rates of emolument, upon the motion of Alderman Flood.

Alderman Macdermott moved that the valuators employed with a view to the assessment of city property be paid at the rate of 10s. 6d. per day; that there be two valuators to each ward, one the collector of such ward, and the other a person to be appointed by the Council; and that the Town Clerk be instructed to publish advertisements calling for applications for these appointments.

Mr. Fisher moved an amendment to the effect that 6s. per day only should be paid.

Mr. Little moved, as a further amend-ment, that the pay of the valuators should be 12s. 6d. per diem, and that of the collectors

The original motion was ultimately carried by a considerable majority.

Alderman Macdermott moved that the sum of £39 17s. 1d., being the amount of Mr. G. R. Nichols's account for conducting the defence in the case of Baker v. Moir, be paid, as recommended by the Finance Committee.

Alderman Flood protested against any of the city funds being devoted to pay legal expenses which had been incurred solely by the ignorance or neglect of any of their officers, conceiving that the burthen ought to fall upon those by whom the expenses were occasioned.

After some further discussion the Council divided upon the motion, which was carried by a majority of nine.

A committee of six members was named for the purpose of opening the tenders for printing and stationery for the year 1845.

Council adjourned until Wednesday week.

Legislative Council.

SATURDAY,

The Speaker reported that the Royal assent had been given by His Excellency the Governor to the following Acts, namely—the Sydney Incorporation Amendment Act, the Melbourne Incorporation Amendment Act, the Distillation Law Amendment Act, the Appropriation Act, and the Acts for suspending the operation of the 70th clauses in the Sydney and Melbourne Incorporation

Mr. Robinson presented a petition from the Mayor and Town Council of Melbourne, expressing in strong terms the alarm and dissatisfaction which they felt at the arrival, by the Royal George, of a number of convicts, from the English penitentiaries, and praying that the Legislature would throw its shield around and interdict the importation of a class of persons whose presence would act as a moral pestilence in the land.

Mr. Robinson presented a petition from the bakers of Melbourne, praying that the Council would pass a law to prevent baking on Sundays.

Mr. Wentworth moved, pursuant to notice, that the Governor's Message on the Lien on Wool Act Amendment Bill, having, in conformity with the 39th section of the standing orders, lapsed in consequence of the house being counted out on the 26th instant, the said Bill be again presented to his Excellency the Governor, for the Royal Assent, by the Speaker and the Colonial Treasurer.

The motion was carried without discussion.

MONDAY.

The Speaker stated that his Excellency had been pleased to assent, on behalf of her Majesty, to the Wharfage Bill;—that his Excellency had been pleased to send back the Bank of Australia Shares Bill, with a note to the effect that he had reserved the Royal Assent to the Bill until he should have brought it under her Majesty's consideration, and received her Majesty's decision thereon. The Interest Bill, he said, was returned with the Council immediately broke up.

a similar note appended to it. The Bill to amend the preferable Lien on Wool Bill was returned, with a note by his Excellency, that he withheld her Majesty's sanction altogether. The Speaker then stated that during the session eighteen measures which had been passed by the Council had received the royal assent; two had been reserved, and from one the royal assent was withheld.

Shortly after this the approach of the Governor was announced by the usual salute. The guard of honour placed in front of the Chamber, presented arms, and the band of the 99th struck up the national anthem; a salute was also fired from Fort Phillip.

His Excellency then entered the Chamber, and after members had been requested, at his desire, by the Speaker to take their seats, read the following address:-

Mr. Speaker and Gentlemen,

I am happy in being able at length to bring this protracted session to a close, and to release you from further attendance.

As you have, gentlemen, declined to take into consideration the Estimates, which early in the session I laid before you for the administration of justice in the year which is now ensuing, I have only to express my hope that the funds which the law had previously placed at my disposal may be found sufficient to keep open the ordinary tribunals of the colony: the resources which are within my reach, I shall rigorously devote to the purposes to which they are applicable; but I shall not suffer myself to exceed in any manner the authority which I constitutionally hold, nor to set aside the instructions of her

Majesty.

The supplies which you have granted for other branches of the public service, I shall expend with the utmost regard to economy.

I am happy to be able to congratulate you on the marked improvement which has recently manifested itself in the general condition of the colony. The rise which has taken place in England in the value of our chief staple has had a very cheering influence on the whole community, and, by the blessing of Providence, we continue to enjoy the most abundant seasons.

Gentlemen, you have, in the latter part of the present session, entrusted to my care various addresses to her most gracious Majesty, praying for extensive alterations in the Constitution which it pleased her Majesty and Parliament very recently to grant to this portion of her dominions: these addresses I shall take the earliest opportunity of transmitting to her Majesty's Principal Secretary of State for the Colonies, in order that they may be presented to her Majesty; and they will, I have no doubt, receive her Majesty's. most attentive consideration.

Many months must, however, necessarily elapse before her Majesty's replies to these addresses can be received in the colony; and I consequently consider it my duty openly to declare my opinion, that many of the demands of the Council are such as never will be granted-such indeed as never can be granted unless it be the pleasure of her Majesty and Parliament fundamentally and entirely to alter the relations on which this country now stands to the British empire.

I now declare this Council to be prorogued to Tuesday, the fourth day of March.

BIOGRAPHY. WILLIAM COBBETT, ESQ., M. P.

WILLIAM COBBETT was born in the neighbourhood of Farnham, Surrey, on the 9th of March, 1762. His father was a farmer, who, though poor, had the reputation among his neighbours of possessing considerable knowledge and experience. In a pamphlet published in America in 1797, Mr. Cobbett gives the following account of his early life.

"I do not remember the time when I did not earn my own living. My first occupa-tion was driving the small birds from the turnip seed, and the rooks from the pease. When I first trudged a field, with my wooden bottle and my satchel swung over my shoulders, I was hardly able to climb the gates and stiles; and, at the close of the day, to reach home was a task of infinite difficulty, My next employment was weeding wheat, and leading a single horse at harrowing barley. Hoeing pease followed; and hence I arrived at the honor of joining the reapers in harvest, driving the team, and holding plough. We were all of us strong and laborious; and my father used to boast that he had four boys, the eldest of whom was but fifteen years old, who did as much work as any three men in the parish of Farnham. Honest pride and happy days!

"I have some faint recollection of going to school to an old woman, who, I believe, did not succeed in learning me my letters. In the winter evenings, my father learnt us all to read and write, and gave us a pretty tolerable knowledge of arithmetic. Grammar he did not perfectly understand himself, and therefore his endeavours to learn us that necessarily failed; for though he thought he understood it, and though he made us get the rules by heart, we learnt nothing at all of

the principles.

"Our religion was that of the Church of England, to which I have ever remained attached; the more so, perhaps, as it bears the name of my country. As my ancestors were never persecuted for their religious
