Government, particularly with the Stamp Act, which trode upon their toes too heavily. They therefore refused not only to take the pledge of union which was offered to them, but also to take tea any more with their mother. So, by way of a finish, they broke all the crockery, and turned Boston harbour into one large teapot, swearing they would eat all the Parliament cakes who could perceive neither the sweetness nor cream of the joke. At that time the felonry of the United Kingdom were accustomed to drag out their lives and chains in America; but, she having de-clined to be fettered with such associations, it was found necessary to found a penal settlement in some other corner of the globe, and Australia was the favorite for choice. In order to give it a pleasing appearance, the infant scheme was clothed in garments of the most humane, affectionate, and charitable cut. Thus, No. 1. The cap and feathers—"To rid the mother-country of prisoners and gaol accumulations." No. 2. The bib and tucker—"To afford a proper place for their safe custody and reformation." No. 3. The swaddling clothes—"To form a free colony out of reformed prisoners and emigrants of a moral, bland, and mellifluous nature.

With these praiseworthy objects in view, but at a very consider able distance, inasmuch as they have not been yet come up with, the first fleet was despatched under the command of Philip, R.N. Governor and Captain A. 1* In 1788, he anchored in Botany Bay,† where, from the tremendous surf which rolls in, he stood every chance of bottomizing, rather than botanizing; and, as bottomry was not in his bond, he took the liberty of altering his views; and taking the whole body through the Heads, landed at Port Jackson, where he commenced his reign in very dry weather. Here, however, he was again put to his shifts, for he found the soil far too hard for his corns, and the prisoners too sharp for his stores: they having committed several thefts, particularly in the matter of a young bull-calf, from his small stock, which the Governor forcibly remarked, "was very detrimental to the general weal." Desertion also became frequent, the men having taken it into their heads that China was not so very far north as to be out of their reach; so that the green tea country was keeping the new, as it had kept the old, Colony in hot water.

Compelled by circumstances, Governor Philip sent a branch Colony to take possession of Norfolk Island, a sweet and fertile spot, about the size of a band-box. Here starvation soon stared them in the face; and had it not been for the arrival of large flights of aquatic birds of the goose species, they would not have had a feather to fly with. Sometimes they took 3,000 birds in a night, eggs and all, warranted. Much has been written and read about geese saving the Capital; yet, surely these were far more capital geese. It has been remarked by ornithologists that these birds came to lay their eggs; and found a difficulty in reascending on account of the length of their wings; but we think that the counter exertions of some hundreds of starving stomachs will very sufficiently account for any difficulty the birds found in reas

In this situation of affairs, arrived the second Fleet; which for tunately lost 194 males, and 4 females on the passage; we say, fortunately, because it was better to die with scurvy on board, than to drag on a lingering existence midst starvation and scurvy treatment on shore. Hercules achieved a vast number of labours; and also did Governor Philip; but both sunk under their weight at last; and the Governor in 1792, was obliged to return home for the benefit of his health, and we hope for the benefit of the Colony. The estimation in which he was held, and the sorrow manifested at his departure, are fully represented in the following distich, which he discovered in the crown of his hat the day after he set sail.

VARNHER'S ELECTRO-VOLTIGEURIC-INWISIBLE-VIRLPOOLIC-SKI-HI BATTERY.

Report of our own Reporter.

"From the earliest dawnings of policy to this day, the invention of men has been sharpening and improving the mystery of murder, from the first rude essay of clubs and stones to the present perfection of gunnery, cannoneering, bombarding, and mining."—BURKE.

The bills inform us that the engagements of Mr. and Mrs. Coppin, and Mr. Morton King are on the eve of termination. This we regret, the more so as we do not find that any arrangements are in train for re-engaging other favorites whose absence from the theatre is a source of regret to its patrons.

Music and Musicians.

In lately adverting to the too-prevailing dulness in musical circles, we noticed the obligations which the dilettanti were under to the excellent band of the ninety-ninth regiment, whose weekly per-formances in the Domain are really the only public offerings at Music's shrine which are found in Sydney. A few remarks on this head may not be out of place just now, and is but a due

There is considerable praise due to Mr. Martin, the talented master, for the great care he must have taken to accomplish so perfect a union of sweet sounds; every instrument in his band speaks, as it were, to the judgment as well as to the ear of the listener, which seems to verify the Rambler's assertion that, from the proper disposition of single sounds results that harmony which adds force to reason, and gives grace to sublimity; that shackles

attention and governs passion.

The master of a military band has greater responsibility attached to his situation than is generally conceived; he has not only the separate teaching and drilling of every instrumental performer in his band—to make him play in tune, in time, and with that precision, and expression of light and shade so essential to qualify him to join in part music, but he has also personally to officiate in the double capacity of both conductor and leader. For the information of those who may be unacquainted with the distinction be-tween a conductor and leader we can only compare the situation of the former to that of a physician, and the latter to that of a

The office of conductor is to arrange, order, and direct the necessary preparations for a concert; to superintend and conduct the whole performance; to give the time, character, and style of the several movements to the leader who communicates them to the rest of the band. The conductor presides at the Organ or Pianoforte, and so situated, that the leader may without impediment, catch every look and gesture. On the Continent the conductor generally stands with a white scroll in his hand—not to violate every sense of good feeling by flourishing it with the most authoritative air of timely consequence over the heads of talented performers, (these are the sutores ultra crepidam, the mere pecus Alcinoi and the like) but to assist the leader in his arduous en-deavour to keep a uniform agreement in the orchestra, by waving his scroll as a signal for Crescendos or Diminuendos, Pianos or Accellerendos, or Rallentandos, for the flourish of Trumpets, or roll of Drums; or, as a signal for any instrument to cease playing, or to re-commence after so many bars rest, &c., &c.

The office of leader after the conductor is certainly the most mportant station in the orchestra. It is to him that the rest of the performers look for direction in the execution of the music; and it is on the steadiness, skill, and judgment, and the attention of the whole band to his gestures or motions, manner and expression that the concinnity, truth, and effect do depend. The leader in the orchestra of a theatre or concert takes the principal violin: the movement of his bow and his mode of bowing is attentively watched by the performers as signals for every accent, style, and character of the music; but in a military band the master, acting as both conductor and leader, takes the principal Ga-ionet or Hautboy. Mr. Martin, the Bandmaster of the 99th, takes this instrument, and it is the clear and expressive into-nation he produces which speaks the style and character of the music to every performer in his band. The possibility of this mode of conveying feeling and expression from a musical instrument in the hands of a talented professor cannot be questioned from the number of well authenticated instances on record. The Ashantees declare they can converse by means of their flutes. Bowditch, in his mission to Ashantee, avers that an old resident at Acera assured him that he heard their dialogues, and that every sentence was explained to him. Nathan, in his "Musurgia Vocalis," says "a certain Spaniard, one night late, encountered an Indian woman in the streets of Cuzeo, and would have brought her back to her lodgings, but she cried 'for God sake, Sir, let me go, for that pipe, which you hear in yonder tower, calls me with great passion, and I cannot refuse the summons, for love constrains me to go, that I may be his wife, and he my husband." In the Island of Bissao, on the Western coast of Africa, they have an artificial language exclusively for persons of rank and fashion; this is an iron ring, upon which they ring the changes with a piece of iron, so as to converse with as much facility, by means of the different sounds produced, as if they used the most polished language. At Canton, Huttner declares he was surprised by an Opera being performed there, consisting of recitations, and airs so expressively sung, that the whole of his party though ignorant of the Chinese language understood, in some measure, the meaning of the words, owing to the excellent imitation of the different accents And he further declares, that their expression was so exquisite, that it fully painted to his imagination all the power and influence over the passions attributed to the music of

the ancients. The Abbé Morlet, in his ingenious pamphlet "On musical expression and imitation," says, that music executed by the same organs with which the language is spoken, and aiming at the same sense becomes itself a language. We may thus clearly understand how an able and talented professor, may in his office as conductor and leader convey to the whole of his well taught band, every accent, style, and character of the music they are performing—by the mere expressive tones of his Clarionet. Mr. Martin does this, and to those of our readers who desire a delightful musical treat, we recommend a stroll in the Domain on Thursday.

LEGISLATIVE COUNCIL.

PORT PHILLIP FINANCIAL SEPARATION.

Mr. Robinson, in pursuance of notice, moved "That it is the opinion of this Council that the whole of the revenue derived from the district of Port Phillip should be specially appropriated for the service thereof." In asking the Council to affirm the resolution now proposed, he only asked for justice to that district; it had contributed to the land fund, from its foundation to the 31st July, 1844, £427,000, and to the general revenue £317,436 16s. 7d., and taking the average population at 13,000, it was a total taxation of £7 5s. 2d. per head per annum, which was unparalleled in any of the British colonies. There was at present due to the district, on account of the land revenue, £176,000; and after defraying all the outlay consequent upon its foundation, paying the whole expenses of the Government since that period, there would, at the commencement of the ensuing year, be a balance due to the district of £1200. The estimated expenditure for 1845 was £44,748; the estimated general revenue, £63,780; leaving a balance in favor of the district of £19,031. It was in order that the latter sum might be appropriated to the necessary works within the district itself, instead of the Sydney district, that the present motion was made. The balance of £176,000 before mentioned might be set off by disembarking at Melbourne a larger portion of the immigrants who were to be brought into the Colony than would otherwise fall to the share of the district. The district had been and still was suffering for want of labour, and it was even yet fifty per cent. dearer than in the district of Sydney. A notice of an amendment had been given, the effect of which was to give all other districts in the Colony that which was claimed for Port Phillip; but no other district afforded a parallel. In the petition he had presented the case was fully made out, and he begged to call the attention of the House to the facts stated therein. The claim made by the petitioners appeared so just and equitable, that he was at a loss to imagine how it could be denied.

Mr. Young seconded the motion.

Mr. Windexer thought it only necessary to meet the statements made by the honorable member for Melbourne, by proposing that the same measure which he proposed for Port Phillip should be carried out for every district in the Colony. It was no argument to state that so much revenue had been raised in a particular district, and therefore it ought to be expended there. If such a statement were admitted as conclusive argument in favor of the claim of Port Phillip, Yorkshire and Lancashire might with equal justice cry out for separation from the other counties of the mother-country. It would be enough to them that Liverpool, in Lancashire, contributed more to the revenue than was contributed by any other county except Middlesex, to entitle that county to be separated financially from the rest of the mother-country. All countries in the world were necessarily made up of portions, some of which, by a happiness of position, or other local advantages, were enabled to contribute more to the general revenue than others that were less favoured; and it was not on this account that they were to be separated, and set up as independencies of themselves. There were higher and more important interests to be regarded. It was of the highest importance to our welfare, and that of posterity, that we should form one united community. This Colony had hitherto been able to command but little atten-tion on the part of the Home Government; but if it was split up into portions, its representations would have still less weight—as into portions, its representations would have still less weight—as little as those of single parishes in England. He considered that no injustice had been done to Port Phillip, and all that district ought to ask was for a fair distribution, in conjunction with the other districts of the Colony, in proportion to the population, from any surplus public funds. He would therefore move, "That it would be just and expedient that the balance of the revenue of the Colony, after providing for all objects of general concernment, should be distilled among the consequence of the Colony in should be divided among the several districts of the Colony, in proportion to their population, to be applied to such local objects as the said districts may severally require." He was not desirous of pressing this amendment, if any other more desirable course could be pursued by which the original motion might be met or got rid of.

Dr. BLAND seconded the amendment. The COLONIAL SECRETARY moved the previous question. The COLONIAL TREASURER seconded it.
Mr. LAMB and Major WENTWORTH supported the motion. Mr. WALKER, Dr. Nicholson, and Mr. Boyd, supported the original motion, and the question being put the division was as
