THE COLONY AND THE COLONIAL OFFICE.

Our readers will bear in mind that, in our article of last week entitled, Colonial Loyalty, we proved that the knowledge of, and time devoted to, the affairs of each Colony, is in an inverse ratio to the power of influencing its destinies for good or for evil. The power of the Imperial Parliament, which stands at the apex of the pyramid, is infinite; its knowledge and attention nearly nothing. Lord Stanley's power is very large; his knowledge and attention very small. Mr Gardner's power is considerable; his knowledge and attention inconsiderable. Thus we find every increase of power compensated by a corresponding decrease of knowledge, and every increase of knowledge by a corresponding decrease of power. It has been laid down by every writer on Government, from Aristotle to Bentham, that, in a ruler, wisdom and power should be combined. How can we, then, sufficiently admire the perverse ingenuity of a system, which not only does not provide for the combination of these two indispensable elements, but seems to consider the presence of the one a sufficient reason for the absence of the other. The maxim of the Colonial Office seems to be,-those who have knowledge must have no power; those who have power must have no knowledge. Sight and bodily strength are useful together, useless apart. "Therefore," says the Colonial Office, "by all means separate them: let those who can see be weak; let those who are strong be blind." Thus will the least possible quantity of service be extracted from the greatest possible quantity of functionaries. What wonder if the results of this system are the same as those described in the ancient epigram: that the blind are obliged to carry the weak; that the powerful Colonial Secretary is forced to carry on his back an Old Man of the Sea, in the shape of Mr. Under-Secretary Stephen, whom no effort can enable him to dispense with. We pointed out, last week, how the superior knowledge of the lower functionaries drew after it that power which it never was intended they should exercise; how Lord Stanley became the tool of Mr. Stephen, and Mr. Stephen the tool of Mr. Gardner. We have still left two points to inquire into: the first is, through what channel does Mr. Gardner obtain that information about the Colony, wherewith he irrigates the brains of his superiors; the other, what is the true estimate of the position of a Colonial Governor. The information which Mr. Gardner derives is almost entirely through the Governor, who, during the first half of his administration, generally lacks the power, and during the last half the will, to give a faithful representation of the affairs of the Colony. He has his experience to acquire, like other men; but, unlike other men, he is expected to give the results of that experience before he has acquired it. Thus he is necessarily led into many errors and misstatements, which, unless he be a person of a very different order of mind to our present ruler, he will never correct or recal, but which, on the contrary, as often as they are called in question, he will endeavour to bolster up by other misstatements and fallacies, till at last he forms a system false in its data, and ruinous in its conclusions, to which he is irrevocably committed, and which he feels bound to support with all the obstinacy and ingenuity he is possessed of. This furnishes, we believe, the true reason of the perverse wrongheadedness of our rulers.

They are called upon to write before they have thought, and to state conclusions before they have acquired premises These groundless conclusions, vanity and self-interest forbid them to abandon, and thus they become, not means of informing, but of misleading, the Colonial Office. The object of a Governor is not so much to say that which is true, as that which is agreeable to the Office and creditable to himself. He is a party interested. All discontent and miscarriages will be sedulously extenuated; all successes and compliments as sedulously magnified. His friends will be extravagantly praised; his enemies unreasonably blamed. The power of libelling without publicity and without contradiction, will be unsparingly exercised; and thus most irreparable injury done to public men and public bodies, by presenting, precisely in that quarter where they are calculated to do most mischief, statements which their author dare not make before those who have the power of contradicting them. We have not forgotten that, when the Governor laid on the table of the Legislative Council those infamous dispatches to which Mr. Stephen or Mr. Gardner, we know and care not which, had done Lord Stanley the irreparable injury of attaching his name, His Excellency shrunk from producing his own dispatches in full, but only gave the Council a garbled extract, carefully omitting several parts to which Mr. Gardner's dispatches referred, and upon which they profess to be founded. Such is the information-we were going to say, the sole information-upon which the Colonial Office acts; but we remember that it is competent to the Colonists to transmit complaints to England through the medium of the Governor. He can assail them without the possibility of explanation; they can only attack him in a way which enables him to extract the sting from the accusation at the same moment as it is preferred. Thus is Mr. Gardner's mind (for why should we keep up the humbug of speaking of Lord Stanley) open to the Governor, and hermetically sealed to all the world beside; or thus, in other words, are all channels of information, except the most questionable and least trustworthy, completely shut out from the Colonial Office. What wonder that such elements, filtered through Mr. Gardner, should form a noxious compound in the mind of Mr. Stephen, and be sublimated into rank poison by the time they reach Lord Stanley?

We have next to enquire, what is the position of a Colonial Governor under this system. The answer is, we regret to state, plain and obvious—one of the meanest imaginable. Were the British Colonies really governed by the Colonial Minister, and were that minister really responsible to Parliament, the Governor's position would pretty nearly resemble that of any other unparliamentary secretary, with this difference, that his remote position implies a greater confidence, and the absence from the Colony of any official of higher rank causes him to be surrounded with a parade, and treated with a ceremonious respect, to which his masters, whether clerks, secretaries, or ministers, are utterly strangers. Stripping him, however, of this gaudy and adventitious plumage, what is he but the deputy of an obscure and irresponsible clerk? Between him and the minister, to whom he is theoretically responsible, a great gulph is fixed; the offices, namely, of Messrs. Gardner and Stephen, which the paper wings of his dispatches have seldom buoyancy enough to fly over. To these functionaries, or rather to the lower of the two, he must account for his measures; his orders he must obey, his crotchets he must carry out; at his frown he must tremble, at his smile he must rejoice. There may have been men who from intrinsic magnanimity, from independent fortune or parliamentary interest, have risen above these miserable influences, but our Governor is none of these. He looks forward to obtaining another government, and to that end he must conciliate the good will of Mr. Gardner. Let those, then, who will, bestow upon a functionary so situated that loyalty which they owe to their sovereign; we have learnt to be more charv of our veneration, and when we want a golden image before which to fall down and worship, we shall not seek it among the depositaries of trebly delegated authority.

In the list of General Grievances adopted by the Legislative Council, there is no point which has been more contemptuously treated by the Head of the Local Executive, more cordially denounced by the alarmed selfishness of the Treasury Bench, or more loudly clamoured against by the "men of moderate principles," than that passage in which a request is made for Responsible Government in the sense in which it is understood in England.

Now in spite of the noise raised by a very few silly fellows like our Camden friend, whose misconception springs from timid imbecility, we are convinced that the good sense of the public will have acknowledged that the request for some control over the Acts of the Local Government is neither unconstitutional, nor unreasonable, nor unfair; and this allegation we shall endeavour to prove by establishing the following propositions :-

- 1. That every free British subject, resident in the United Kingdom, and possessing the elective franchise, can exercise a direct influence in the matter of his own Government.
- 2. That this direct influence remains, as a matter of right, in the person of himself, or his issue when resident in any plantation within the British dominions.
- 3. That there is nothing in the present condition of the Colony of New South Wales which ought, in a constitutional point of view, to annul or suspend the exercise of such inherent privilege of influence over Government.
- 4. That the exercise of such influence, nevertheless, has been, and still is, virtually suspended in this Colony.
- 5. That, consequently, it is to be required that the Government should be subjected, in so far as the customary and constitutional practice in England extends, to the influence of the people as exercised through their Representatives.
- 1. The first position for which we contend, namely, that the people of England do exercise a direct influence in the matter of their own Government, need not detain us long, for it must be admitted as a fact. The constitutional history of England, more especially during the last 250 years, is little else than the history of the struggle of the people to acquire and maintain a control over the various administrations which have governed them in the Royal name, and, in a greater or less degree, under the personal interference of the Sovereign. We allude not now to the various desultory efforts made to wrest from the Plantagenet and Tudor princes a portion of the power which they irresponsibly wielded. For, in effect, the result of these efforts was little more than to transfer state influence from the hands of royalty to the grasp of a selfish oligarchy of Barons. But it may with great precision be affirmed that the popular movement towards that liberty, nay that positive control of Government, which in this our generation we claim as a birthright, was commenced during the reign of the first Stuart. Then it was, that the mind of man, so long depressed by subjection, began to feel its active powers. The spirit of inquiry shook off those incumbrances which had hitherto retarded its flight and fixed it to the earth. The strange and convulsed periods of Charles I. and of Cromwell, the momentous struggle which ended with the abolition of the Stuarts and the establishment of the house of Orange, and, in particular, the political retrospect of the reign of William, present to us, as observers of the march of popular freedom, one all-pervading and memorable result. These revolutions would scarcely merit the inquiry of posterity had they not established, on the given basis of constitutional law, the fact of the ultimate appeal lying with the People Exalted high above the ephemeral conflicts of party and the fury of fanaticism, we of the present day may perceive an eternal principle which, under similar circumstances, might produce similar effects, namely, that the voice of the people. when constitutionally raised, has been before, and ever will be,

PREDOMINANT. Perpetually thankful should the British race in all successive generations be, to that hardy band of philosophers and statesmen who laid the eternal foundations of so vast a truth. Around the memory of these "fathers of their country," Harrington and Sidney, Milton and Locke, Pym and Hampden, Eliot and Vane, an undying glory smiles. They are those who warred with time and grappled with prejudice, who gained the mastery over custom and rolled the stone from off the tomb of buried liberty; who framed and enunciated opinions which it has been beyond the reach of

It is trite to express, but necessary to bear in mind, the mode in which in more modern days the people of England exercise this inherent privilege purchased for them by the struggles of departed patriots. It has not been thought necessary during the last century to keep in full force all the provisions of the Act of Settlement of William III., and more particularly that clause whereby it is enacted, that "no person who has an office, or place of profit under the King, or receives a pension from the Crown, shall be capable of serving as a member of the House of Commons," or even the clause which asserted the responsibility of the Privy Council, by requiring that every resolution of that Council should be recorded and signed by the Councillors present. It has been thought sufficient to adhere to the practice which has now acquired the fixity of custom, and which, perhaps most conveniently asserts the paramount power of the Representatives of the people. We of course allude to the custom of the Ministry resigning office, whenever, upon any matter of public interest, they fail to obtain a majority of votes. Such being the custom, the real power may directly be said to vest in the people themselves as they choose the members who permit that minority only, to be near the Royal person, which is agreeable to the Commons. And this control would doubtless be more immediate and efficient if the Triennial Act of William III. had

(which it ought to have) the force of law.

2. Such then being the undoubted right of every British subject having the elective franchise, and resident in the United Kingdom, a right of personal control over the Government, it is next to be shown that this right is inherent in himself and his issue in any and every portion of the British dominions. Now we cannot conceive the possibility of any rational person seriously disputing this. To assert that the rights of civil liberty, or any of them are connected with questions of locality or geographical limit is to transgress one of the fundamental laws of human reason; for it is to confound in the same category, things physical and metaphysical, to make a mental privilege subservient to a bodily residence. To attempt to bind by rock, and to circumscribe by seas, the virtue and efficacy of a British subject's political immunities, is a thought worthy only of the darkest days of capricious tyranny. And accordingly the law, in this instance if in no other the "perfection of reason," has explicitly declared, that a Briton, no matter in what part of the Empire he may reside, carries with him in his own person, the constitutional rights which lawfully appertain to him. As in ancient times a man might reside a thousand miles from the imperial city and still enjoy all the prerogatives of a Roman citizen, so does an Englishman, though migrating to India, Canada, or Australia, bear with him individually the results of birthright.

3. But is there anything in the peculiar constitution of this Colony, that should bar the recognition of these rights of Self-Government which we inherit from our British ancestors, and which we have carried with us in our persons to this extremity of the globe, or which, as the children of immigrants to this soil we receive from our fathers? Is it because we reside, or because our parents have chosen to reside in New South Wales, that our liberties are to be abridged, and that we are to be for ever denied any voice in the administration of our internal affairs? We emphatically assert that such an abrogation of rights is equally illegal and impolitic, and that there is not a shadow of reason whereon such a wholesale edict of deprivation can be based. For how stands the case which thousands of our fellow-colonists do most earnestly and rightfully com-plain of? Here is a Colony, purely of British origin, and which has never ceased to be an integral part of the Empire of Great Britain. For a long period of time past, emigration from England to these shores has been expressly encouraged by the Home Government, and, in consequence, a very large majority of the colonists consists of free British subjects who have, with the knowlege and consent of the Crown, transferred their residence from some part of the United Kingdom to some part of the territory of New South Wales. Shall it be said that these persons lose their rights of Self-Government by the circumstance of passing over the sea? Are they to be governed irresponsibly and despotically because they cho reside in a part of the British dominions which is not England? Minime gentium!

But it will be said that we live here in a convict Colony, and that this penal peculiarity places it without the pale of English national rights. It will be averred that hence arises an argument ex necessitate rei, which is fatal, as far as this territory is concerned, to the recognition of British privileges. It seems sufficient, in reply to these superficial cavillers, to request them to remember that certain political rights are under no circumstances separable from free members of the body politic, and that, if this community were carefully classified, a very small minority would, with justice, come under the truly be complained, not only that a large number of free persons who have emigrated hither, are debarred from that greatest bulwark of freedom, a control over their local Government, but that this right is denied to all of the many individuals duly qualified in other ways, who have passed through the period of probation legally allotted to them as a punishment for crime; and who, that punishment having been endured, revert to their original position in the eye of the law, and have as great a claim to all British privileges of birthright as the strictly free inhabitants of the Colony. We deny that there is any force in the objection that this has been a penal settlement. For if the Imperial authorities had wished to exclude all claim for British rights, they should have strictly kept it as a large prison; they should have maintained it as a residence merely for persons actually suffering the sentence of the law; they should have refrained from throwing it open as

have avoided laying it out as one of those nursery grounds of the earth, where the British language, religion, laws, rights and immunities might take root, and flourish to the end of time. Already the penality of New South Wales has become a tradition. Let our English Parliament cease to be frightened at the bug-bear of the past, and at once concede those liberties which, in spite of defamation, it may be said that we have too much intelligence, too much thoughtfulness, and too much morality to abuse, but which we have too much British independence and spirit ever to cease asking for, until the boon is granted.

4. For the fact is undeniable, not merely that the Colonists of New South Wales are debarred from the exercise of that control over their Government which is possessed by their countrymen elsewhere, but that they are in truth governed, as respects all their internal affairs, by authorities resident at the Antipodes, and who act, with regard to this community, through the medium of an overseer, whom the governed are compelled to pay, and who as far at least as the present holder of that office is concerned, is the obsequious instrument of that particular clerk in the Downing-street office who has charge of the Australian Colonies, and who has the use of Lord Stanley's signature just in the same manner as a merchant in his counting-house uses a brass stamp to seal his letters with.

This part of the case is well stated in the Grievance Report (page 8).

The utter state of pupilage in which the Governors of our Colonies generally are now held, by that necessity for constant reference to Downing-street, which is imposed on them by their instructions; and the public inconveniences and mischiefs that accrue to the Colonies in general, from the distrust thus evinced on the part of the Home authorities of the ability or inclination of Governors to use that local knowledge which they possess, or acquire with due judgment and discretion, if attended with practical and serious evils in Colonies at the other side of the Atlantic, cannot but operate with aggravated injury in a community situated as we are, at the distance of half the circumference of the globe from this seat of imperial reference and power.

Nor is it the least evil of this system, that itrenders the term "Governor" a practical misnomer, and constitutes him who ought, in fact, as well as in name, to be the Queen's representative, fully armed with all the powers delegated to him by the Royal Commission, a mere subordinate officer; and what is worse, as far as the moral influence of his station goes, a mere imperial officer, possessing on the one hand, in reality, little or no discretion in the wide range of administrative powers from their inability to separate those measures which are of his origination from those which are not, accountable, on the other hand, for the whole of the mischievious policy of which he is the apparent author.

To suppose then, under such circumstances as these, that the representives of the people possess the smallest amount of real power, is manifestly to adopt a perfect fallacy. The exclusive management of the internal affairs of the Colony by an Executive irresponsible to the governed as repects its local head and officers, whose salaries are permanently secured by an exorbitant civil list, deprives the people of the smallest shadow of true freedom, robs us of our peculiar rights, stamps us as the victims of a heartless despotism, and proclaims an experimental "Constitution" to be "a delusion, a mockery, and a snare."

5. What then, and are these things so? Is the privilege of control over those who govern us a sacred and inalienable birthright? Do we carry with us this right into every Colony of the Empire wherein we choose to fix our abodes? Is the spirit of Anglo Saxon freedom unchanged by our voyage across the Pacific and the Atlantic? Do we feel that there is nothing in the condition of New South Wales which should abridge or invalidate our customary claims? And yet are not these rights abrogated, stifled, and held up to scorn? And shall we not agitate? Shall we be restrained from knocking perseveringly at the door, by reason of the frowns of arbitrary power, the alarmed hostility of placemen, and the pulings of "men of moderate opinions," dupes of their own stupid conceit and mental imbecility? No doubt it will be said that the end we seek is distant and precarious of attainment. Truly, the task is arduous. Indeed when we recollect the tedious and multiplied difficulties which have always attended the accomplishment of a great purpose, the chaotic mixture of the social elements in this Colony, acting by opposite efficacies; when we consider the animosities of individuals in whose breast a vindictive remembrance still rankles, when we think of the pecuniary distresses of the times which tend to disunite the bands of public confidence; above all, when we contemplate the oftenproved aversion of this community to all political enterprizes. the "deadly mildew" of a circumspect and qualifying despot-ism; when we estimate the influence of an established government, and that pernicious waywardness so epidemical in all colonies and countries among the sons of men, by which they are led to defend the very authority that oppresses them, and to become the active instruments of their own servitude; when we meditate upon all these things, we cannot but at times admit a fear lest we fail in gaining those privileges which are the proper right of every Briton, which are the vigorous growth of the better part of our nature, which are inherent and inalienable, and to the exercise of which a free man's conscience tells him that he is born no less than to the

exercise of his moral and intellectual powers.

But our battle is a strong one. The cause is good, nor is it without champions to set forward positive rights by honest and powerful exertions. The men who wage this warfare on behalf of the Colony are not likely to give way before the peremptory insolence of a tyrant, nor yet to be outwitted by the insidious manœuvres of ministerial legerdemain. Far less will they pause at the outcry of waiters upon court favour, the weak and silly fools who are entranced by the cuckoo note of "moderate opinion," a set of beings who are the everready tools of arbitrary workmen, a class of persons easily duped, patient of domination, solicitous of contumely, zealous in the proportion in which they are scrutinized, and whom nature hath not condescended to qualify for the luxury of independence.

The only passive obedience which shall then be known to us, is that which we pay to our country's laws. Wherefore? "Legum ideirco servi sumus ut possimus esse liberi."

THE STATE OF THE PUBLIC REVENUE.

In a recent number of this journal, we briefly adverted to the returns relating to the Revenue which have been just published in the Government Gazette, and called the attention of the Colonists to the serious falling off, as compared with the previous year, which they exhibited. The total income for 1844, including receipts of all descriptions, amounted to £249,057, (showing a decrease of upwards of 15½ per cent. below the income of 1843); and when we remember that the estimated expenditure of the Colonial Government was calculated at no less a sum than £266,875 2s., it will be allowed that an examination and exposure of the probable expedients which must be attempted by the Government to maintain its various departments, and defray its extravagant expenditure, will afford the Colonists the best instruction in respect to the manner in which they are taxed, and the sagest lessons to those legislators who are entrusted with the charge of the

people's money.

Whilst deeply lamenting the sufferings inflicted by that revolution whereby the Colony was plunged from the height of commercial prosperity and confidence to the extreme of depression, we always felt perfect reliance on the elasticity of the industry of the Colonists; and this reliance was grounded on the obvious fact, that the evils did not arise from overproduction at home; for the English export markets were rather insufficiently supplied than encumbered with our staple produce. Our predictions have been fully realized, and the rapidly increasing demand for our wools has operated in producing an adjustment which must soon restore to full activity the prosperity of all our great wool-growing districts. The state of the Public Revenue can therefore be discussed without any very oppressive fears in regard to its present unfavorable aspect.

The consideration of a falling revenue is usually accompanied by calculations of consequent taxes laid on industry, restrictions imposed on commerce, and other expedients for replenishing the exhausted exchequer; but such calculations ought not to be encouraged by the Legislature of New South Wales until the principle of RETRENCHMENT has been firmly established in every department of the public service. Re membering the promises of economy so pompously set forth and vaunted on the occasion of the Governor's presentation of his first financial minute to the Council—promises glaringly violated or forgotten—the recently published Abstract of the Revenue urges the Colonists to fully consider all His Excellency has done, all he has promised, and all he has prevented or neglected—urges them to try his administration by the severe test his financial budget enables them to apply, and to inquire how far practices and professions accord; how far expectations have been realized, and the Colony improved. The abstract of the estimated expenditure for 1845 is the best proof of the economy of Sir George Gipps. It was calculated, as we have just said, at £266,875 2s., and that in spite
