habited the forfeited dwelling of a burgess who had been killed in the great Dragonnade of 1685. Supposing that the tones proceeded from a religious assembly in the town, the archpriest ordered out his soldiers; but they found it impossible to quit the ordered out his soldiers; but they found it impossible to quit the mansion, already invested by the mountaineers, who demanded the surrender of the prisoners. "Begone!" replied Du Chayla from a window—"Begone, you Huguenot rabble!" and upon their refusal the soldiers fired and killed one of their number. Upon this they became furious; seizing the trunk of a tree, which was lying along the wall, they swung it like a battering ram and broke a hole in the door, which they then cut away with their axes. They rushed into the vestibule, forced the wicket of the dungeon, and delivered the captives. At the sight of these ill-used persons. delivered the captives. At the sight of these ill-used persons, whom they found in a state of great suffering, their rage increased, they rushed to the staircase and demanded the archpriest himself. A priest whom they mistook for him, fell mortally wounded with a halbert; Du Chayla, seeing himself in extremity, gave absolution to his people, who still defended the staircase. One of the assailants had his face grazed by a ball, when the prophet shouted aloud to "burn the priest and satellite of Baal!" In a few minutes the house was in a blaze; its inmates retreated to an upper room, whence they tried to escape by means of a rope formed of sheets twisted together. The archpriest first attempted to slip down into the garden, but fell and broke his thigh, and was only able to crawl under a hedge, where he was soon after discovered and slaughtered. The others let themselves down after him and fled across the Tarn. Such of the soldiers and domestics as were caught were instantly put to death, with the exception of two for whom the prisoners interceded.

The fanatic Seguier, relentless as Du Chayla himself, had resolved upon a general massacre of the priests, and he hurried from one point to another, surprising and slaying them whereever he could, and destroying on his way the churches, the crosses, and all the insignia of Romanism. Having learnt that all the clergy of the neighbourhood were gathering at Saint Germain de Calberte to celebrate the obsequies of the archpriest, who had there his library and his principal residence, Seguier hastened in that direction, and would have given a bloody funeral to his enemy; but, on approaching the place, he heard that it was guarded by the militia, and he did not venture to attack it. In the meantime, the assembled priests were listening to Louvreleuil, the curé of St. Germain, who in an eloquent sermon, extolled the virtues of his superior, and exhorted his brethren to die, if necessary, at their posts, like the illustrious deceased. At that moment a cry was raised that the insurgents were upon them; that fire and sword were at Frugéres-at St. Maurice-at St. André! The body of the archpriest was hastily consigned to its tomb, and the assembly, in great consternation, dispersed and sought shelter where they could.

Seguier still proceeded in the execution of what he called "the judgment of God." Going to the Château of Ladevèze, he demanded the arms which had been deposited there. The lord of the mansion replied by sounding the alarm-bell, and firing upon the party, one of whom was killed, and several wounded. Upon this the prophet forced the gates, and ordered

a general massacre.

The whole of the family perished—the lord, with his aged mother, his sister, his brother, his steward, and his servants.! The assailants then retired, after having set fire to the house.

But the end of their daring leader was at hand. The powerful relatives of Du Chayla, and the whole noblesse of the Haut Gevaudan, with their followers, took the field to avenge his death. Broglie speedily arrived at Pont de Montvert, and despatched against the insurgents a certain Captain Poul. a military adventurer of extraordinary prowess, lately tested in a partisan warfare against the Vaudois. With his warlike mien, his austere habits his long and heavy Armenian blade, and his Spanish horse, Poul was the admiration and the terror of the mountaineers. He attacked and routed them at a place called Fontmorte, and captured the prophet with his own hand, while endeavouring to rally the fugitives. "How do you expect to be treated?" said the unfeeling Poul, escorting his prisoner in chains to Florac. "As I would have treated you if I had taken you," replied Seguier. He was sentenced to lose his right hand, and to be burnt alive; and this punishment he underwent, firm and triumphant to the last, at Pont de Montvert, within less than three weeks from the day of his success on that very spot. Broglie now supposed the insurrection to be at an end, and after punishing the relatives of those who had taken part in it, he returned to Alais, leaving Poul with some companies of fusiliers to occupy the villages of the Higher Cevennes.

The insurgents wandered among the hills, dejected and irresolute and considering how they might escape out of France, when they were joined by one Laporte, once a soldier, but now a dealer in iron; a man of resolute character, endowed in the highest degree with those prophetic gifts which were all in all with the fanatical pesantry. He persuaded them to give up all thoughts of leaving the country of their ancestors, but declared that it must no longer be a land of slavery and death, that all the priests of Baal must be exterminated, and the temples of the Almighty must be reared again. "The Lord of Hosts," said he, "is our strength. We will sing the psalm of battles, and from Lozière to the sea, all Israel will arise. As for arms have we not our axes? they will get us muskets:" and he instantly led them to disarm some Roman Catholic villages. The band was speedily increased by recruits from the Vebron, and from Nismes. Among the latter were some young men by whom the Baron de St. Cômes, a noted renegade and oppressor, had been assassinated upon the highway, the very day after Seguier's execution. In a few days Laporte was at the head of one hundred and fifty men, with the prospect of a great addition when the vintage and the clive harvest should be over. He styled himself "Colonel of the Children of God," and his camp "the Camp of the Almighty," and with these lofty pretensions he bade defiance to King Louis and his armies.

To be affected by galvanism, it is necessary that the part to be galvanised should lie between two opposite galvanic poles or extremities; now as the finger is inside the ring, the galvanism is outside the ringer. Thus, the finger is to the galvanic fluid as a person standing on the Isle of Dogs is to the fluid in the Thames. With what power an inappreciable force, ineffectually applied to the extremity of the body, must act in the cure of such a com-plaint as rheumatism, is obvious. In all positive diseases the Galvanic ring will afford a negative relief; and those who have nothing the matter with them may confidently depend on being cured by it.

THE BANKS AND THE JURY. Doth not a meeting like this make amends? MR. ATLAS-The heading of this article I admit, has something

I replied, that at the time, the Jurors thought it not only insulting, but unjust; but as the

consideration which it involved, was so very trifling, it had long since ceased to occupy their thoughts. We parted, and at a subsequent period I communicated the opinion thus accidentally

received, to Mr. Falconer. And, I am here free to confess, that honest, to act as the Rev. W. G. Ward has done, and go over at am guilty of the slightest breach either of confidence, or of correct duty, by giving it a prominent place in a statement intended for public opinion, such as this. Mr. Falconer not only assured me, that my intimation was the first which had reached him of the transaction, but with much earnestness of manner, disavowed on the part of the Bank all participation in it;—said, that up to that moment, he had laboured under the belief, that such Juror had received the sum of one guinea per day, from the funds of the Banks—irrespective of his claim on any other; asked me why I had not sooner made known our complaint, adding, that it was one of such a character, as called for immediate reparation; or, words to that effect.

Such honest and well-regulated sentiments, while they stand a

rustful pledge for the fulfilment of public faith on the part of the bank, and are in wholesome keeping with the manager of such an establishment, cannot, at the same time, prove very complimentary to those who were instrumental in carrying out this affair. H was requested by Mr. Falconer to call again. I did so; but in the mean time the transaction had been brought before some of the Diectors, and through whatever phases it had passed when there, its already forbidding features had contracted another frown. It came out with a sine qua non appended to it, one the most fatal to its success—that of Mr. Gurner's assent. I saw that they were about to place me in the hands of my old friends again, and thought the wisest thing I could do, was to find my way to the steamer as quickly as possible. On reaching home, I wrote a short letter to Mr. Gurner, calling his attention to the result of my interview with Mr. Falconer, and at the expiration of nearly ten days, I received a very laboured and verbose reply, abounding in quaint and technical precision, and, in a good deal of what I should call professional fudge! but pitiable in its struggles through the mist of error to free itself from entanglement. As was anticipated, the assent was refused, the five jurors, minus their twenty-five pounds, as be-fore. We attempt not to explain the Siamese union, which appears to subsist between these two establishments. The Bank of Australasia has now repudiated the acts of its agents. There is a "dream of the past" brought home to us in these words. We "tread on haughty Spain." Let us now see what is the simple fact at issue. The solicitors to the banks took upon themselves the onerous and self-created duty to withhold from five country jurors, on the late trial at bar, the sum of 5s, each per day, from fund placed in those solicitors' hands by the banks, on the plea that those jurors had a claim for a like amount upon the Government. This is precisely their own case, and I shall give them battle with their own weapons. That there was a fund of one guinea each per day, unfettered by restrictions, abridged by no exceptions, placed at their disposal for the TWELVE, will scarcely dare to be denied. And now, Mr. Solicitors, I would ask you, way has country Jurors this claim of five shillings per day upon the Government? Simply to lift them on the common platform of JURY BQUALITY, nothing more !---to make Sydney their home---to transmute them as it were into town Jurors for the time being-into that very class of persons, whom you have thought worthy to receive at your hands the sum of one guinea per day, while those five men have been paid with that of sixteen shillings!! I forbear to make one intemperate comment upon this transaction, further than perhaps to say that, exposed as those Jurors were to expenses which covered ble the amount of this paltry five shillings claim—to absence from families, and to losses and privations from all of which town Jurors were exempt, I feel that the act stands at this moment one more prejudicial to the "fair fame" of those solicitors, than it is to the pockets of the injured parties. The banks never would have extended their liberality, did they not intend that an equality of claim should form the basis of its benefits. This is an axiom open to every ingenuous mind. Had all been alike, either town or country Jurors, no irritating distinction could well have crept in—no principle of right could well have been invaded. But as such was not the case, pigmy as those interests were, they should have been alike respected. This paltry Government pittance to five Jurors, should never have been squeezed into an act of roluntary and spirited liberality! there was no kindred spirit between them. The Banks' offering should have stood alone, unassisted from so drained and reduced a source. And if the gold be now mibbled off the gingerbread, believe me, Mr. Solicitors, that you are the naughty boys who will come in for the wanton and wicked sport. Many a good weapon has been blunted when intrusted in the hands of the unskilful; and if bright and massive blades have now suffered through the clumsy and ungraceful tilts of others we extend to the Banks more our sympathy than our blame.

Having now settled my "Long arrear of gratitude with Alonzo!"

and knowing that I had no legitimate claim on the Banks for one shilling no further than gratuity is sought, none shall be received. Lest any of my fellow country Jurors should tremble at a field being left open for *conjecture*, by affixing an anonymous signature to this letter, I feel, Mr. Atlas, that the manliest course to pursue, is at once to say that the writer is

PUSEYISM IN AUSTRALIA. (By Permission of the Atlas.)

Bishop of Calcutta informed them, that one of the chief duties he had to discharge in the three immense dioceses of India, as Bishop and Metropolitan, was to raise a barrier against the inundation of smr-rogard called PUSEYISM, which was pouring out its defiling and ideath conveying streams over the PROTESTANT CRURCH there, as at home. He endeavoured to do this as became him as BISHOP, by ordaining none who emertained the gross and superstitutus Tractarian sentiments—by und entertained the gross and superstitutes Tracturius sentiments—by refuting and condemning them openly all over India, in his sermons, and charges, and private advice—and by following out every particular instance of a tendency to these novel doctrines, ceremonies, or practices, which came to his knowledge, with all the measures which the case demanded, and his duty allowed.—Report of a Public Meeting of the Clergy and Inhabitants of Islington.

Fellow Churchmen—Contrast the above beautiful sentiments ith the sayings and doings in some of our semi-Popish Churches in Sydney and elsewhere in this colony, fostered and nurtured as they now are by the Diocesan himself. Is it possible that, in the nineteenth century, men should be found so ignorant as to imagine they can with impunity revive the Popish superstitions of the dark ages, and rivet the chains of priestcraft again around the necks of our generation? Let us cry shame!—shame upon these Popish revivalists! Look at St. Andrew's semi-Popish Church, with its Crosses mounted on the summit of each corner, staring you in the face turn which way you will; and, again, at Christ Church, with all its Popish paraphernalia, daring and defying public opinion in the most open manner. And why is all this? The reason is too obvious—it is pleasing to the head of the Church. A gentleman who visited the latter place, on Sunday last, observed, "It would be difficult to draw a distinction betwixt the service of the Romish Continental Churches and the service as now performed in Christ Church, St. Lawrence." Would it not be more consistent, more

my interview with that gentleman was no less honorable to him-once to the see of Rome, than thus to delude a congregation under self, than its result was unexpected by me. Nor, do I feel that I the plea that the Rubric enjoins this, and the Canons enforce the other, till-"one strange event so rapidly supersedes another, that men's minds have undergone a complete mistification, and now even cease to wonder what will come next."

Fellow Churchmen, allow me once more to appeal to you as members of our Protestant faith, to shake off the dull sloth that has taken possession of you, and shun the polluting stream that is waiting to overwhelm you! there is, I am happy to say, a remnant of our pure Protestant Church yet left us in this colony, cling to it, and its worthy ministers will receive you into its bosom with

joy and gladness.

It has been observed by a minister of the Church in this colony, that the introduction of these forms are repugnant to his feelings, but his ordination oath binds him to obey his Diocesan. These same forms and innovations were attempted in the Diocese of Hobarton, under the guidance of Bishop Nixon, and for a time appeared successful, but a feeling of indignation at length arose against them, and they have been adandoned, even to the pulling down of the wooden crosses from the buildings—the disuse of the surplice—and also the collection of the offertory, which of itself has kept hundreds from our Churches, and driven many, very many, to seek Christian consolation in other communions. For what purpose has this revival of obsolete forms been attempted? forms which in the age of superstition and priestcraft were obliged to be abandoned for the security of the Church; and shall we in the nineteenth century, allow them to be revived for the sole purpose of preventing us the right of private judgment, and thinking for ourselves; these my fellow Churchmen are matters for our con-sideration, let us then at once boldly unite and demand their withdrawal, or by our silence we shall be assisting in the destruction of our once happy Church in this colony.

CACOETHES SCRIBENDI.

MR. ATLAS.—The above dreadful malady has so fatally siezed apon the Carcoarians, and is now making such havoc among them, that I hasten to announce to the world through the columns of your valuable journal, the injuries, both public and private, resulting therefrom. I am aware that a similar itch prevails at certain seasons in our Council Chamber, Sydney, distinguished by the faculty by the cognomen of Loquendi-but, sir, permit me to assure you that the effects of the two are very dissimilar. Loquendi simply causes loss of breath to the honorable speakers, and the injury, if any, is confined exclusively to themselves. Already has it attained such a pitch as to render two mails per week between the metropolis and this remote insignificant little hamlet insufficient, and the Postmaster General has in consequence, thought it prudent, in the plenitude of his wisdom, to accept a tender for three mails per week, in lieu of two as heretofore; further, has appointed, as I am credibly informed, the holy Sabbath as the third mail day—thus adding private to public injury—for not only is the extra sum of £45 wanted to support the charge for the third mail, without the slightest possibility of an equivalent in any shape whatever being returned, but the Sunday attendance of three Christians at least, is required on these itchy patients yes, three Christians—two Postmaster's and a Mailman must neg-lect the worship of their God, and break upon that rest and quiet which are held to them sacred by laws both human and divine, to wait upon these mono-maniacs who are wasting their substance in postage and stationery, and who, whether from madness arising from much and profound erudition, or whether from their ignorance of rhetoric and want of learning, I know not, cannot get through their lucubrations in the six days allotted for work, but require the seventh also to make up for their dulness and de-

Our immortal Pope must have predicted their existence, when he wrote these lines:-

How much of paper's spoil'd! What loads of ink! And yet how few, how very few, can think! The knack of writing is an pasy trade; But to write well, requires at least—a head.

But independent of this shameful breach of a divine ordinance and infringements on private rights, let us look into the demoralising results of this worse than heathenish practice. It is well known that the arrival and dispatch of mails on a Sunday wherever the practice exists, causes large crowds of persons to assemble in the vicinity of the Post Office—among the mobility so congregated you see the drunkard, and hear the blasphemer,—your hearing is pained with oaths and imprecationsswearing,—there the smutty jokes are cracked and foul and obscene language passes round—there may be seen boxing and wrestling betting and gaming; there stand the old teaching—the young learning—there are concerted plans for burglaries, mail robberies, and thence is conveyed that private information, so necessary to the bushrangers and receivers of stolen property, for eluding the vigilance of the police—there stands the blood-stained adept, teaching the young idea to shoot. Alas! the sight, the very thought, makes the Christian heart shudder. "Is this a Sunday," quoth you, a holy Sabbath in a Christian land? you pause, and repeat the question—you answer in the affirmative—but find it difficult to credit your own senses. This is but a faint picture of Government. The day set apart for holy worship is converted into a day for the meeting of murderers and robbers—and the area in front of the Post Office is made the lounging hall of the idler—the rogue and the vagabond. What temptation indeed does this offer to the honest poor—wearied with his six days' labor and naturally preferring light and frivilous conversation to a grave sermon, wants little or no persuasion to neglect divine service—and is accordingly iniated into this sabbath-breaking system, and ever after shuns the fear of God, and deviates from the path of rectitude.

In conclusion, sir, viewing this as a public question, I take leave to ask how will the Postmaster General account for the unwarantable and unauthorised increase in the public expenditure. there a board appointed to open the tenders, or is this important and confidential duty left to the sole discretion and unaided wisdom of our sage director of mails? Be this as it may, sir, any sane and honest person acquainted with the extent and importance of the Carcoar correspondence, will concur with me in pronouncing the whole affair to be a nefarious jobbery! a sleight of hand hocus pocus trick, requiring strict investigation.
