the events that have occurred in the Church of England within the last 5 years—teach us, if we are not ignorant of the signs of the times, or spiritually infatuated, to associate such things with the superstition and idolatry of Rome. There are already several churches in England which have crucifixes on their "allars," to which the knee is bowed; and if the advances already made in this colony are to be tolerated, we may soon witness the same.

These are not mere groundless suppositions, but founded upon occurring events. Many have gone over to the Church of Rome within a late period, from that famous seat of learning and once famous bulwark of Protestantism—Oxford. Thirty of its members have already seceded, amongst whom are about eighteen clergymen, some of them men of rank and influence. Crosses, and things of their kind, are approximations to Rome. They are Rome's insignia—beacons which already have directed many thither. The creatures of a superstition arising in the bosom of the Church of England, which, if not suppressed, will hatch such a brood of abominations as we may fear shall bring down the displeasure of God upon the church of our fathers. "So that he will cast her out of his sight," and Protestant Briton, like apostate Israel, shall "become a proverb and a by-word among all people"—(1 Kings, ch. 9, ver. 6-9).

MR. ATLAS—The Squatting Act is now nearly defunct. "To be or not to be" renewed; "that is the question." So far in the Bush as we are, we cannot tell how quickly these matters may be carried out in Sydney, although we are far more intimately acquainted with the working of these enactments than the framers themselves

I have no money—no estate—no profession—and cannot get a living without a Government appointment—(some say I am too lazy to work and too stupid to live, but this is a libel)—I owe many small debts—I often leave my reckoning unpaid; I have even borrowed silver from publicans, and "made my lucky with it." I have some small dislikes and quarrels, which I think I could settle to my own satisfaction were I dressed in a little brief authority. My mode of proceeding would be very plain and concise. If accused of giving a decision contrary to evidence—instead of arguing, or denying the accusation, I would freely admit it, and blandly add, "but I go by my own opinion in this matter." I should have no hesitation in fining any young man five pounds or more, at the same time refusing to hear any witnesses or defence he might have ready—unless I was afraid that he had sufficient spirit and cash to annoy me afterwards. Nor should I hesitate to give a servant an award against a master I did not like—should the master be absent and unsummoned; and vice versa, according to my taste. I would also (to favour whom I pleased) refuse to hear criminal informations for murder, perjury, and other trifles. I would not mind altering the book, &c., in my own office—if no-body were present; and, when convenient, I should certainly manage to lose papers, for I could easily certify that they never existed

Had I any direct authority over other Magistrates and Commismissioners, should I punish them for acting in a similar manner? The question needs no reply.

Now, Mr. Atlas, I call upon you, by your own high-flown protestations, by the character you started with and have maintained before the public, to do something for me. Take particular notice of this application—urge it upon the Legislative Council—let them consider it when arguing the renewal of the Squatting Act—do not allow them to treat this letter as a joke.

To revert to myself, if by my present professions 1 am not calculated much to surpass my predecessors, consider—I might improve, and soon after my instalment into office get more thoroughly consisted with the minuting of business

acquainted with the minutiæ of business.

Let me, at least, have a common Commissionership. Should I fail in this, my first application, may Heaven reward me with the office of a Judge in the Supreme Court, a Chairmanship of Quarter Sessions, or a Police Magistracy.

I know a fine, or rather a splendid run, part of it belongs to a Mr. Square (hang him)—use your most strenuous influence for me (as you undoubtedly ought)—I will ensure it for you, and we will not talk of arrears of assessment, trespasses, &c. If you could lend me a few pounds, you would much oblige

IN THE ESTATE OF JOHN TERRY HUGHES.
This was an appeal by Henry Macdermott and the Bank of Australia, as creditors in the above estate, from the decision of the Chief Commissioner, who had suspended the certificate of the insolvent for twelve months. The insolvent had been compulsorily brought before the Court of the Chief Commissioner, upon a citation issued at the instance of Mr. Macdermott, in order that he might be dealt with as the Act prescribes in cases where the

insolvent abstains from making his own application.

The proceedings commenced as long back as the 14th July, 1845, and the different hearings had been continued by adjournment, until the 19th of February last, on which day the Chief Commissioner gave judgment, deciding on suspending the insolvent's certificate for twelve months from the date of application. It was against this decision that the present appeals had been

Messrs. Foster and Fisher counsel for the Bank of Australia; Mr. Michie for Mr. Henry Macdermott; and Messrs. Windeyer and Broadhurst for the insolvent.

The petitioners relied upon the whole of the evidence which had been taken in connexion with the estate.

The case had been closed last Court day, and his Honor the Chief Justice this day delivered the Judgment of the Court, that the certificate of the insolvent must be wholly withheld. His Honor stated that the opposing creditors having succeeded by an appeal from the decision of the Chief Commissioner, which was to a certain extent in the insolvent's favour, the Court could not give costs against the latter.

LATEST ENGLISH NEWS.

THE arrival of the Agincourt, on Thursday afternoon, (the mail packet for March.) has put us in possession of important English news up to the 6th of that month, she having left the Downs on the 8th. The February packet is still due.

Sir Robert Peel's motion on the Corn Laws had been carried in the House of Commons by a majority of 97, the numbers being for the motion, 337; against it, 240.

America'—important news on the Oregon question will be found among our extracts.

India—large reinforcements for the Indian army were about to leave England. Six regiments of infantry and two of cavalry were spoken of as being under immediate orders.

THE CORN LAW QUESTION.

The question of the corn laws, may, as we have said before, be considered as set at rest. In spite of resignations, ejections, and protection meetings, the Minister has had a majority of 97—a majority greater than that which supported him on several occasions, ere he had startled the intelligence, roused the fears, or offended the consciences of his Conservative adherents. Another question may also be considered as dismissed, or, at any rate, as diminished in importance, That is, "What will the Lords do!" With a majority of only 70, the Premier might have looked forward to the tactics of the upper house with anxiety,—had it been only 60, with alarm. He may now, as far as the safety of his measure is concerned, regard them with indifference. The House of Commons dare not rescind a vote which it has thus confirmed by an after recantation: the House of Peers will be wise enough to avoid a collision with the representatives of public opinion.

But, it is asked, and asked too with sincere and unstimulated doubt,—"Is public opinion really on the side of the Premier? How has it been tested? Look to the premises:—A House of Commons, elected especially on protective principles, by the will of large and enthusiastic constituencies—making protective speeches—uttering protective cheers for three years together,—and then in the fourth year suddenly veering round, disposing of all its former speeches, protestations, and professions, as a professor of conjuring disposes of white pocket handkerchiefs. How can you tell this emanation of public opinion? Public opinion disowns such an affiliation, is scandalized by such levity, and is disgusted by such a palliation. Besides, public opinion is not a dumb thing. It speaks loudly and intelligibly. It shows itself in gatherings and large assemblies, in the excitement of crowds, and the enthusiasm of cities. Where is that public opinion signifying itself now? Where is the excitement? Where the commotion? Where the expression of popular feeling? There is nothing of this sort. The Minister has outrun it by his policy; has outraged it by his fickleness; has calumniated it by his defence. You must seek its voice elsewhere." There are who spoke thus a week ago, and whom a majority of 97 in the House of Commons has failed to convince. They speak so still. They believe what they say. Their consciences and their interests are in a happy accordance. Their professions jump with their principles. They believe what they wish to believe. Their faith is deeply coloured by their hopes. They look for a sign to disabuse their impressions; but they look in the wrong place, or with shaded eyes, and therefore they look in the wrong place, or with shaded eyes, and therefore they look in the Lords."

Appeal to the country! For what? A great ethical experiment! To read lectures at the hustings of political consistency, or harangue mobs on the duties of a party? Alas! we grieve to say, the people, or rather the constituencies—care for none of these things at election times. Not that the nation is indifferent to the merits of constituency or the weakness of vacillation. judge with an exact rigour of political deserters and individual apostates. A "turncoat," is a name of obloquy even in a village. The man who has changed his principles without cause, or sold them for a consideration, runs the risk of atoning by involuntary lapidation for his delinquencies. They think there is something mean, cowardly, shabby, in not standing to one's colours. It is related that a colour-sergeant who, at the battle of Fontenoy, had displayed unprecedented gallantry in maintaining the standard with which he was entrusted, was afterwards charged with a The testimony was strong, positive, and consistent. Evidence of character was adduced. Among other things, witnesses spoke of his heroism on that occasion. This decided the verdict. He was acquitted. The jury could not believe that a man who had kept his colours at the hazard of his life could do a mean or criminal act. This is a popular feeling; you see it in every mob, in every assembly. Let a man cling to an unfortunate or unpopular side, he will gain the respect of bystanders, enemies, partisans. "He stood by him through thick and thin," is an exressive eulogy, which is understood nowhere so well as it is in England, and by none so well as an English mob.

Those are right who lay great stress on the English love of firmness, consistency, devotion. It is the essence of our loyal feeling. All the nonsense which is spouted after dinner about "the British lion" is but the effervescence of a sound and manly principle.

And they are right in inferring that the constituencies of the kingdom would avenge themselves on the apostacy of those who had turned their coats and their votes. They would do in other boroughs as they did in Westminster. They would shoulder off the labourer who came at the eleventh hour—to make way for him who had toiled in the heat of the day. Yet, remember this, Protectionists. A new election would see the punishment of deserters; but it would not see enlistment of new recruits in the same cause. You would be gratified by the castigation of those who had betrayed you, not by the concession of new forces to your standard. The nation which would gladly punish apostacy is on the brink of apostatizing itself. "Protection," as a word of charm, has gone by. It strikes on ears all but indifferent, on hearts all but dull. The country has gone to school for the last few years. It doubts what it once denied—it admits what it once doubted. It would find scapegoats for its non-conversion, and immolate victims on the altar of consistency. Inconstant itself, it yet admires but would not elect, the constant lovers of protection. It gives them "vails," and bids them gracefully adieu. It says to them prettily, coquettishly, but not without meaning:—

Lu-istis satis, edistis satis, atque bibistis; Tempos abice."

It has been gradually unlearning its former economical lessons; and hitherto it has found material as well as intellectual gain in its change of doctrine. The new tariff disabused it of some old ideas, and set it a thinking on some fresh ones. It learned thereby that a nation may have more and yet not be worse off than before: may eat, drink, and buy more from other nations than it did, and yet not be the poorer; and that it is possible so to adjust customs as to receive less upon each article separately, but yet gain more upon the whole aggregate of imports. Its interests and its theories have so far harmonized. It has forgotten its predilection for "protection" in the abstract, but saves its character for consistency by condemning the immortality of Parliamentary renegades.

Let not the protectionists imagine that the old colours may be waved triumphantly over the country, or the old cry be re-sounded in the counties. If they see no startling enthusiasm—no wild excitement—no fierce and sturdy combination in behalf of free trade, it is because the necessities of the times and the tone of the people do not require them. The people of England deride superfluous preparations and unprovoked combinations. When the time comes for resistance or for exertion they combine with alac-rity, and struggle with resolution. They are quiet now, for there is no show of determined opposition, no intimation of even a temporary check. They have made up their minds to the issue. Slowly, and step by step, the late adopted policy of the minister has made its way against the prejudices of party or the interests of crafts. It has been conned over and over again in ten thousand homesteads. It may not, yet be universally popular; but the good sense of the country is embracing it. Not the good sense alone, but the good faith likewise. Men who hope to see a general principle limited to one object, and a legislative battery concentrated against one class, are beginning to acknowledge that their own lot is justly cast with that of others. Those who had indulged the desire of seeing the landowners damaged by an exclusive act, confess the impartiality of a policy which comprehends mercers, tailors, and tanuers. The confession may not be general, nor the satisfaction universal: but it is sufficient to observe that the dissatisfaction is not strong enough nor wide enough to encourage the Lords in provoking an "appeal to the country." To do this with effect would require a greater political strategy, and a greater economical knowledge, than belong to the leaders of the protection party.—Times, March 3.

AMERICA.

but one. This is a significant fact, as it points to a similar course on the part of the Senators from that state. The votes of members from the other southern states were pretty equally divided.

It appears that the only condition made in the resolutions that passed the house by such a large majority was one preventing them from interfering with any negotiations that may be going on, or that may hereafter arise. This does not amount to much, as the resolutions will probably be very much altered and modified before they can have any effect.

It is possible that the recent correspondence that has passed between the Secretary of State and the British Minister, and the position taken by the President, as exhibited in Mr. Buchanan's letters, may have a great influence in the Senate, and prevent the passage of the resolutions giving the twelve months' notice, of such a liberal character as anticipated by many previous to the publication of that correspondence. The senators, even, in favour of concurring with the house in giving the notice, may not be disposed to leave so much to the President as they have heretofore.

Messrs. Allen, Cass, and Hannegan, are considered the mouth pieces of Mr. Polk in the Senate; and whatever may be stated by those Senators in debate can, therefore be considered as the Presidents views. The decided stand taken by these gentlemen, and the war speeches of General Cass, clearly show that the Government feel justified in placing the country in a position to meet any emergency. This indicates very little hope of an amicable settle-

ment of the question; but we are not disposed to put such a construction upon any preparations the Government may make for war. We have not given up all hope of the virtue of negociations. Even in the event of appropriations being made to place our ports in a better state of defence, and the increase of our navy to a new standard, the giving of the notice, the expiration of the twelve months, and the official announcement that mutual or joint occupancy has ceased, we do not abandon all hope of an amicable, sa isfactory arrangement of the question.

All may hasten negociations, and bring about a more speedy settlement of the disputed points. So long as the question is left open, and both parties have before them an unlimited period, we cannot expect any decided action; but if the notice is given, something must be done at once, and if the two Governments will approach each other with a determination to bring matters to a crisis at once, and then Mr. Pakenham can offer the ultimatum of his Government. The effect of the recent movements in relation to this question, upon trade and commerce, has been of the most injurious character, and all feel anxious to see the end of it. Any honourable compromise, any arrangement, rather than months or years of such uncertainty as now exists.—Times, March 5.

THE OREGON QUESTON.

The resolutions for the abrogation of the convention of 1827, which recognised the temporary joint occupation of the Oregon territory by Great Britain and the United States, have passed the House of Representatives by a majority of 163 to 54 votes, and there is no doubt that they have since been adopted by the Senate. The confident announcement which we made yesterday morning has thus been fulfilled within a few hours, and all doubt is removed on this part of the case. It must be borne in mind, that there is nothing, either in the nature or in the form of these resolutions, which exceeds the undoubted right of either party to the convention of 1827, or violates the courtesy of nations. Thus far, the difficulties of the case are scarcely aggravated by the notice. But this resolution having been irrevocably taken, the peace of the world depends upon the next step which may be set along this slippery path. Is Mr. Polk now prepared to open the negociation on an admissible basis, or must we infer from his silence that the settlement of this question is not the real object of his policy, but that he entertains very different designs, which the next twelve-

months will disclose to the world?
In estimating the causes which guide human conduct and govern the destinies of the world, there is unhappily a very wide distinction to be drawn between good reasons and probable motives; and the history of the follies and disasters which befall mankind is nothing more than the result of the preponderance which the worst incentives sometimes acquire over the best conviction. That form of government is undoubtedly safest and wisest which is best able to preserve the balance of a temperate and rational policy from the accidents of passion and of popular delusion. But the more a Government tends to the extreme of despotic power or of democratic license, the less can we rely upon this salutary control, and the more reason have we to dread the predominance of its insane impulses over its sane reasons and true interests. The other day, when the Governor-General of India doubted the intentions of the Seikh army, and affirmed that they would not cross the Sutlej, until he was actually apprised that their whole force had taken up a strong position on the left bank of the river, his opinion was formed upon reasons which would have been conclusive if they had applied to a rational Government and a prudent General, but which were false with reference to the sots and strumpets of Lahore and to the Sirdars of that licentious camp. Sir Henry Hardinge miscalculated the course of events by giving the enemy credit for more self-control and less fool-hardiness than the Seikhs really poisessed. They were, no doubt, mistaken in the objects and prospects of their invasion, but it required three days of frightful slaughter to convince them that they had better have staved at home.

The same remark may be applied, mutatis mutandis, to the attitude which has now been assumed towards this country by the Cabinet and Congress of the United States. Excellent, innumerable, and unanswerable arguments may be found to demon-strate the absurdity and wickedness of a war between the United States and Great Britain—the immense disproportion between the forces of the contending Powers—the close relation of their common interests—the worthlessness of the territory in dispute—the enormous injury which war must inflict on the states engaged in it, and may possibly on the whole world—and the infamy which such a catastrophe must heap upon the heads of the accidental statesmen and the popular dupes by whom alone it is provoked. Nothing can be truer, nothing more certain; but is it ascertained that truth and reason are exclusively the guiding lights of the policy of Mr. Polk? Must we not rather argue against truth and against reason, if we would arrive at a correct calculation of his perverse career? From the portentous declaration contained in his inaugural address down to the very last act of his Government, which was to heap fuel upon an angry debate by the precipitate publication of the negotiation so lately renewed by Mr. Pakenham, every part of his conduct has evinced a direct tendency to war, which we have only treated lightly, because it seemed, in spite of himself to be utterly incredible. The good reasons against war are so evident in this country and throughout Europe,—and the bad motives which may lead to war are so obscure, so peculiarly American, and in part so nefarious, that we have never condescended to acknowledge that the cause of peace could be sacrificed to such considerations. But, since the repeated messages and the public acts of the President have thrown off all disguise, and rejected every alternative, he must be judged as a man actuated by the most deplorable motives, and who can only be arrested in his disastrous career by the re-action which the consequences of his policy must occasion. No doubt that re-action will occur; it is the retributive punishment of the excesses of democratic governments; but we are compelled to add, that it seldom acts with sufficient energy and opportunity to prevent them; and it is more likely to pursue Mr. Polk's administration than to restrain it in its course. At present, the recent votes at Congress have placed the game in his hands.

An American President is raised for a limited period to the exercise of a limited power. As nothing but impeachment can shorten the duration of his term of office, whilst it may be doubled by his re-election, he has a strong inducement to play the highest stakes of ambition, to repay a hundredfold to his party the support which that party has given him, and to make all the power he enjoys, and all the interests of the state contribute to this personal and party object. The outbreak of a war, and especially of a war which has been rendered popular by artful appeals to the passions of the democratic party, as the only event which can suddenly enlarge the powers of the executive Government in the United States. It places at once at the disposal of the administration immense sums of money, loan contracts, army and navy contracts, and military and navai patronage on a great scale. The whole people are constrined to concur in strengthening and concentrating the forces of the executive power; and in the excitement of success,

or the terrors of defeat, they become alike insensible to the effects of measures which would be regarded at another time as dangerous inroads on their freedom. Mr. Polk probably does not aim at any serious encroachment on the liberties of the United States; but we have no doubt that he does aim at securing, hy every possible means, the unbounded ascendancy of the democratic party. If war be possible, if its horrors and disgrace are to be inflicted on the world, there is not a man in either hemisphere who will not clearly know that such a war could only be caused by the democratic party in America, and for the supposed interests of that party. That execrable motive, that false and deluded policy, may, we are told, prevail over all the higher considerations which stand forth so prominently before the world that he who runs may read. We disbelieve it, for we refuse to attribute to our own American descendants, in this civilised age, a conduct which was accredited even in the barbarians of the Seikh camp. But the resistance to dangerous and alarming tendency must not be looked for in the cabinet of Washington; it can only arise amongst the American people. Upon them the hopes of peace now rest. The courage of moderation is the rarest of all courage in popular states, but the tone of the greater part of the press in the United States has of late much improved, and we trust the nation will pause to weigh the consequences of the resolution which has just been carried. The guarded and dignified expressions of the Queen's speech, the temperate language of the Government, the opinion delivered by Lord John Russell at Glasgow, the free-trade measures of Sir Robert Peel, and the attitude which has been assumed by France for the maintenance of a strict neutrality in this dispute, implying her disapproval of the aggressive and warlike policy of the American Government, are all important circumstances which cannot fail to act on public opinion in America. They were not known there upon the 9th of February. The next step upon the path Mr. Polk has hitherto pursued must be one of active preparation for war. Congress must be prepared to give into the hands of the rashest Government which ever assembled at the White-house the means of sustaining the most formidable and the most wanton conflict the Union has ever engaged in. The real pressure of danger will then be felt; and at the same time easy and honorable means of preserving the amicable relations of the two countries will lie open to the choice of the people. If in that choice they err, the curse of all that may ensue will rest upon their country.—Times.

LAUNCH OF THE STEAMER PHENIX.

On Wednesday last, this vessel was launched from the building yard of Mr. Chowne, at Pyrmont, being the twin vessel with the Sovereign, also built by Mr. Chowne. It being high water about ten o'clock, that was the hour appointed for the launch; long before that time, however, the neighbourhood of the yard was thronged with persons occupying every available position along the shore, as well as several steamers well filled, numbers of boats and small craft in the bay, to obtain a view of the ceremony adopted on such occasions. We have, in a former publication, spoken of the good taste and mechanical skill which had been brought into action in building this vessel, but our remarks on that occasion, fell far short of the merit due to Mr. Chowne as a shipbuilder; she was then in an unfinished state as regarded her hull, but every pains having been taken to make her as perfect as possible Mr. Chowne appears to have fully succeeded, and this, too, within the short space of eight months, about which time her keel was laid

Mr. E. Manning, the principal owner of the vessel, together with his lady, accompanied by the honorable the Colonial Secretary and lady, the Solicitor-General, and others of his family were

It having been arranged that Mrs. E. Manning should perform the ceremony of christening her, every preparation having been made, orders were given to knock away the shores, and in an instant she glided from the stocks, during which, Mrs. Manning dashed the bottle of wine against her bows, and christened her the hænix, amidst the cheers of the multitude.

The launch was effected as successfully in every respect as could have been wished, and we have heard of no accident that could in any way tend to mar the pleasures of the day.

The engine belonged to the Sophia Jane. so long plying to and from the Hunter, but the boilers were made by Mr. Struth. It is expected that she will make her first trip in about six weeks.

NEWCASTLE AND MORETON BAY .- The Government Gazette f yesterday, makes the following announcement :-- " And whereas it is deemed necessary to alter the boundaries of the Port of Newthe Governor, in pursuance of the power and authority so vested in me as aforesaid, do, by this my Proclamation, hereby declare and direct that, for the purposes of the said recited Act, the Port on Newcastle shall be construed to extend from Bungaree Norah on the south to the thirtieth degree of south latitude on the north, and that the Port of Moreton Bay which shall and is hereby established, shall be construed to extend from the said thirtieth degree of south latitude on the south, to the twentysixth degree of south latitude on the north, including within each such Port, all inlets, rivers, bays, and harbours, within the same respectively, and one league to seaward."

Mr. Maberly said he could do no more for her than was already done by Mr. Gain; Mr. Maberly did not afterwards visit her; a constable wished to take her in a cab to the Dispensary, but he could not get a cab. In the morning between eight and nine o'clock, Mr. Gain saw her, and stitched up the wound; he attended her ever since, twice a day, up till the time of her death; she died about noon on Mon-day; she has frequently spoken since she inflicted the wound on her throat, and was quite sensible.
