"Oh, my dear fellow, it would be impossible," he replied, " to calculate upon the immense numbers that will flock to our glorious standard as soon as it is unfurled—on that point there is not the least doubt; in fact, all we apprehend is, that too many will flock to us, and that their numbers will embarrass our operations by the difficulty of feeding them. As for a regular plan for a campaign, we have none at present,—the unlooked for procedings of Govern ment have completely deranged our original plans and we must now act according as circumstances dictate. In answer to your third question,—have we secured the co-operation of any considerable number of the Catholic clergy?—I have to observe, that we have a sufficient number with us to render nugatory the opposition of some. In Waterford, Tipperary, Limerick, and Cork sition of some. In waterroya, Inperary, Limerick, and Cork, we can rely on numbers of them joining us; and when we have four or five with us we shall be able to persuade the people that the opposition which may be given us by some old sordid priest is dictated by selfishness, not religion. O, we are sure of all the really good priests, and with them we shall be able to overbear the rest. They are pledged to us."

"I shall not mention the names of those clergymen he enumerated then as having actually encouraged the Confederates to resort to extreme measures, and upon whose co-operation they relied for support; but I do solemnly pledge myself that he named at least one dozen within a circuit of four miles of the Castle, besides several dozens in the provinces. Whether he had sufficient grounds for the belief which he expressed I have no further guarantee than his word; but that he is a person of the most unquestionable veracity no one who knows him can doubt. He may have been too hasty in coming to conclusions, and his hopes may have had no real grounds to rest upon; but of this I assure you that so far as I have gone I have given a faithful epitome of our

"My dear friend,' said I, ' you are a much younger man than I am, and although your talents and genius are of a much higher order than mine, yet I have much more experience in the world than you could possibly have. As one, therefore, who possesses some knowledge of Irishmen, and the state of parties in this country, I feel it my duty to warn you of the dangerous gulf into which you seem determined to precipitate yourself. You say, 'you are afraid too many will flock to your standard at first.' Your fears, my friend, run in the wrong direction. Remember, I tell you, that when it comes to action, you will be miserably deserted,

and that you will never get as many men to act with you as would storm successfully a police barrack."

"Oh, nonsense, man!" Mr. —— exclaimed, with some indignation, "how can you fairly anticipate such a result, when on Slievenamon, the other day, there were 50,000 men who only waited for 'the word' to overwhelm the entire force at Her Majesty's disposal in the province of Munster? Look at Waterford, where thousands turned out at a moment's notice, and even in opposition to their leaders; and it was as much as they could do to restrain them from annibilating every soldier in the city; but, unfortunately, it is the case in every country, persons are to be found who put the worst construction upon everything, and are always looking at the dark side of the picture."

"Well," said I, "it is very necessary to make correct calcula-

tions before a man risks his fortune and his neck, and those calculations cannot be correct if we only look at the bright side of everything. My reason for asserting that you will be deserted are these—first, the people are degraded to a depth that renders them incapable of, and unequal to, the accomplishment of any great purpose, no greater sign can be afforded that these premises are correct than their willingness and extreme eagerness to congregate in large masses to hear persons talk. For 50 years they have been listening to talk and humbug—not one of the millions of promises by which they have been deluded into supporting trading and speculating agitators has been fulfilled. Their condition is now infinitely worse than when they commenced to congregate in large masses to hear spouters make promises never to be fulfilled. They see generation after generation of "spouting thieves" improve their own fortunes at the expense of the people; they behold these things, year after year, day after day, and yet they never dream of withdrawing their support from a system so abominable. so degrading, that I verily believe it could not be practised, for the same length of time and with similar success, upon any other race of people on the entire globe. Yes, my friend, it will take at least 50 years of ceaseless labour upon the part of enlightened leaders to make the people of this country a nation of men; they have been debased, brutalized, and degraded by the oppression of their landlords on the one side, and degraded by the oppression of their landlords on the one side, and the lying, speculating system of agitation, which they were told was to raise them in the scale of nations and humanity, has sunk them to a depth of degradation which almost precludes a hope of ever raising them from. My second reason for saying you will be deserted is, that the Catholic clergy will to a man oppose you. You look astonished. Now, remember 1 tell you that man deep them they are the catholic clergy will to a man oppose you. I tell you that you do not know them. The Catholic clergy value their influence and authority over their flocks far more highly than they do any temporal blessing which the success of the struggle you are about to embark in could confer on this country. Repeal of the union, separation from England, or the establishment of an Irish Republic, would not be considered desirable by them if any of these events should be brought about by the party to which you belong. They hate you infinitely more than they do the Orangeman, or even the Saxon; for you have always advocated doctrines inimical to their temporal authority. They will never forgive you, they hate and detest you, and if they now seem to sanction your proceedings, it is only in obedience to the will of their flocks, which they know it would be dangerous to openly oppose, but which they hope time may be productive of events that will enable them to resume their former sway over. Remember, I tell you that your destruction as a party would be hailed by the Catholic clergy of Ireland as a blessing which they would value much more highly than the repeal of the union. If you rely upon their support you only deceive yourselves, and if you enter into this contest without it, you sacrifice yourselves, and you will only shed unredeeming blood.' These are my reasons for anticipating a disastrous failure."

Mr. - walked with me for some minutes after I concluded my remarks without making an observation. At length he turned round, and took me by the breast of the coat, and said in a most serious tone, "If I thought that the Catholic clergy would be capable of such baseness as to encourage us in a course which they must all see leads us into inevitable contact with Her Maiesty's forces, and then desert us, I for one would deem any further sters in advance as the sheerest madness. I would leave the country at once, and use all my endeavours to save my friends from the consequences of proceeding further. But it is impossible to believe that those bishops and clergymen who have joined the league, those priests who have always privately encouraged us; that those

who have openly advocated our doctrines, and have been apostles of our faith, will desert us when the monient arrives for proving or our fatth, whi desert us when the moment arrives for proving our sincerity. I will not believe it; you take an ungenerous view of the priestly character. If they did, not approve of our course, and were not prepared to give us their support in the struggle to which it mevitably leads; they would have warned us that we might not only not calculate upon their support; but that we must be prepared to meet their most determined opposition.

ARRIVAL OF HER MAJESTY AT ABERDEEN.

ABERDEEN, THURSDAY EVENING.—At eight o'clock this morn ing the Royal yacht Victoria and Albert rounded the Girdleness light, and steamed right up into the harbour of Aberdeen. passage from Woolwich was made in 39 hours and a half, and from the Nore in 37 hours—this last run being without a parallel in the history of steam navigation between Aberdeen and London

When the Royal yacht was telegraphed from the Girdleness Lighthouse, the harbour authorities were quite taken by surprise. From the information of the embarkation received yesterday by the Provost, from Sir George Grey, it was not expected that the Royal squadron would reach Aberdeen Bay until seven o'clock this evening, and then only by an effort to save the evening tide. But so perfect were all the arrangements made for her Majesty's reception, and so fully alive were the civic authorities to the importance of leaving nothing to be done at the last hour, that before the yacht had entered the lock to pass through the gates to the Victoria dock, the Provost and Magistrates were ready to receive her Majesty, and thousands of her citizens rushed down to the harbour, when the bells were set a-ringing to bid her a loyal wel-The vessels in the harbour sent their colours aloft in quick time, yards were speedily manned, and the scene, as her Majesty viewed it from the bridge of the paddle-box, even at that early hour, was well fitted to excite her admiration.

The yacht was moored at the floating buoys, immediately opposite the landing place, at nine o'clock. At half-past nine, Mr. George Thompson, provost; Mr. A. Davidson, sheriff of the county; and Mr. Arthur Dingwall Fordyce, M.P. for the city, proceeded on hoard the Royal yacht to receive her Majesty's commands. At 11 o'clock the gratifying announcement was made that the landing would take place at half-past eight o'clock on Friday morning, and then the multitude, who had assembled in front of the yacht, gave three hearty cheers for the Queen. It was further arranged that her Majesty would receive the civic authorities at half-past one, to present a loyal and dutiful address, to confer the freedom of the city upon Prince Albert, and also receive a deputation from the Professors of Marischal College and the University.

The appearance of the dock was to the Royal visitants, a subject of agreeable surprise. Both Her Majesty and Prince Albert expressed their astonishment at a work of such stupendous magnitude, and Sir George Grey remarked to Captain Cargill, that he had no idea such a dock existed at Aberdeen. Let us describe it. It includes the upper part of the tidal harbour already described, and the water covers an area of 34 acres. It is the largest single dock, we believe, in the kingdom. The chamber of the lock is 250 feet in length and 60 in breadth, and is constructed entirely of dressed granite. The whole of this immense structure rests upon a foundation of 4000 piles. There are three pair of gates in the lock, the ribs of which are of cast iron, and the covering plank entirely of mahogany. Beyond the lock, on the south side, a cofferdam has been constructed for another entrance, for a single pair of gates, 70 feet in breadth. The whole of the quay walls round the dock are composed of dressed granite, and measure 6000 feet in length. The quays measure 100 feet in breadth, and are all paved with granite. In the centre of this magnificent sheet of water, and about 30 feet from the north quay, the Victoria and Albert is now lying gaily decked, and viewed by at least 60,000 people.

The Black Eagle and Vivid are also in the dock, but the Virago

did not arrive in time for the tide.

At one o'clock, the whole of the vast amphitheatre around the dock was filled by elegantly dressed citizens. A detachment of military guarded three sides of the platform. The special constables lined the inner front of the circle, and the carriage way, which was railed off on the quay, was kept clear for the magis trates and council, who were now on their way to present the address

At half-past one, the Lord Provost, accompanied by Captain Fordyce, M. P., Sheriff Davidson, and Sir M. Bruce, arrived in a splendid carriage. They were received, with the town clerk, magistrates, Dr. Cruickshank, Professor Pirie, Rev. Dr. Pirie, and Professor Martin, of Marischal College and University, by Sir G. Grey, on the quarter deck of the Victoria and Albert. The officers were ranged by the fore rail, and the deputation on the starboard side of the quarter deck. At a quarter to one o'clock Her Majesty and Prince Albert appeared on the main deck, which was splendidly carpeted for the reception, and the moment they were recognized they were welcomed by a burst of cheering from the immense multitude who had congregated to witness the reception.

The Lord Provost, having been introduced to Her Majesty by Sir. G. Grey, did obeisance, and kneeling, presented Her Majesty with the silver keys of the city. The Lord Provost had then the bonour of kissing hands, and presenting in the name of the community a loyal and dutiful address from the magistrates and council of the town. In presenting this address, the Provost said, he had the honour, in the name of the magistrates, town council, and community of Aberdeen, to congratulate Her Majesty and Prince Albert on their safe and speedy arrival in this ancient city, and begged to tender the grateful acknowledgments of the citizens for the distinguished honour thus conferred on them." Her Majesty graciously received the address, and expressed her hap-

The Lord Provost then, addressing Prince Albert, said,-"May it please your Royal Highness to allow me the honour of present-ing to you the freedom of the city of Aberdeen.—the highest compliment which it is in the power of the community to offer. Assuredly, it cannot be more worthily conferred, and it will afford great pleasure to the citizens to know that the name of your Royal Highness is enrolled among the burgesses of Bon Accord."
To which His Royal Highness replied, "that he felt highly honoured by this mark of distinction from the citizens of Aberdeen, and highly appreciated the privilege of being enrolled a burgess of Marischal Collège, was then introduced by Sir George Grey, and presented to Her Majesty a loyal address.

The Provost and magistrates then withdrew, and Her Majesty and Prince Albert advancing to the taffrail of the quarterdeck, was received with deafening shouts of applause. Retiring for a little, Her Majesty and the Prince again advanced, and, with the Prince of Wales in one hand and the Princess Royal in the other, pre-

sented themselves before the multitude, who welcomed them with most enthusiastic cheering. -"

In the afternoon Prince Albert, accompanied by Sin James Clerk and Sir George Grey, visited the King's College, and was received in the hall by the Earl of Aberdeen, Chancellor of the University, Sir Michael Bruce, and the Professors and Magistrates of Olds aberdeen. Lord Aberdeen great an address from the Senatus to His Royal Highness, which was very cordially received and gracefully acknowledged. The Provost of Old Aberdeen also presented a loyal and constitutional address, which was received with equal cordiality. His Royal Highness showed the utmost courtesy to the large audience, comprising all, the beauty and fashion of Old Aberdeen. Prince Albert was then shown through the dibrary and museum, after which His Royal Highness proceeded to Marischal College, where he was received by the Professors in the open square of the court, and walked to the College Hall, where an address was presented by Sir Michael Bruce. After inspecting the pictures in the Hall, His Royal Highness proceeded inspecting the pictures in the Half, his hotal highless. M. PROGRESS OF THE CHOLERA.

It would seem that we must shortly expect the cholera to appear in this country, as there are all the indications prevailing which heralded its approach in 1832. In the last return of the Registrar General we find a very serious increase in the deaths from diarrhoea and dysentery. During the last three weeks in May, the deaths from these diseases were only 12, 15, and 16 respectively; during June they had increased to 37; and now, for the week ending August 5, we find they have risen to the large number of 154. which is more than double the average of the seasons'. It must be remembered that diarrhoea was the forerunner of cholera when that scourge made its last visit to London.

By the accounts from St. Petersburg it seems that the disease had raged more extensively and more fatally than on any previous occasion. For the twenty-one days from the 30th of June to the 21st July the deaths have exceeded on the average 500 daily. Of the total number attacked nearly three persons died to every one that recovered. The Military Medical Gazette of St. Petersburg states that since the first appearance of the disease in that city, on the 30th June, there had been attacked, up to the 21st of July, 19,772 persons, of whom 4,834 recovered and 11,068 died. In the whole of Russia, since the first appearance of the cholera, the 28th October, 1846, to the 5th July, 1848, 280,318 persons were seized with the epidemic and 116,658 died. On the 28th July there were at St. Petersburg 2,396 cholera cases. In the course of the day 137 fresh cases occurred; 211 recovered and 82 died, 45 of whom were in their own dwellings. On the 29th there were 2,240 sick—132 new cases; 188 recovered and 68 died. On the 30th there remained 2,116 cases under treatment. From this statement it would seem that the disease is diminishing in inten-

The cholera has also, we learn, broke out at Revel; on the 22nd, the number of patients amounted to 40.

In Galicia the disease has also made its appearance. Pour cases had proved fatal in the Charité Hospital in Berlin.

In Wallachia the pestilence was raging with great virulence.

Letters from Alexandria, of the 22nd ultimo, announce that the cholera had manifested itself with considerable intensity at Cairo, and that the epidemic had also reached Tantah, a town on the Damietta branch of the Nile. Ibrahim Pasha had immediately given orders to suspend all laborious works, and to supply the men engaged in them with wholesome food. All the public establishments in Cairo were placed in quarantine, and the country people expressly forbidden to bring into the towns either grass, vegeta-bles, or fruit. All those measures had been executed.—Britannia, August 12.

THE OCEAN MONARCH.

LIVERFOOL, WEDNESDAY.—At a meeting of the Shipwreck and Humane Society to-day, for the purpose of taking into considera-tion the service rendered by the parties instrumental in rescuing the sufferers, gold medals of the society, executed by Wyon, of the Mint, were presented to Mr. Littledale, owner of the yacht Queen of the Ocean: Admiral Grenfell, Brazilian Consul-General Jerome. A sum of money was also voted to the crew of Mr. Littledale's yacht. It is intended to reward other parties as soon as the respective merits of each shall have been adjudged.

The mate of the Ocean Monarch, when giving his evidence before the committee, stated that being aware that Jerome was on board of the New World and having witnessed his courageous exertions when the packet-ship Henry Clay was stranded near New York, he proceeded in a boat on board the New World, and conveyed him to the wreck.

The Mayor having written to the Prince de Joinville and the Duc d'Aumale, returning thanks on the part of the town for their exertions during the burning of the Ocean Monarch, a reply was received this morning, expressing the gratification, and also praising the exertions of the various parties instrumental in saving

The bowsprit of the Ocean Monarch, was seen yesterday morning off the north-west lightship.

Up to the hour at which we write, the contributions amount to upwards of £2,000.

The Venezuelan government has granted a charter for an American company to navigate the river Oronoco by steam, and it is intended to run steamers up the river 700 miles beyond Angostura. A Mr. Ellice has the superintendence of the concern.

NEW USE OF WASTE STEAM .-- A manufacturer, who has a steam-engine which discharges much waste steam, conceived the idea of using it to raise pineapples. The steam was introduced under the roots of the plants, and the heat and moisture united acted so powerfully that the pineapples soon ripened; while the body of the plant, being exposed all day to the open air, assumes a healthy and agreeable taste, which renders the fruit far superior to those which have been ripened in hothouses.

DREADFUL HURRICANE ON THE EAST COAST OF SCOTLAND.

ABERDEEN, SATURDAY EVENING, AUGUST 20 .- Last night about 1000 boats, each manned by five fishermen, left the various ports of the east coast of Scotland, betwirt Stouchaven and Fraserburgh, for the herring fishery. When at the offing, at about an average distance of ten miles, and the nets down, the wind, which had continued during the day at south and south-west, suddenly chopped out to the south-east with rain. About 12 o'clock it blew a gale, the rain falling in torrents, and the night was so dark that none of the land lights could be seen. As soon as the gale came some of the fishermen began to haul their nets, but the sea ran so high that most of the fleet had to run for the shore to save life. At Fraserburgh, the boats being to leeward of Kinnaird's head, which forms the entrance to the Murray-frith, were less exposed than the boats to the southward, and managed to get a landing without loss of life; but at Peterhead, which is the easternmost point of the coast, and altogether exposed to an easterly gale, 70 out of the 400 boats that were fishing there are missing, and there is too much reason to fear that most if not all of them are wrecked or sunk. At daybreak this morning the scene that presented itself along the shore between the Buchanness lighthouse and the entrance to the south harbour, was of the most appalling description. The whole coast for a mile and a half was strewed with wrecks and the dead bodies of fishermen. Twenty-three corpses were carried into Peterhead before 9 o'clock, and at the time the latest accounts left others were being constantly thrown ashore among the wreck on the sands or the rocks. Forty boats were wrecked within the circuit of half a mile, and so rory boats were wrecked within the circuit of half a mile, and so sudden and awful was the catastrophe, that no means of succouring or saving the distressed and perishing fishermen could be devised. How many boats may have foundered at sea or gone to pieces among the precipitous cliffs of Buchan no one at present can tell. One thing appears certain, that the lowest possible estimate of the loss of life and property by this gale exceeds that produced by any other hurricane hitherto recorded in the annals of the cert scott of Scholad I. his calculated that learn the of the east coast of Scotland. It is calculated that along the coast not fewer than 100 lives are lost, and when it is considered that for the most part the deceased fishermen have left wives and families, it will be felt that the widowhood and orphanage of our seaport towns have received in one short night an unparalleled augmentation.

in recording these melancholy facts, the inquiry presents itself, "How does it happen that the boats engaged in the fisheries on the east coast of Scotland are constantly exposed to such terrible calamities, while the boats engaged on the east coast of England generally weather the storm?" The answer is simply this—the boats on the English coast are decked, while those on the Scotch coast are open. The former are in every respect fitted out for the deep sea fishery, and admirably adapted to withstand a gale; the latter, although manned by hardy and most adventurous fishermen. are adapted only for fine weather, constructed solely with the view of prosecuting one object—the herring fishery; and while this system prevails here such terrible calamities as these we have just recorded may be expected to recur.

I must omit, for want of space, many other palpable differences, such as the seven Sacraments, Transubstantiation, &c., &c., and the very lucrative doctrine of Purgatory, which Meagher, a reformed Roman Catholic describes origin, intended to cheat the simple out of their money, by giving them bills of exchange upon another world for cash paid in this, without any danger of protest." You acknow-ledge yourself, however, that Purgatory (p. 76.) was not of St. Paul which in St. Augustine's day, "was not as yet propounded as an article of faith, though it was generally believed,"—one of those additions to Paul and Peter's foundation which may suit the wealthy, but, however reduced in price presses hard upon the poor.

Now, Sir, as it is the boast of your church that "her doc-

trines are revealed in Holy Scripture, and that expressly as such they have always been unanimously taught by the Fathers, and have always been received by the Church universal." And seeing further that you acknowledge Paul and Peter as the founders of your Church. We Protestants, with our Bibles in our hands, must come to the conclusion that the Church of Rome now is not what it was.

This book, the Bible, say the Bishops of Bononia, 1553, to Pope Julias III., above all others, has raised the storms and tempests with which we are carried away, and truly if any man diligently examine it and then consider the things which are practised in our Churches, he will instantly see that they differ very much from one another, and that our doctrine is different from that (i.e. Bible,) and often contrary. And this is exactly the charge we Protestants make against you; that, in the language of Paul, you have preached "another Gospel" what he warns us not to receive even from an apostle or angel from heaven.

What care we, Sir, for your antiquity, the Jews and Pagans may better boast that. Or what care we for the ancient suprecy of the Holy See. If you have cast away the foundation of that supremacy, Paul and Peter's doctrines, and you have taken to build upon the vain traditions of men heaping up thereon gold, silver, &c., (i.e. human learning) hay, stubble, &c., (i.e. Superstitious) taking as the rule of faith that monstrous dogma of your Church of believing "what has been delivered always, everywhere, and by all,"
