The Supreme Court has been made the arena of a most disgusting affair in the instance of an Orphan School Girl, named Caroline Sarah Chantry, whose master, Mr. Douglass brought an action against Dr. Silver, for seduction of the girl. THE CITY COUNCIL met on Monday; the business of the day related chiefly to finance, and great opposition was made by Messrs. Thurlow, Titterton, Driver, Hyndes, &c., against the exhorbitant propositions brought forward. The following amounts, after a strong contest was voted:—Inspector of Slaughter-houses, £120; Stationery, £60; Printing £110; Newspapers and Advertisements, £50; Election and Citizen Lists, £50; Rent and Fuel, £200, Alderman Broughton moved that £5,000 be voted for improvements in the city; he was supported by Messrs. Driver, Flood, Allen, Sillitoe, Browne, Holden, Hyndes, Cowlishaw, &c.; Mr. Fisher moved that it be £8,000, which Messrs Walker, Wilshire, &c., supported. Mr. Thurlow preferred £8,000 to £5,000 for this purpose, but objected to both, and moved that the consideration of the same be deferred until the improvement committee have reported in detail the particular improvements to be carried out; Alderman Willshire supported Mr. Thurlow's amendment, which was opposed by Aldermen Holden and Flood, and when put to the vote, the motion was lost by a majority of 15 to 6. The vote for £5,000 was then carried.

The "Hannah."—The schooner Hannah left Port Nicholson about three months since, for Sydney, having on board a valuable cargo, and, owing to her non-appearance, great fears have been entertained for her safety. From the following account received from Capt. Lewis, of the LLOYDS, there is every reason to suppose that these fours has not been without conserved that the hull of a vessel had been driven ashore, within about twelve miles of the North Cape, the dimensions of which were seventy-four feet over-all, and nineteen feet beam, having the name of Dawson on the windlass palls—five bodies were found on the deck, one of which had lost an arm and leg. The stern board on which the name originally was, had been knocked off, and neither boats nor papers could be found which could give the name of the vessel. When the Hannah left Port Nicholson it was well known that she had 600 sovereigns on board, also a cargo of oil, &c.; a hundred casks of oil had been landed from the wreck; also a quantity of mould candles, which corresponded with the cargo shipped on board the Hannah at Port Nicholson. The general opinion at Auckland was, that a mutiny had taken place on board her.—Sydney Herald.

INCORPORATION OF PARRAMATTA.

INCORPORATION OF PARRAMATTA.

ABOUT twelve months past the attention of the residents in this town was bent upon one absorbing question; the propriety and advantage of taking the necessary steps for getting the town of Parramatta incorporated; the predominant feeling was strongly in favor of the measure, partly from a desire of being governed by men chosen from amongst themselves upon whom they believed they could depend, but more particularly from feelings of alarm shared generally by every class of the townsmen, that the inhabitants being then most grievously oppressed; insulted and overridden grievously oppressed; insulted and overridgen by the police, must on the occasion come for-ward openly, and declare their abhorrence of the tyranny, and the determination to bear it no longer, or be prepared to resign their freedom altogether.

Our reason for considering that the latter feeling had greater sway at that time than the worther motive of being governed by men elected by and from among themselves, is, that as soon as the authorities of the district, awed by that manifestation of public displeasure, had put a temporary stop to the grisyspess by that manifestation or puolic displeasure, had put a temporary stop to the grievances denounced by the several speakers at the meeting for forming a Protective Society; the inhabitants apparently satisfied with that proof of the inclination of the powers that be, to remedy the evil, ceased to continue the agitation and the society dropped. Since that time gradually and almost imperceptibly, the old vile and detestable system has been revived and and is now once more approaching the limits further endurance becomes shameful and contemptible but absolutely criminal. We do not say that already the houses of respectable inhabitants are, as heretofore, watched on festive occasions, by the police, not for their protection, but in hope of entrapping the guests—the abomination has not reached that climax yet, and we may predict never will be suffered to attain that height, but unmistakable indications are neither few nor far between, that things are approaching an unbearable limit.

The Magistrates of this district are perhaps as good as those of any other—if we have but little to say against them individually, we have less to remark in their favor. Our comhave less to remark in their favor. Our comments are upon the measures and not upon the men. They, as a body, labour under what we esteem a grand disqualification; they are neither of the people, not identified with their interests, their sympathies do not approximate, nor are there any connections between the parties which are likely to have a practical effect to the advantage of the people.

irresistable power, wherever it is brought to bear;—from the potentate to the peasant,— from the meanest to the noblest, all within its irresistable influence are to a great extent governed by its dictates; wherever it penetrates it is impossible to avoid its sway, pains and penalties sink into insignificance when opposed to its overwhelming

But this immense moral engine is not readily set in motion, it is only in instances wherein important measures are concerned that it can be brought into activity—but there is meanwhile a minor degree of the same salutary power which would be of essential service to the townsmen if those who govern them were within its reach

The Magistrates of this district have so The Magistrates of this district have scarcely any associates in the town, the number is so contemptibly few as to be of little importance to them. Consequently, as long as they are on good terms with those of their own class of life, it is a matter of indifference to them how they are esteemed by the townsmen, or whether they are regarded as their benefactors or otherwise—public opinion does not reach them.

essentially different would be the case Hov this town was incorporated and its magis if this town was incorporated and its magistrates chosen from amongst the people—we should then be governed by men identified with our interests, conversant with our wants, anxious to promote improvements and remove grievances for their own and the general welfare—men who must daily meet those whose prosperity they either assist or undermine—their respectability and self-esteem would depend upon the estimation of their fellow citizens, and Parramatta would become the object of their hourly and ardent solicitude. renow citizens, and Farramatta would become the object of their hourly and ardent solicitude. If any public benefit was in agitation, they would form the nuclus from which the first efforts would proceed—the grand misfortune of the town, its want of unity, would be in a great measure ameliorated, for then the inhabi-tants would have a rellying recent which has been the greatest drawback upon every scheme for its advancement.

The only objection that can be urged is, that the town must be taxed: we believe it is now taxed as much indirectly as it would be openly taxed under an improved system, as to the want of proper aspirants for the suffrages of the people, that may at once be met by naming the present Council. Messrs. Oakes, Pye, Payten, Byrnes. and Hcuison, who are already stamped by public acceptance, and whose past conduct in office would place them in an advantageous comparison with any five of the District Magistrates now upon the Bench; moreover a score of respectable inhabitants could be found were these not to come forward. Were the Magistrates elected by the townsmen, how long would a multitude of vexatious and oppressive abominations last. We should not see competent and respectable individuals pining in idleness; while an illiterate fellow, holds a plurality of offices, which would support six or seven better men. We should not have policemen prowling in couples about the town as keen as foxes, to entrapthe inhabitants. If townsmen were upon the Bench, the poor would not by a quirk of law, or perhaps of no law, be shorn of half of certain fines which are now so inexcusably appropriated by policemen, to the detriment of the aged, the infirm, and the afflicted. Whenever miserable old age or decriped sufferers are thrown on the world to depend upon the precarious means of pro-

miscuous charity it is impossible to forget the police or to forbear wishing that a townsman presided upon the Bench, who could not, and dare not insult the inhabitants by permitting any portion of the funds assigned by enactment for the support of the sick and distressed to be grasped by insatiable harpies, under color of a form of law.

The people may depend upon the fact, that the town can make no effectual advance towards prosperity until they are governed by men who prosperity until they are governed by men who sympathize in their feelings and are bound up in the same interests—We do not require men of shining talents, as the selections of the government incontestibly prove; common sense and honesty of purpose are essential rather then great acquirements, but more than all, the confidence of the townsmen is of importance, and that will never be afforded to any set of men who are not elected by the

people.
Under the direction of men interested in the event and anxious to secure its prosperity the town of Parramatta would yearly increase in wealth and influence—poverty and misery would be the lot of few save the improvident and the vicious—the morals of the people now left to take their chance, would be guarded and encouraged, and immorality checked with as firm a hand, but by less unpalatable means; the present system is pains and penalties for vice—and neglect for virtue, unless it be public virtue when it becomes a prescribed thing if the present system is pains and penalties for vice—and neglect for virtue, unless it be public virtue when it becomes a prescribed thing if its uncompromising hand ventures to probe the cherished abuses which embitter the lives of the inhabitants.
