In returning once more to the consideration of the tenant system in this country, we acknowledge ourselves astonished at the apathy of the public and the silence of the press upon a subject so intimately connected with the future welfare and happiness of the colony. Except in a letter signed "Aristides," addressed to the Australasian Chronicle, and a brief allusion in the Herald to the liberality of certain proprietors of land in the neighbourhood of Port Macquarie, we have been unable to trace the smallest indication of any interest being felt upon the subject among those who have assumed the highly arduous and responsible duties which devolve upon the directors of public

We are not less grieved than astonished at this indifference, for the subject is one in which the interference of the press is required in order to assist the public mind to a correct judgment. In the bustle of life and eager pursuit of wealth and dis-tinction, the interests of the poor and humble are ever liable to be disregarded. The attention of the giddy and unthinking, as well as of the selfish and aspiring, is easily attracted by the ostentation of riches; the man of taste and acquirements natur ally prefers the society of those who, having been delicately nurtured and care-fully educated, have the advantage of polished manners and agreeable conversation to recommend them; distinguished talents, as they usually elevate the possessor and, however humble his origin may have been, introduce him into the narrow circle of the aristocracy, thus shed upor that minority of the people their own lustre, and increase its influence: in short, whatever is eminent catches the eye which overlooks what is common. And the effect of these natural errors in our estimate of things is heightened by those mistaken ideas which are derived from the habits and feelings of modern society. From the earliest period of our lives we have been taught that what is common is vulgar, and what is vulgar is despicable; while a wiser and more benevolent philo sophy should teach us that what is com-mon is connected with nine-tenths of the population, and that distinction is the lot only of the favored few.

It is not our present purpose to follow out this principle in its Benthamite application-we merely wish to show that the interference of the press is required to fix the attention of the public upon the interests of the humbler and most numerous classes. Even men who assume the title of "patriots," and "friends of the poor," are little conversant with such topics as this; occupied as they are in a contest about principles, and lured on by the vision of political advantages, they seldom stoop to such petty considerations as those which are connected with the home comforts of the peasantry. And the ablest statesmen who, whether by the authority of the Sovereign or by election of their countrymen, are placed at the helm of public business, have little leisure or inclination for such reflections. Engrossed by the high affairs of state; engaged with disputed and intricate questions of law and politics; attentive to those great comprehensive principles which involve our rights and liberties; investigating with studious eye the complicated machine of commerce; looking into far distant lands for some new object which may possibly affect the future prosperity of the country; and tracing Windeyer, the remote consequences of legislative enactments-they are apt to overlook

Amidst the illusions of past years w supposed that we were rearing up a noble edifice of colonial welfare; but, careful only of the ornamental parts of the building, we neglected to provide for its stability or foundations. These must lie among the interests of the most numerous

classes of the people, among

things of life; and the formation of a colonial peasantry is a subject which deserves the attention of every true and far sighted patriot. It will be little considered by those who are impatient in the pursuit of present enjoyment, or intent on rapidly accumulating wealth—it will not obtain a hearing from those whose pressing engagements leave scarce a moment's breathing time, and who venture not to look into that future which presents to them an aspect of dreadful uncertainty-it will be estimated at low value by that very numerous class of politicians who deal in petty expedients that produce only temporary effects and leave no lasting impressions

upon the character and condition of the country. But to all who can appreciate such measures of improvement as are slow indeed in their operations, but extended in their influences, permanent in their consequences, and suited to infuse perennial vigour and health into the body politic, it will be evident that this is a subject which touches all the secret springs of a nation's prosperity-that commerce cannot revive while the land remains imperfectly cultivated—that religion cannot extend while the physical and moral condition of the peasantry is neglected-that the law cannot attain its due supremacy over the minds of a people who have no interest in the soil—that settled, honest, and industrious habits cannot take root among hordes of wanderers who are continually changing their place of residence —that the domestic virtues are rarely known among those who have no homethat a proper sense of liberty, as distinguished from anarchy and license, and an attachment to the country where they live, are plants of too noble a nature to grow up and flourish under such blighting influences—and that a young generation which springs up in ignorance, filth, gloom, and sullenness, is likely to be more immoral than their fathers. Such reflections should enlist the sympathics of every truly benevolent man in this cause, and he will perceive that it possesses an importance which extends far beyond the present generation, or the mere commercial prosperity of the colony. Suppose us once more as affluent as we ever were, or ever imagined ourselves to be, yet

"Ill fares the land to hastening ills a prey, Where wealth accumulates, and men decay."

THE ELECTION.

WE perceive from the Sydney papers that it is probable the writs will be issued in the course of next week, and that the elections will take placesomewhere between the 15th and the 30th June.

Major Wentworth's friends are anxiously looking out for his arrival, but no account has been received since the letter announcing that he had taken his passage in the Brankenmoor; we perceive, however, by the Australasian Chronicle of Thursday last that the Socrates, which left Launceston on the 19th instant, reported the Brankenmoor to leave the same port for Sydney on or about the 23rd; if she did leave on that day, the Major may be expected in the course of next week.

The election for the county of Northumberland appears likely to go off without any one coming forward against Mr. Foster.

The representation for Durham, on the contrary, is being warmly contested; the friends of each candidate exerting them selves greatly.

The contest in the district of Hunter Brisbane, and Bligh is equally warm; the reports from that district vary a great deal, but from their general tenor the struggle will be between Captain Dumaresq and Mr. Dangar.

In the district of the counties of Gloucester, Macquarie, and Stanley neither candidate seems to have made much exertion to secure his return. The electors in the neighbourhood of Port Macquarie seem somewhat dissatisfied with them both, neither having as yet personally visited that place. THE ADDRIGHTES,...Monday last being the day fixed upon for the distribution of blankers among the aboriginal natives of this district, a largo number of them assembled about the court house, East Maitland, pretty early in the day. There were but thirty-six blankets to be distributed among them. The authorities at day. There were but thirty-six blankets to be distributed among them. The authorities at Sydney have heretofore sent up to Mailland seventy-two blankets for this purpose, three or four of which have been usually sent to Mr. Hobler's, and a few to Mr. Wyndham's, and besides these a quantity have been always before this year sent from Sydney to the Wollombi. This year, however, instead of any having been sent to the Wollombi, an order was sent from Sydney to the police magistrate there stating Sydney to the police magistrate there stating that he was to receive thirty-six of the blankets which had been forwarded to Maitland; these he accordingly received; so that there were thirty-six blankets less to be distributed amongst the natives in this district than on former occasions. In consequence of this, the chief constable, in distributing the blankets, supplied first the old men and women, afterwards children, and then such men as had gins, as far as the blankets would go; consequently several of the single men received no blanket; four blankets were as usual forwarded to Mr. Hobler's place; but none have been sent to Mr. Wyndham's, nor are there any to send. Why the number of blankets usually sent to the Wollombi has not been sent this year it is impossible to say, but it appears to us that the authorities in Sydney ought to look into the circumstance, and if it has arisen from an oversight, a fresh supply should be immediately send up to Maitland for those blacks who have not yet received any, and also for those who are usually supplied at Mr.

Surrounded as we are on all sides by the gloomy and depressing circumstances attendant upon the present disorganised state of both the social and commercial condition of the colony, it is gratifying to find that the name of our young and virtuous Queen is still cherished by us, her antipodean subjects of New South Wales; and that the thousand kindly feelings with which we were wont to invest the name of our beloved monarch have not been obliterated our beloved monarch have not been obliterated by the winds and the waves which have wafted us so many thousand miles from the homes of our fathers, and the seat of her empire. During a ride on the banks of the Hunter this mornin and whilst indulging in a reverie inspired by the natal day, our cars were saluted by the discharge of ordnance at half-minute intervals: from whence could the sounds proceed? possibly signal of distress from some unfortunate bark, foundering on the dreary world of waters—no, our distance from Newcastle was too great, and the calmness and screnity of the morning were also at variance with the conjecture. We pursued our journey, and at length reached the highly cultivated and improved estate of that enterprising individual, Mr. Eales, and shortly after descried from among the stately trees of the surrounding forest the masts of a vessel; we approached still nearer, and found it to be the splendid steamer Shamrock, not indeed "walking the waters like a thing of life," but safely live in the dry dock recently constructed by lying in the dry dock recently constructed by

flying in the broad sunshine she looked like
"Some dark beauteous bird, whose plume Is sparkling with unnumbered dyes."
The scene was exciting. Peal after peal awaked the echoes of the woods, but lately redeemed from the occupancy of the wombat and guana, or the prouder predominance of the kangaroo and emu; and while on the one hand we had before us an imperiable mouraget of British before us an imperishable monument of British skill and ingenuity in the first-class steamer, we were surrounded on the other hand with no less convincing proofs of indomitable energy and industry in the splendid estate. "And vhat," we were led involuntarily to exclaim, "cannot these two mighty agents effect?" Yes mighty indeed are the achievements of human skill and industry; but mightier far are the achievements of that man who has made the conquest of himself, and has learned to rule bis own spirit. QUEEN'S BIRTH DAY.—Wednesdey last being the anniversary of Her Majesty's hirthday it was not allowed to pass without some manifestations of loyalty by the inhabitants of Mattand. Several large bonfires were lighted in various parts of the town, and the youngsters amused themselves with squibs, crackers and other hand fireworks; a good deal of gunpowder was ex-pended in shooting, and there was a partial illumination. Mr. R. P. Cummins, of the Sportman's Arms, exhibited a very tasteful symbol consisting of a large transparent star, with a beautiful and well executed crown in the centre; this device was very much admired, both for its brilliant and various colours as well as for its splendid effect. It was the workmanship of Mr. Random, painter, and the neat and elegant manner in which this and several other transparencies which were exhibited were got up by him reflects great credit upon the taste and judgment of that artist. At Mr. Random's own house were exhibited two smaller but no less brilliant transparencies, the one consisting of the shield of the royal arms, surrounded by a white star, and the other a well executed portrait of her Majesty in the centre of a star of green and gold. Mr. Clarke, boot and shoemaker, had his window illuminated with candles, and over the door a very neat transparent star and garter, with a V in the centre, and the window of Mr. Belcher, shoemaker, was also well lighted with candles. Seyeral houses were illuminated at East Maitland; and a good deal of gunpowder was fired away during the course of the night, in manifestasion of the loyalty of the inhabitants.

DESERTING A CHILD.—On Monday last Richard Bowers appeared at the police office, on ard nowers appeared at the ponce omee, on summons, to answer a charge preferred against him by Mr. W. Lipscomb for deserting his child. Mr. Lipscomb stated that about two months ago, the defendant's wife became insane, and was wandering in that state about the streets, the defendant having left her and her two children some days previously. The woman was removed by the police into the lockup, from whence she was sent to Newcastle gaol, and had subsequently been forwarded to the lunatic asylum. The youngest child, now about three months old, had been taken in by Mr. Lipsecomb, who had put it to nurse, and for the last eight weeks had been paying ten shillings a week for it. Previous to taking in the child, Mrs. Lipsecomb had furnished the mother and the other child with food, as there was none in the house.

comb had furnished the mother and the other child with food, as there was none in the house. Mr. Lipscomb further stated that he had spoken to the defendant requesting him to provide for the child, and he had promised that he would take it away in a few days, but he had never offered to do so. Mr. Lipscomb said he wished for no remuneration for what he had already done, but that the bench would order the defendant to provide for the child himself. In answer to the charge the defendant said he had not deserted his wife and children, he had only gone away for three or four days on business, and had left money in the house. During his absence his wife became lunatic, and he was greatly obliged to Mr. Lipscomb for all he had done both for the woman and children, and as soon as it was in his power he would remunerate him, but at present he was not in employment. The bench said they had reason to know that the defendant was not without the means of obtaining money, and they would therefore child with food, as there was none in the house the defendant was not without the means of obtaining money, and they would therefore order that he should pay ten shillings to Mr. Lipscomb every Saturday morning until a further order was made by the bench, and that if he failed, on the complaint of Mr. Lipscomb the bench would issue a warrant for his apprehension, and commit him to Newcastle gool.

The ale itself has a much pleasanter flavour than Tooth's, and whilst it contains a good body is a much lighter drink than the English ales of the same quality.
